WHEREAS the Climate Change Bill (National Assembly Bill No. 1 of 2014), the Persons with Disabilities (Amendment) Bill (National Assembly Bill No. 43 of 2013) and the Division of Revenue Bill (National Assembly Bill No. 11 of 2015) were published vide the Kenya Gazette Supplements No. 43 of 22nd November, 2013, No. 3 of 20th January, 2014 and No. 28 of 18th March, 2015 and passed by the National Assembly on 5th March, 11th March and 25th March 2015 respectively;

NOW THEREFORE, in accordance with provisions of Article 110 (4) of the Constitution and Standing Order 142 of the National Assembly Standing Orders, I hereby forward the said Bills to the Senate, the effect of which is to seek the concurrence of the Senate on the said Bills."

Honourable Senators,
