NOTICE OF AMENDMENT

**** THE NATIONAL DROUGHT MANAGEMENT AUTHORITY BILL**
(NATIONAL ASSEMBLY BILL NO. 42 OF 2013)
(The Senate Majority Leader)

NOTICE is given that Sen. Lenny Kivuti intends to move the following amendments to the National Drought Management Authority Bill, 2014.

CLAUSE 4

THAT clause 4 of the Bill be amended by deleting subclause (2) and substituting therefor the following new subclause-

(2) The Authority shall establish offices in each county.

CLAUSE 8

THAT clause 8 of the Bill be amended-

(a) in subclause (1) by inserting the following new paragraph immediately after paragraph (d)-

(da) one person who shall be nominated by the Council of County Governors.

(b) In subclause (5) by inserting the words "and (1)(da)" immediately after the words subsection (1)(d).
