### 4. MESSAGE FROM THE SENATE

The Speaker conveyed the following message from the Senate -

"Honourable Members,

"Pursuant to Standing Order 41(4) of the National Assembly Standing Orders, I wish to convey a Message received from the Senate on March 4, 2015. The message was submitted by way of a letter dated February 27, 2015 for presentation in accordance with Article 110(4) of the Constitution which states that –

(4) When any Bill concerning county government has been passed by one House of Parliament, the Speaker of that House shall refer it to the Speaker of the other House."

Honourable Members, the message states "THAT, the National Police Service (Amendment) Bill (Senate Bill No. 29 of 2014) as published in the Kenya Gazette Supplement No. 103 of 2<sup>nd</sup> July, 2014 as a Bill originating in the Senate was passed on Tuesday, 24<sup>th</sup> February, 2015, without amendments. The message continues, that "the Senate now seeks the concurrence of the National Assembly to the said Bill as passed by the Senate."

Honourable Members, I am now directing that the Clerk circulates copies of the Bill. Upon being read a First time, the Bill shall stand committed to the Departmental Committee on Administration and National Security.

I further direct that, before the Bill is scheduled for Second Reading, the Committee engages with the Budget and Appropriations Committee with a view to satisfying the requirements of Article 114 of the Constitution relating to Money Bills.

### 5. <u>COMMUNICATION FROM THE CHAIR ON THE FOURTH LEADERSHIP RETREAT</u> FOR THE NATIONAL ASSEMBLY

The Speaker conveyed the following message from H.E. the President-

"Honourable Members,

"As you are aware, at the beginning of each Session, the Leadership of the National Assembly retreats for a day or two to undertake a review of the activities of the previous Sessions and lay the framework for the incoming Session. I therefore I wish to notify you that the National Assembly has planned a two-day Retreat for the Leadership of the House under the theme: "Reflections, Planning and Forging Ahead". The Retreat will be held on February 27 and 28, 2015. In addition to Members of the Parliamentary Service Commission, the Presidium of the House, Leaders of Majority and Minority and other Political Party Leaderships in the House and Chairpersons of Committees, Members of the House Business Committee will also be attending this year's Retreat.

Honourable Members, the retreat will be an opportunity for the Leaderships to take stock of the business considered by the National Assembly in 2014 and prioritize key business for the Third Session that is 2015. The retreat will also discuss the manner of considering and processing of the 2015/2016 Budget and related legislation and provide an early opportunity for the leadership to discuss decorum and the general conduct of the business of the House and its Committees. The Leadership has also agreed to invite the Cabinet Secretary for Information, Communication and Technology to brief them on the status of the digital migration and the possibilities for all-inclusive alternatives.

I do hope that all Chairpersons of committees and other leaderships will find time to attend this important retreat so as to have a structured engagement as we collectively forge ahead in fulfilling our constitutional mandate.

#### 6. PETITION - ALIGNMENT OF CRIMINAL LAWS TO CONSTITUTION

The Speaker conveyed the following Petition -

"Honourable Members,

Standing Order 225(2)(b) requires that the Speaker reports to the House any Petition other than those presented through a Member.

I, therefore, wish to convey to the House that my office has received a Petitionsigned by one Joseph MwathiNyanjui, a death-row inmate on behalf of all death-rowinmates in the Republic of Kenya. Among other prayers, the Petitioner is praying that theNational Assembly amends the Criminal Laws (Penal Code and Criminal Code) – foravoidance of doubt, it is Penal Code Cap63 and Criminal Procedure Code Cap 75 – witha view to aligning them with the provisions of the Constitution of Kenya, 2010.

Hon. Members, the Petitioner states that the law as currently formulated constrains judicial officers in exercise of discretion when making judicial decisions contrary to Article 160(1) of the Constitution. He, therefore, prays that the National Assembly:-

(i) enacts legislation to provide for provision for a Government sponsored advocate to represent accused persons at all stages in capital offences trials; and, (ii) reviews criminal laws (Penal Code and Criminal Procedure Code) to provide judicial discretion on capital offences.

Hon. Members, this Petition stands committed to the Departmental Committee on Justice and Legal Affairs for consideration. The Committee is required to consider the Petition and report its findings to the Petitioner and the House in accordance with Standing Order 227(2). I urge the Committee to find ways of engaging with the Petitioner, who is in incarceration as he proposes weighty constitutional matters relating to the Bill of Rights.

# 12. <u>NOTICE OF MOTION</u> - <u>DEVELOPMENT & IMPLEMENTATION OF A NATIONAL</u> <u>CURRICULUM FOR EMERGENCY TRAINING OF ALL MEDICAL PERSONNEL</u>

THAT, aware that Article 43(1)(a) and (2) of the Constitution provides forthe right of the highest attainable standard of health for every person; furtheraware that emergency health care is an important component of standard healthservices; concerned that many lives continue to be lost due to lack of adequateemergency healthcare and poor response to emergencies in the country; notingthat only 13 per cent of the public health facilities in the country have basiccomponents to support emergency cases; deeply concerned that emergencypatients are exposed to untrained personnel and/or good Samaritans who, in mostcases, worsen the situation; cognisant of the need for the country to have a wellco-ordinated emergency care system; this House resolves that the Government immediately develops and implements a national curriculum for emergencytraining of all medical personnel in the country.
