**COGNIZANT** of the fact that Kenya Airways Limited, the National flag carrier, has been experiencing tremendous delays and cancellation of flights;

**AWARE**that each delay and/or cancellation has led to grave loses to the airline, thereby worsening the debt burden of the corporation;

**REALIZING**that the airline is now in debt to the tune of 18 billionKenya Shillings;

**FURTHER AWARE** that the current business plan of the airline does not seem to take into full account necessary measures to turn the company around;

**CONCERNED**that the situation, if left unchecked, may lead to the collapse of the company and great loss to the nation, investors and the Kenyan taxpayers;

**NOW, THEREFORE**, the Senate resolves to establish a Select Committee to conduct an inquiry into the affairs of the Kenya Airways Limited and its subsidiaries and report to the Senate within three months, taking into account the following:

- i) The leasing and buying arrangement of aircrafts since 1996;
- ii) The role of off-shore companies in the investment affairs of the airline;
- iii) The identity of the shareholders of these off-shore companies and their relationship with the management of Kenya Airways Limited;
- iv) The employment policies and practices of personnel, including engineers, pilots, cabin crew and ground personnel;
- v) The reason for delayed and cancelled flights, their frequency and the magnitude of losses attendant therein; and
- vi) Any other matter that may shed light on the financial and management crisis currently facing the airline.

## 6. STATEMENTS

## a) Statement Pursuant To Standing Order 45 (2) (b)

- i) The Senator for Taita Taveta County (Sen. Danson M. Mwazo) sought a statement from the Chairperson of the Sessional Committee on Devolved Government regardingthe devastating effects, including loss of lives and destruction of property, caused by recent flooding in Nairobi and other major towns like Narok.
- ii) The Chairperson of the Standing Committee on National Security and Foreign Relations issued a statement regarding the safety of Kenyans caught up in the unfolding political events in Burundi and informed the Senate that the safety of the Kenyans in Burundi is guaranteed and that the Kenyan Embassy in Bujumbura had urged all Kenyans in that country to avoid non-essential movements and to remain in their residences until the situation was clearer.

The Chairperson also informed the Senate that many Kenyans had already left Burundi on their own volition since schools were on holiday and further that family members of Embassy staff had already been evacuated as well as non-essential staff and that the Ambassador, who had been out of the station attending the EAC Extra-Ordinary Summit on Burundi held in Dar-Es-Salaam, Tanzania, was due to travel back to Bujumbura to coordinate the activities of ensuring the safety of Kenyans.

The Senate was further informed that the EAC leaders were meeting in Dar-Es-Salaam even as the reports of the attempted coup were received and that the leaders had condemned the attempted coup and noted that the environment was not conducive for holding of elections, recommending postponement of the elections to a date within the current Government's term in order to give all parties sufficient time to campaign.

The Chairperson assured the Senate that the African Union does not condone change of government through unconstitutional means.
