3. COMMUNICATION FROM THE CHAIR - IPU EXPERT MISSION TO KENYA ON WOMEN PARTICIPATION AND REPRESENTATION IN PARLIAMENT

The Speaker issued the following communication from the Chair-

"Honourable Senators."

I would like to acknowledge the presence in the Speaker's Gallery this afternoon of some visitors who are part of the Inter-Parliamentary Union (IPU) Expert Mission to Kenya on women's Participation and Representation in Parliament.

The Inter-parliamentary Union (IPU), as you all know, is the world organization of Parliaments and is a global forum for parliamentary dialogue, cooperation and action. The IPU advances democracy and assists Parliaments and parliamentarians throughout the world to fulfill their mandates. The IPU facilitates parliamentary debate, dialogue and cooperation and also promotes and defends democracy and the rule of law while assisting Parliaments in coping with an ever growing international agenda that is relevant to their duties.

Honourable Senators,

6. **STATEMENTS**

a) Statement pursuant to Standing Order 45(2) (b)

- i) The Senator for Migori County (Sen. (Dr.)Wilfred Machage) sought a Statement from the Chairperson of the Standing Committee on Health regarding alleged administration of wrong or expired drugs on children at a Busia Hospital leading to paralysis of the children.
- ii) The Chairperson of the Standing Committee on Health issued a Statement regarding outbreak of Malaria in the Country and Specifically in Vihiga and Kakamega Counties.

The Chairperson informed the House that the Government was aware of the outbreak in the two Counties and further the Government had carried out a number of measures to contain the outbreak including distribution of emergency anti-malaria drugs and surveillance to monitor new cases as well as community advocacy. The chairperson also stated that the Government had offered necessary assistance to Vihiga and Kakamega Counties to combat the outbreak.

The Senate was further informed that the Ministry of Health had carried out thorough investigations following the outbreak of Malaria and found out that the two counties fall under the endemic region of malaria transmission, the upsurge of malaria cases was also found to be as a result of the recent rainy season and most mortality cases were due to late referrals for medical attention.

The Speaker directed that the Cabinet Secretary for health be summoned to appear before the Standing Committee on Health on Thursday, 23rd July 2015 to comprehensively respond to the statement and all Senators be invited to the meeting.

b) Statement pursuant to Standing Order 45(2) (c)

8. MOTION - ESTABLISHMENT OF A SELECT COMMITTEE TO CONDUCT AN INQUIRY INTO THE NEEDS OF EACH OF THE FORTY - SEVEN COUNTIES

Motion made and Question Proposed-

THAT, noting that County governments were allocated offices and premises formerly occupied by the defunct local authorities and, to some extent, by former provincial administration;

OBSERVING that these arrangements were satisfactory in most counties;

AWARE that some counties had little or no such offices or premises to inherit resulting in serious operational challenges of such county governments;

APPRECIATING that there are many counties with inadequate physical facilities whether they inherited the envisaged facilities or not;

CONCERNED that the situation, continues to impact negatively on the performance of the said counties;

ACKNOWLEDGING that it is the mandate of the Senate to protect the interests of the counties and to ensure that their governments are fully operational;

NOW THEREFORE, in order to form the basis for possible assistance to counties for headquarter facilities, the Senate resolves to establish a Select Committee to conduct an inquiry into the needs of each of the forty – seven counties and report to the Senate within three months, and further that the select committee shall comprise the following Senators-

- 1.Sen. (Eng.) MuriukiKarueMuriuki;
- 2. Sen. George Khaniri;
- 3. Sen. Abu Chiaba;
- 4. Sen. Abdirahman Hassan;
- 5. Sen. Stephen Sang;
- 6. Sen. FatumaDullo; and
- 7. Sen. Judith Sijeny.
