### 5. <u>MOTION - REVIEW OF THE PROCEDURE AND COST OF MARRIAGE REGISTRATION,</u> <u>AND DECENTRALIZATION OF MARRIAGE SERVICES</u>

Motion made and Question proposed -

THAT, aware that the Marriage Act, 2014 was assented to by H.E the President on 29th April, 2014 and commenced on the 20th of May, 2014; noting that the act was by andlarge an amalgamation of the previous Acts, thus amendments relating to the regulationswere minimal in effect; deeply concerned that there are only twelve offices for the registrarof marriages in the whole country, making it difficult for the hopefuls to issue notice ofmarriages; mindful of the fact that the upward revision of the marriage certificateacquisition fee is not affordable to many Kenyans, thus inhibiting them from registeringmarriages as envisaged by the new Act; this House **urges** the Government to review theprocedure and the cost of marriage registration, and to decentralize the offices of theregistrar of marriages to a minimum of all sub-counties so as to reduce bureaucracy andenhance accessibility.
