5. STATEMENT

Status of Disbursement of Funds for the National Government Constituencies Development Fund for Financial Years 2015/2016 and 2016/2017

The Chairperson for the Select Committee on the National Government Constituencies Development Fund (Hon Moses Lessonet) gave a statement informing the House that during the 2015/2016 Financial Year, the Government allocated and disbursed Kshs. 31,213,000,000.00 to the Constituencies Development Fund kitty.

Regarding the 2016/2017 Financial Year, he informed the House that a total of Ksh. 25,000,000,000.00 had been allocated to the National Government Constituencies Development Fund (NG-CDF), out of which Kshs. 8,000,000,000.00 had been received by the NG-CDF Board. He clarified that part of the money, being Kshs. 1,412,978,131.00 had already been disbursed to various constituencies as payment for outstanding arrears for previous Financial Years.

The Chairperson also informed the House that the National Government Constituencies Development Fund (Amendment) Bill, 2016 passed by the House was awaiting Assent by the President. He said that upon assent, the Act would pave way for the NG-CDF Board to allocate the NG-CDF funds equally among the two hundred and ninety (290) constituencies and invite project proposals from constituencies based on the new allocations.

6. **MOTION - RATIFICATION OF THE ECONOMIC PARTNERSHIP AGREEMENT BETWEEN THE REPUBLIC OF KENYA AS A PARTNER STATE OF THE EAST AFRICAN COMMUNITY, AND THE EUROPEAN UNION AND ITS MEMBER STATES**

Motion made and Question proposed –

THAT, this House **notes** the Progress Report of the Joint Committee on Finance, Planning and Trade, and Regional Integration on its consideration of the Economic Partnership Agreement intended to be *comprehensively* entered between the Partner States of the East African Community (EAC) on the one hand, and the European Union and its Member States on the other hand, *laid on the Table of the House on Tuesday, September 20, 2016 (Morning Sitting)*, and in furtherance to the provisions of Article 2(6) of the Constitution and in accordance with the provisions of section 8 of the Treaty Making and Ratification Act, 2012, **approves** the ratification of the Economic Partnership Agreement entered between the Republic of Kenya, as a Partner State of the EAC on the one hand, and the European Union and its Member States on the other hand.
