1. The House assembled at thirty minutes past nine O'clock
2. The Proceedings were opened with Prayer
3. **Presiding** – The First Chairperson
4. **PETITION**

The Member for Chuka/Igamba Ng'ombe (Hon. Muthomi Njuki) presented a Petition on behalf of former employees of Chogoria Farmers Co-operative Society Limited (In Liquidation) regarding non-payment of dues by the Society;

The Petition was referred to the Departmental Committee on Agriculture, Livestock and Co-operatives pursuant to Standing Order 227(1).

5. **PROCEDURAL MOTION- EXEMPTION OF BUSINESS FROM THE PROVISIONS OF STANDING ORDER 40(3)**

- c) The Fourth Annual Report to Parliament on the State of National Security.
