5. STATEMENTS PURSUANT TO STANDING ORDER 45 (2) (b)

- a) The Senator for Wajir County (Sen. Abdirahman Hassan) sought a statement from the Chairperson of the Standing Committee on National Security and Foreign Relations concerning the policy guiding the issuance of Identity Cards for Nairobi residents who hail from other regions of the country.
- b) The Senator for Kakamega County (Sen. (Dr.) Boni Khalwale) sought a statement from the Chairperson of the Standing Committee on Finance, Commerce and Budget regarding pending bills in all the 47 Coutnies as at the end of the Financial Year 2014/2015.
- c) A Nominated Senator (Sen. Daisy Kanainza) sought a statement from the Chairperson of the Standing Committee on Labour and Social Welfare regarding the collection of performance levies from businesses for playing music.
- d) The Chairperson of the Standing Committee on Finance, Commerce and Budget issued a statement on contravention of Article 231(4) of the constitution by the Governor of Central Bank of Kenya concerning having portraits of individuals on Kenyan currency.

In the statement, the Chairperson informed the House that the Central Bank had embarked on the process of developing new currency as required by the Constitution, and that public participation on the same had already been undertaken. The next steps include preparation of the designs and procurement of the currency in accordance with the law.

The Chairperson further informed the House that a public announcement would soon be made by the Central Bank once all processes are concluded and the new currency is ready to be rolled out.

On the continued use of currency bearing portraits of individuals, the Chairperson clarified that, pursuant to the transitional and consequential provisions in the Constitution, the current generation currency remains valid legal tender, to be phased out gradually by the Central Bank once the new currency is issued.

e) The Chairperson of the Standing Committee on Agriculture, Livestock and Fisheries issued a statement on money belonging to small scale tea farmers held in a fixed deposit account of the Kenya Tea Development Authority (KTDA) at Imperial Bank.

In the statement, the Chairperson informed the House that KTDA had invested Kshs.2,926,365,091/- in a fixed deposit account with Imperial Bank Limited at the time the Bank was placed under receivership. The deposits were made based on the attractive interest rates offered by the Bank.

The Chairperson further informed the House that as at the time Imperial Bank was placed under receivership, KTDA held deposits of Kshs.27,093,433,144/- spread across 12 banks to minimize the risk for loss of funds in a case such as that of Imperial Bank.

The Chairperson assured the Senate that KTDA was able to release farmers' payments in October, 2015 using money earmarked for other obligations, and planned to further spread the existing deposits held by banks in order to minimize risk.
