#### Honourable Members,

The message states, and I quote; "THAT, the County Allocation of Revenue Bill, (Senate Bill No. 5 of 2015) as published in the Kenya Gazette Supplement No. 41 of April 17, 2015, as a Bill originating in the Senate, was passed by the Senate on Wednesday, 24<sup>th</sup> June, 2015, <u>with amendments</u>." Consequently, the Senate now seeks the concurrence of the National Assembly to the Bill.

Honourable Members,

A County Allocation of Revenue Bill is a special Bill concerning County Governments in terms of Articles 110 and 111 of the Constitution, and is crucial for the operations and budgeting of counties. Aware of the strict statutory timelines with regard to passage of the Bill, and pursuant to Standing Order 41(6), I direct that the Bill be prioritized for First Reading. I also refer the Message to the Budget and Appropriations Committee for

the necessary consideration of the Bill. Due to the urgent nature of this business, the Committee is expected to submit a report to the House by Tuesday, 30<sup>th</sup> June 2015, to aid in conclusion of this Bill.
