4. STATEMENTS PURSUANT TO STANDING ORDER 45

Statements pursuant to Standing Order 45 (2) (b)

- a) The Senator for Kakamega County (Sen.(Dr.) Khalwale) sought a Statement from the Chairperson of the Standing Committee on Roads and Transportation regarding the status of the construction of the Kakamega to Kaburengu/Webuye Road.
- b) A Nominated Senator (Sen. Ongera) sought a Statement from the Chairperson of the Standing Committee on National Security and Foreign Relations regarding a letter written by the Cabinet Secretary for Interior and Coordination of National Government directing the Criminal Investigations Department and the National Cohesion and Integration Commission into areas they should investigate relating to a speech made by Sen. Muthama on 23rd September, 2015 at the Uhuru Park.
- c) A Nominated Senator (Sen. Mukiite) sought a Statement from the Leader of Majority regarding government's preparedness for the impending El Nino rains.
- d) The Vice-Chairperson of the Sessional Committee on Devolved Government issued a statement on the status of resettlement of internally displaced persons (IDPs).

The Vice Chairperson informed the Senate that IDPs in Vihiga who totaled 814 were categorized as integrated IDP and that out of the 814, 447 IDPs were paid KShs. 10,000/= each. The rest are yet to be paid.

She further informed the Senate that a National Consultative Coordination Committee on IDPs which was constituted to deal with the matter had held several planning meetings, visited various IDP groups and was already implementing planned crucial activities. She noted that this intervention was only addressing 2007/2008 post election violence victims but the government acknowledged the existence of victims of previous violence whose plight needed to be addressed but was not being addressed due to lack of framework that defined how far back in time they could go. She further informed the Senate that in the current Financial Year (2015/16) the programme had been allocated Kshs. 2.205 billion which would be utilized to profile and settle those who had not been settled.
