- **III. - IV. THAT, notwithstanding the provisions of Standing Order 97(4), each speech in a debate on Bills sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party shall be limited as follows:- A maximum of forty five (45) minutes for the Mover, in moving and fifteen minutes (15) in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee), and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each (if the Bill is not sponsored by either of them); and that priority in speaking shall be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in that order.

I. <u>QUESTIONS UNDER THE DEPARTMENTAL COMMITTEE ON</u> LANDS

Questions to the Cabinet Secretary for Lands and Physical Planning:-

(i) Question No. 001/2018 by the Member for Kisumu West Constituency (Hon. Olago Aluoch, MP):-

Could the Cabinet Secretary brief the Committee on the legality of the appointment of Members to the Kisumu Land Control Board done vide Kenya Gazette Notice No. 5180 of 8th July 2016; the reasons for not recognizing Kisumu West Sub County as a constitutional entity entitled to its own Land Control Board under Section 5 of the Land Control Act, Cap 302; and the selection criteria for the appointment of Members to the Land Control Board as set out in the Ministry's circular dated 6th May, 2016? Could the Cabinet Secretary also brief the Committee whether all the members gazetted as Members of the Kisumu City Land Control Board, except for one Elisha Guya Didi, are non-residents of Kisumu West Sub County therefore may not be able to understand and appreciate the dynamics and intricacies of land matters in the rural Kisumu West Sub County?

(ii) Question No. 042/2018 by the Nominated Member (Hon. Godfrey Osotsi, MP):-

Recognizing that land title deeds are proof of land ownerships as well as a basis for security when accessing credit facilities against land, aware that most households in Kenya do not have title deeds due to the inability to afford the high cost of processing of the said document, could the Cabinet Secretary inform the Committee on the measures in place to facilitate the poor land owners especially in rural areas acquire certificates of ownership for their land? Could the Cabinet Secretary consider waiving title deeds processing fee for the poor land owners?

II. <u>QUESTIONS UNDER THE DEPARTMENTAL COMMITTEE ON</u> EDUCATION AND RESEARCH

Questions to the Cabinet Secretary for Education:

(i) Question No. 037/2018 by the Member Wajir East Constituency (Hon. Rashid Kassim Amin, MP):-

Could the Cabinet Secretary apprise the Committee regarding the circumstances that led to the transfer all non-local teachers from Wajir County and other Counties in the North Eastern Region; and the measures the Ministry has put in place to ensure that replacements are made to the affected schools, and that the recommended teacher to student ratio is adhered to and sustained?

(ii) Question No. 062/2018 by the Member for Kiambu County (Hon. Gathoni Wamuchomba, MP):-

Aware that Section 39 of the Basic Education Act, 2013 as amended in 2017 provides that it shall be the responsibility of the Government to provide free, sufficient and quality sanitary towels to every girl child registered and enrolled in a public basic education institution who has reached puberty, and provide a safe and environmentally sound mechanism for disposal of the sanitary towels; and further, Section 88 of the Act provides that the Government shall provide for among others, conditional capitation funds to facilitate the acquisition of the said sanitary towels; could the Cabinet Secretary apprise the Committee on the implementation status of the said provisions since the Act came into effect; and the various disposal mechanisms being used by institutions?

(iii) Question No. 067/2018 by the Member for Molo Constituency (Hon. Kimani Kuria, MP):-

Aware that the Government in 2014 introduced waiver of examinations registration fees for both primary and secondary schools candidates through a scheme aimed at easing the financial burden on parents and making education accessible and affordable, further aware that the waiver was in 2017 extended to candidates in private schools, could the Cabinet Secretary inform the Committee whether the scheme is applicable to adult candidates who register under the adult basic education as well as adult and continuing education centers?

(iv) Question No. 068/2018 by Nominated Member (Hon. Godfrey Osotsi, MP):-

Aware that Section 14 of the Higher Education Loans Board Act provides that the Board shall notify every applicant in writing whether the application for a higher education loan has been accepted or rejected, could the Cabinet Secretary brief the Committee on the average processing time for loan applications; the total amount disbursed in the past three (3) years for the various loan categories; and how the Board harmonizes disbursements with the academic calendars for various institutions to ensure release of funds to beneficiaries is not delayed?

III. <u>QUESTIONS UNDER THE DEPARTMENTAL COMMITTEE ON</u> <u>ADMINISTRATION AND NATIONAL SECURITY</u>

<u>Questions to the Cabinet Secretary for Interior and Coordination of</u> <u>National Government:</u>

(i) Question No. 030/2018 by the Member for Kimilili Constituency (Hon. Didmus Wekesa, MP):-

Could the Cabinet Secretary brief the Committee on the current security situation in Mt. Elgon area, the number of persons who have been murdered over the past six months by an alleged organized gang terrorizing residents in

the area, and the measures the Ministry has put in place to ensure security is restored and that the criminals involved are apprehended? Could the Cabinet Secretary also inform the Committee regarding the measures the Ministry has put in place, if any, to stop smuggling of illegal guns into the area?

(ii) Question No. 034/2018 by the Member for Gilgil Constituency (Hon. Martha Wangari, MP):-

Aware that the late Evans Gathuri Njoroge who was a student leader at Meru University was brutally murdered in cold blood on 27th February 2017 under unclear circumstances, could the Cabinet Secretary apprise the Committee on circumstances that led to the murder of the student leader, and what measures the Ministry has under taken to apprehend the killer(s)? Could the Cabinet Secretary also apprise the Committee on the plans in place, if any, to ensure the safety and security of student leaders; and whether there are plans to compensate such victims?

(i) Question No. 006/2018 by the Member for Kangema Constituency (Hon. Muturi Kigano, MP):-

Could the Cabinet Secretary inform the Committee on the criteria used in the issuance of work permits to Non-Kenyans wishing to engage in employment in Kenya whether in gainful employment or voluntary service; the total number of foreigners working in Kenya in gainful employment between the year 2008 to date and their nationalities; the key sectors where the said foreign nationals are working in the country; and their contribution to the economy? Could the Cabinet Secretary provide evidence that organizations that have engaged foreign nationals in gainful employment were unable to fill the vacancies from the local labour market; and state the measures that the Ministry through the Directorate of Immigration and Registration of Persons has put in place, if any, to address the influx of immigrants into the Country?

(ii) Question No. 046/2018 by the Member for Dadaab Constituency (Hon. Mohamed Dahir Duale, MP):-

Could the Cabinet Secretary provide the Committee with data for all refugees in Kenya particularly those in camps and especially the Dadaab Refugees camp? In addition, could the Cabinet Secretary apprise the Committee on the provision of social and physical amenities including the infrastructure; and the effects of these camps on the Country's economy and the environment? Further, could the Cabinet Secretary apprise the Committee on whether there plans to close these camps in the near future and have the refugees repatriated back to their countries?

(iii) Question No. 051/2018 by the Member for Kisii County (Hon. Janet Ong'era, MP):-

Is the Cabinet Secretary aware that one Pastor Esther Bochaberi Oyugi from Ekiendege, Riana ward, Bonchari Constituency, Kisii County was kidnapped and later murdered in March 2018? If aware, could the Cabinet Secretary apprise the Committee on the progress made by the security agencies in investigating the matter and apprehending the killers?

(iv) Question No. 056/2018 by the Member for Emuhaya Constituency (Hon. Omboko Milemba, MP):-

Considering that Article 238(1) of the Constitution obligates Kenya's National Security Organs to protect the people against internal and external threats to among others, the people and other national interests, could the Cabinet Secretary inform the Committee whether he is aware of the incessant incidences of unresolved insecurity, including murders, regular breakages of business premises, theft of livestock, trading of illicit brews, among other crimes in Emuhaya constituency, particularly Ebukhaya, Ematsuli, Esibuye, Emanyinya, Duka Moja Milimani, Esirulo and Ebuyangu sub-counties? In addition, could the Cabinet Secretary inform the Committee whether he is aware of the existence of trafficking of illicit alcohol from a neighboring Country through Emuhaya constituency? If aware, could he outline the action the Ministry is putting in place to ensure that security is restored in Emuhaya Constituency and that trafficking of illicit alcohol is put to a stop?

(v) Question No. 069/2018 by the Member forLoima Constituency (Hon. Jeremiah Lomorukai, MP):-

Aware that there have been incessant cases of insecurity in Turkana, West Pokot, Baringo and Samburu Counties occasioned by among other things cattle rustling, illegal firearms, poverty, youth unemployment and inadequate security personnel in the said counties; could the Cabinet Secretary apprise the Committee on the steps the Ministry is taking to ensure lasting security in the said areas?
