# 8\*. MOTION - DEVELOPMENT OF RENEWABLE/GREEN ENERGY (The Hon. Dr. Wilbur Ottichilo, M.P.)

THAT, aware that the Kenya Nuclear Electricity Board (KNEB) was created and tasked with spearheading the development of Nuclear Energy in the country; deeply concerned that the construction and maintenance of a nuclear plant is a highly technical, expensive and risky undertaking that potentially exposes a country to the threat of nuclear radiation and the challenge of disposal of radioactive nuclear waste; further aware that due to these inherent risks in nuclear energy production, many of the developed countries like Germany, India, Japan and South Africa amongst others have increasingly embarked on the systematic shut-down of their nuclear plants and instead are promoting the development of clean renewable energy, especially wind and solar energy; noting that Austria which hosts the United Nations International Atomic Energy Agency, has terminated the development of any nuclear energy; this House resolves that the Government shifts its attention from the development of nuclear energy and instead invests in the development of renewable or green energy which is safe and abundant in the Country.

**THAT**, notwithstanding the resolution made by the House on Wednesday, February 11, 2015, each speech in the debate on **The Public Procurement and Asset Disposal Bill** (National Assembly Bill No. 40 of 2014) be limited as follows:- A maximum of sixty (60) minutes for the mover, in moving and thirty (30) minutes in replying and a maximum of thirty (30) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of forty five Minutes (45) each; and that priority in speaking be accorded to the Leader of the Majority Party, and the Leader of the Minority Party in that Order.

### II. The House resolved on Wednesday, February 11, 2015 as follows:-

THAT, notwithstanding the provisions of Standing Order 97(4), each speech in a debate on Bills sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party be limited as follows:- A maximum of fourty five (45) minutes for the Mover, in moving and fifteen minutes (15) in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee), and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each (if the Bill is not sponsored by either of them); and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in that Order.
