I. PRONOUNCEMENT OF THE BUDGET HIGHLIGHTS:-

PURSUANT to the provisions of Standing Order 25(A)(a) and Standing Order 244C, the Speaker will today, not later than 3.00 p.m. call upon the Cabinet Secretary for the National Treasury to make a Public Pronouncement of the Budget Policy Highlights and Revenue Raising Measures for the National Government for the Fiscal Year 2018/2019.

The House resolved on Wednesday, February 14, 2018 as follows-

II. THAT, notwithstanding the provisions of Standing Order 97(4), each speech in a debate on Bills sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party shall be limited as follows:- A maximum of forty five (45) minutes for the Mover, in moving and fifteen minutes (15) in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee), and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each (if the Bill is not sponsored by either of them); and that priority in speaking shall be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Committee, in that order.
