THE NATIONAL CORONERS SERVICE BILL (NATIONAL ASSEMBLY BILL NO. 46 OF 2016)

Notice is given that the Chairperson for the Departmental Committee on Administration and National Security, Hon. Asman Kamama, M.P., intends to move the following amendments to the National Coroners Service Bill, 2016 at the Committee Stage—

CLAUSE 25

THAT, clause 25 of the Bill be amended in sub-clause (1) by deleting paragraph (b) and substituting therefor the following new paragraph—

"(b) make such report as soon as possible but not later than six hours after the death."

CLAUSE 47

THAT, clause 47 of the Bill be amended—

- (a) by deleting the opening sentence in sub-clause (4) and substituting therefor the following new opening sentence—
 - "(4) If prescribed tissue has been removed, the Coroner shall not order the release of the body unless satisfied that—"
- (b) in sub-clause (6) by deleting the expression "6-monthly" and substituting therefor the words "six months".

CLAUSE 49

THAT, clause 49 of the Bill be amended—

- (a) in sub-clause (1) by deleting the word "must" appearing in the opening sentence and substituting therefor the word "shall"; and
- (b) in sub-clause (3) by inserting the expression "47" at the end of the sentence in paragraph (a).

CLAUSE 68

THAT, clause 68 of the Bill be amended in sub-clause (1) by inserting the words "and the Clinical Officers Council" immediately after the words "Kenya Medical Practitioners and Dentists Board" appearing in paragraph (g).

The House resolved on Wednesday, January 25, 2017 as follows:-

- **THAT**, notwithstanding the provisions of Standing Order 97(4), each speech in a debate on Bills sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party be limited as follows:- A maximum of forty five (45) minutes for the Mover, in moving and fifteen minutes (15) in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee), and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each (if the Bill is not sponsored by either of them); and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in that order.
- **THAT**, notwithstanding the provisions of Standing Order 97(4), this House orders that, each speech in a debate on a **Report of a Committee**, including a Report of a Joint Committee of the Houses of Parliament or any other Report submitted to the House, be limited as follows: -A maximum of sixty (60) minutes for the Mover in moving and thirty (30) minutes in replying, and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each; and that priority be accorded to the Leader of the Majority Party and the Leader of the Minority Party, in that order.
