Standing Order 225(2)(b) requires that the Speaker reports to the House any Petition, other than those presented through a Member. I therefore wish to convey to the House that my office is in receipt of a petition from one Mr. Brian Onyango.

Honourable Members,

The Petitioner alleges that Medanta Afri-Care Group of Hospitals has been establishing hospital units across the country using local medical experts, after which the said hospital institutes criminal charges against the local experts and subsequently terminates their services. The Petitioner further alleges that the said hospital has been referring patients to its partner hospital, Medanta India for ailments that can be treated locally. He alleges that the objective of such referrals is to defraud the National Hospital Insurance Fund (NHIF) Scheme and unsuspecting patients of approximately two thousand United States Dollar (2,000 USD) per patient to cover medical expenses.

The Petitioner prays that the National Assembly investigates the matter and recommends appropriate action against the said facility and its accomplices.

Honourable Members, pursuant to the provisions of Standing Order 227, the Petition stands committed to the Departmental Committee on Health for consideration.
