Honourable Members, You are therefore requested to submit any proposal for amendments to the Standing Orders, on your own behalf or through your respective Committees, to the Office of the Clerk on or before Tuesday, March 21, 2017. The Committee will then review and harmonize the amendments with a view to presenting a Report for consideration by the House before the end of the term of this Parliament.
