## 4. <u>PETITION</u> – <u>IRREGULARITIES SORROUNDING TATU ESTATE LAND AND FRAUD</u> <u>AGAINST CITIZENS OF THE REPUBLIC OF KENYA</u>

I, the UNDERSIGNED on behalf of the residents of Kiambu County, DRAW the attention of the House to the following: -

- 1. THAT, the Tatu Estate and Kofinaf comprises of land estimate to be more than 10,000 acres of land located in Kiambu County with proposed mixed-use development which will consist of residential areas and public utilities such as schools among others;
- 2. THAT, on diverse dates in the year 2007, the residents of Kiambu County were invited to acquire and own land in the industrial park through the form of acquisition of shares with the believe and knowledge that the shares would eventually translate into ownership of the land equivalent to the shares being held by each individual;
- 3. THAT, the private placement and arrangement of acquisition of shares was eventually withdrawn for unclear reasons and the residents of Kiambu County were informed of the proposed establishment of special purpose vehicle in the form of a limited liability company through which the residents of Kiambu County would eventually acquire shares and own land in the Tatu City and Kofinaf;
- 4. THAT, over two thousand people in the local communities where the land is situated proceeded to set aside their hard-earned money with some even liquidating and closing up their existing businesses and invested their funds into the project by acquiring shares;
- 5. THAT, thereafter the Tatu Estate and Kofinaf Company Limited were taken over by foreigners and the two companies have to date been illegally disposing off land owned

by the local residents to unknown persons with the help of public officers in the Ministry of Lands;

- 6. THAT, the two companies through their directors have also been engaging in tax evasion in the form of stamp duty which stands at an estimated Kshs. 185, 287,002 and income tax which stands at estimated at Kshs. 1,389, 652, 512 further defrauding Kenyans of revenue necessary for use by the government to provide services to its people;
- 7. THAT, in the year 2016 a multi-agency taskforce comprising of representation from the Ethic and Anti-Corruption Commission (EACC), the Directorate of Criminal Investigations, the office of the Director of Public Prosecutions, amongst others was formed to investigate the matter, but the report of its findings is yet to be made public, or even availed to the genuine owners of part of the land;
- 8. THAT, the foreign interests, who own part of the land and who have been using clandestine and illegal means to disposes the citizens of the Republic of Kenya of their land, through unknown means, been using police officers to intimidate local owners;
- 9. THAT, the petitioners are fearful and conscious that part of the foreign interests in the Tatu Estate located in Kiambu County may be part of global fraudsters targeting large chunks of land in African countries, given their similar trend in Congo, Nigeria, Zambia and Ghana.

THEREFORE, the Petitioners PRAY that the National Assembly through the relevant Departmental Committee investigates and inquires into all matters raised in this Petition with a view to: -

- (i) lawfully assisting the genuine citizens of the Republic of Kenya who own part of the land to resolve the falsified intrigues on the land, which are largely and deliberately perpetrated and financed by foreign interests;
- (ii) resolving issues and intrigues ensuring that the genuine citizens of the Republic of Kenya access, take possession and control of their land situated at Tatu City;
- (iii) causing the relevant state agencies, particularly the Director of Public Prosecutions to make public or avail the report of the Multi-Agency Investigation taskforce on the said matter; and
- (iv) investigating the tax evasion issues and immigration status of the foreign interest in the land.

And your PETITIONERS will ever pray.

(ii) Statement on the Mismanagement of the Wildlife Sector in Kenya

Honourable Speaker, Pursuant to Standing Order 43, I wish to make a statement regarding the challenges currently facing Kenya Wildlife Service in the Country.

Honourable Speaker, The socio-economic importance of the wildlife sector remains central to the economic sustainability of our country for instance. Besides being a major foreign exchange earner through varied wildlife, the sector contributes to the positive growth of hotel industry, curios, transport industry and other interlinking private service sectors thereby acting as direct source of the source of employment opportunities to thousands of Kenyans.

Honourable Speaker, It is worrying, that despite the many benefits we get through wildlife, sector is currently facing many challenges due to mismanagement of the service by the policy makers and implementers, corruption and interference arising from some NGOs/sector brokers, alleged low morale amongst its workers leading to high rate of exodus staff to seek for greener pastures, coupled conflicts with rural communities having failed to protect people and their property against wildlife attacks.

Mr. Speaker, these challenges have largely been associated with inadequate facilitation of the KWS personnel levels at County and County Wildlife Conservation and Compensation Committees, since decision making on key matters such as financial and procurement are centralized at the national level without the input of crucial services providers at the Counties and Sub-Counties hampering efficient service delivery.

Honourable Speaker, Even after Wildlife Conservation and Management Act, 2013 came into force, the wildlife sector-management functions are still overly centralized at the national level with its authority and operational resources still retained at Langata headquarters, thus greatly hampering service delivery in the counties. Honourable Speaker; Arising from this is an urgent need for the National Assembly to expeditiously intervene in addressing the challenges faced by KWS with a view to restoring its lost glory.
