Notice is given that the Leader of the Majority Party intends to move the following amendments to the Supplementary Appropriation Bill (National Assembly Bill No. 23 of 2015), at the Committee Stage—

CLAUSE 1:

THAT, clause 1 be amended by inserting the words “**and shall come into force upon publication**” at the end thereof.
