New Clauses 10A and 10B - Insertion of New Clauses proposed

That the Bill be amended by inserting the following new clauses immediately after clause 10 –

Offences. **10A.** A person who –

- (a) fails, without reasonable cause, to -
 - (i) approve the publication of a document required to be published under any written law; or
 - (ii) publish, within the period specified under any written law, a document which has been approved for publication;
- (b) willfully or recklessly, authorises the publication or publishes false or misleading information; or
- (c) without authorisation, alters a document approved for publication,

commits an offence and is liable, on conviction, to a fine not exceeding two hundred thousand shillings, or to imprisonment for a term not exceeding six months, or to both.

General penalty.

10B. A person who contravenes any provision of this Act for which no penalty is provided is liable, on conviction, to a fine not exceeding one hundred thousand shillings, or to imprisonment for a term not exceeding six months, or to both.

- (g) the Director General of the Kenya National Bureau of Statistics or an officer designated by the Director General of the Bureau who shall be the secretary to the technical committee and shall have no vote.
 - (3) The persons nominated under sub section(1) (d), (e,) and (f) shall
 - (a) be appointed by the Cabinet Secretary by notice in the *Gazette*; and
 - (b) serve on a part-time basis for a term of four years renewable for one further term.
 - (4) The Cabinet Secretary shall appoint the first members of the technical committee under subsection (1)(d)(e)and (f)within two months of the commencement of this Act.
 - (5) The Cabinet Secretary shall provide the technical committee with such facilities and other support as it may require for the discharge of its functions.
