I. <u>EXPUNGED PARTS OF THE PUBLIC ACCOUNTS</u> <u>COMMITTEE REPORT ON THE INDEPENDENT</u> <u>ELECTORAL AND BOUNDARIES COMMISSION</u>

In the Speaker's communication of Thursday, March 14, 2019, the following parts of the Report were declared inadmissible and subsequently expunged -

- (i) The words "To that end, the Commissioners, Chief Executive Officer and the Directors who were involved in the unlawful procurement should vacate office immediately upon adoption of this report to allow for much needed reforms to be effected to restore public confidence in the Independent Electoral and Boundaries Commission" in the General Recommendation No. 3 appearing at pages 4 and 127, of the Report in so far as it relates to the IEBC Commissioners;
- (ii) Sections 4.0 and 34.0 of the Report relating to "*Basis for Committee Recommendation for Vacation of Office*" appearing on pages 6, 7, 129 and 130 of the Report <u>in so far as it relates to the IEBC Commissioners</u>;
- (iii) The second sub-paragraph of paragraph 3 of the General Recommendation No. 3, appearing at page 4, which states that "To that end, the, Chief Executive Officer and the Directors (emphasis on staff) who were involved in the unlawful procurement should vacate office immediately upon adoption of this report to allow for much needed reforms to be effected to restore public confidence in the Independent Electoral and Boundaries Commission."

II. <u>THE SPORTS (AMENDMENT) BILL (NATIONAL</u> <u>ASSEMBLY BILL NO.25 OF 2018)</u>

Notice is given that the Chairperson of the Committee on Sports, Culture and Tourism intends to move the following amendments to the Sports, Culture and Tourism Bill, 2018 at the Committee Stage—

CLAUSE 2

THAT, the Bill be amended by inserting the following new paragraph immediately after paragraph (b)—

(c) inserting the following new definition in its proper alphabetical sequence—

"Fund" means the Sports, Arts and Social Development Fund established under regulation 3 of the Public Finance Management (Sports, Arts and Social Development Fund) Regulations, 2018;

<u>CLAUSE 4</u>

THAT, the Bill be amended by deleting clause 4 and substituting therefor the following new clause—

Amendment of section 11 of No. 25 of 2013.

4. Section 11 of the principal Act is amended by deleting paragraph (c) and substituting therefor the following new paragraph—

"(c) an amount out of the Fund for the promotion of and development of sports;"

NEW CLAUSE

THAT, the Bill be amended by inserting the following new clause immediately after clause 5—

Amendment of section 38 of No. 25 of 2013.

5A.Section 38 of the principal Act is amended by inserting the following new paragraph immediately after paragraph (b)—

> "(ba) an amount out of the Fund for the promotion of and development of sports;"

The House resolved on Wednesday, February 13, 2019 as follows:-

- **III. THAT**, notwithstanding the provisions of Standing Order 97(4), each speech in a debate on **Bills sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party** shall be limited as follows:- A maximum of forty five (45) minutes for the Mover, in moving and fifteen minutes (15) in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee), and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each (if the Bill is not sponsored by either of them); and that priority in speaking shall be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in that order.
- IV. THAT, notwithstanding the provisions of Standing Order 97(4), each speech in debate on **Reports of Committees**, including a Report of a Joint Committee of the Houses of Parliament or any other Report submitted to the House for which limitation of time has not been specified, shall be limited as follows:- A maximum of sixty (60) minutes for the Mover in moving and thirty (30) minutes in replying, and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each; and that priority shall be accorded to the Leader of the Majority Party and the Leader of the Minority Party, in that order.
- V. THAT, notwithstanding the provisions of Standing Order 97(4), each speech in a debate on any Motion, including a Special motion shall be limited in the following manner:- A maximum of three hours with not more than twenty (20) minutes for the Mover and ten (10) minutes for each other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each, and that ten (10) minutes before the expiry of the time, the Mover shall be called upon to reply; and that priority in speaking shall be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in that order.

132/2019 The Member for Kisauni (Hon. Mbogo Ali Menza, MP) to ask the Cabinet Secretary for Interior and Coordination of National Government: -

> (i) Is the Cabinet Secretary aware that since 2009, Shimo la Tewa Maximum Prison, Shimo Borstal Prison, Mombasa Remand and Shimo la Tewa Medium Prison have not paid their suppliers for goods procured?

(ii) When will the said suppliers be paid?
