THAT, taking into consideration the findings of the Departmental Committee on Administration and National Security of the National Assembly and the Standing Committee on National Security, Defence and Foreign Relations of the Senate in their Report on the *Vetting of the Nominee for Approval as the Inspector-General of the National Police Service, laid on the Table of the House on Tuesday, April 2, 2019,* and pursuant to the provisions of Article 245(2)(a) of the Constitution, section 12(1) of the National Police Service Act, 2011 and section 8 of the Public Appointments (Parliamentary Approval) Act, 2011, this House <u>approves</u> the appointment of **Mr. Hilary Nzioki Mutyambai** as the Inspector-General of the National Police Service.

17*. MOTION- DEVELOPMENT AND IMPLEMENTATION OF A CURRICULUM FOR TRAINING STUDENTS AND PUPILS IN SCHOOLS ON ROAD SAFETY

(The Hon. Silvanus Osoro, M.P.)

THAT, concerned that available reports indicate that on average, road traffic accidents in the country cause an estimated 3,000 deaths with many other victims injured and maimed as a result, placing Kenya among the Countries with the highest road carnage globally; further concerned that it is estimated that the cost to the economy from road traffic accidents is in excess of Kshs. 300 billion annually according to the National Transport Safety Authority (NTSA) Road Safety Status Report (2015); aware that legislation and policies in place to a large

extent addresses the key road safety risk factors, and the challenge is in implementation and enforcement; cognizant that road safety awareness would help in combating road accidents in the country; acknowledging that section 4(2) of the National Transport and Safety Act mandates the NTSA to develop and implement road safety strategies; and facilitate the education of Members of the public on road safety; recognizing that schools provide the largest and most concentrated group of Members of the public who can benefit from road safety education; this **House resolves** that the National Government urgently develops and implements a mandatory and examinable curriculum for training of students and pupils in Primary and Secondary Schools on road safety.

18*. MOTION - MEASURES TO BRIDGE TRADE DEFICIT

(The Hon. Maj. (Rtd) John Waluke, M.P.)

THAT, aware that Kenya's trade deficit has been on the increase in the past few years with the financial year 2016/2017 deficit being estimated at Kshs.1.1 trillion; noting that, the deficit is mainly attributable to the exports worth Kshs.594 billion against imports amounting to Kshs.1.7 trillion, driven mainly by the more than doubling of food and machinery imports amid slowmoving exports; concerned that, the widening deficit has continued to pile pressure on the shilling against other global currencies such as the dollar; alarmed that, the high demand for the dollar to fund imports has been forcing the Central Bank of Kenya (CBK) to intervene, depleting foreign exchange reserves even as the Country continues to incur foreign debts; cognizant that, the rising imports amplified by flat exports portends a difficult operating environment for local enterprises and farmers thereby denying Kenyans employment opportunities when locals lose out to foreign manufacturers and farmers; notwithstanding the effects of protectionism policies which contribute towards affecting local industries and farms abilities to compete in international markets; this House resolves that the Government urgently puts in place measures to bridge the huge trade deficit including by providing incentives to potential investors and farmers, supporting local production through promotion and protection of local industries and implementing competitive export promotion strategies.

19*. MOTION **FORMULATION OF SELF-REGULATORY** MECHANISMS FOR RELIGIOUS INSTITUTIONS (The Hon. Muturi Kigano, M.P.)

THAT, aware of our ethnic, cultural and religious diversity as recognized by the Constitution; further aware that Article 27(4) of the Constitution provides that the State shall not discriminate directly or indirectly against any person on any ground, including religion; noting that Article 32 of the Constitution provides that every person has the right to freedom of religion; cognizant of the fact that the rights and freedoms under Articles 27 and 32 of the Constitution are

not absolute but are rights and freedoms that can be limited; concerned that the Country has been experiencing a proliferation and emergence of cults and sects under the guise of religious institutions; further concerned that the general public and revenue collection agencies have often fallen prey to fraudulent and unscrupulous persons acting as religious leaders; also concerned that the growth of these religious institutions remain largely unregulated including on matters such as the registration, standards of operation, requirements for establishment, appointment and qualifications for religious leaders, among other things; this House **resolves** that the Office of the Attorney General –

- (i) forthwith undertakes an audit of all religious institutions in Kenya including examining their bank accounts and qualifications of the religious leaders, with a view to formulating self-regulatory mechanisms; and,
- (ii) submits a report to the House on the audit within ninety (90) days of passage of this Motion.

- II. I. MOTION ON THE REPORT ON EXAMINATION OF THE FINANCIAL STATEMENTS FOR THE INDEPENDENT ELECTORAL AND BOUNDARIES COMMISSION FOR THE YEAR ENDED 30TH JUNE 2017

NOTICE is given that the Member for Homa Bay Town (The Hon. Peter Kaluma, MP) intends to move the following amendment to the Motion on the Report on Examination of the Financial Statements for the Independent Electoral and Boundaries Commission for the year ended 30th June 2017-

THAT, the Motion be amended by inserting the following expression immediately after the expression "February 27, 2019" **subject to** -

- (i) deletion of <u>Recommendation 1</u> under Chapter 33.0 (Committee Recommendations) on pages 4 and 127 of the Report and substituting therefor the following-
 - **"1.** Parliament expedites the strengthening of IEBC by reviewing the legal framework and the general policy guidelines while taking into account the recommendations of the Kriegler Commission. Further, Parliament considers reviewing or repealing section 11A of the IEBC Act relating to the functions of the Commission and the secretariat, to bring clarity to the constitutional functions of the Commission vis-a-vis the administrative functions of the secretariat."
- (ii) deletion of the words "Commissioners failed to exercise oversight while the" appearing in the first line of Recommendation 3 under Chapter 33.0 (Committee Recommendations) on page 4 and 127 of the Report;
- (iii) Insertion of the following recommendations 9(a), (b), (c), (d) and (e) under Chapter 33.0 (Committee Recommendations) on page 128 of the Report -
 - M/S. IDEMIA (formerly *Morpho, OT Morpho, SAFRAN Identity & Security*)
 - **9**. Noting the Committee's Conclusions and Observations on pages 120 126, relating to IDEMIA regarding its engagements in Kenya, the House further recommends-

- (a) THAT, the Directorate of Criminal Investigations and the Director of Public Prosecutions undertakes investigations and institutes appropriate criminal action under section 974(3) of the Companies Act against M/S. IDEMIA in its current name and in its former names of M/S. Morpho, OT Morpho, SAFRAN Identity & Security, its officers and local representatives for having purported to do business with the IEBC before being registered as a foreign company by the Registrar of Companies and noncompliance with the mandatory provisions of sections 974(1) as read together with sections 975 and 979 of the Companies Act, No. 17 of 2015;
- **(b) THAT**, pursuant to the provisions of section 41 of the Public Procurement and Asset Disposal Act, 2015, the Public Procurement Regulatory Authority Board investigates, within sixty (60) days, the conduct of M/S. IDEMIA (formally operating as Morpho, OT Morpho, SAFRAN Identity & Security) and if it finds the company culpable, enters the names of the company in the central repository of **debarred** firms and ensures that the firm is precluded from participating, award or entering into any kind of procurement contract payable using public funds under any state department or agency in the Republic of Kenya for a period of 10 years;
- (c) THAT, all contracts entered into between the company known as M/S. IDEMIA in its current name herein or in its former names of *Morpho, OT Morpho, SAFRAN Identity & Security* and the IEBC be investigated and if found to have contravened sections 974, 975, 979 or any other section of the Companies Act or any other law, be nullified;
- (d) THAT, the IEBC takes immediate legal action to recover all monies unlawfully paid under the contract(s) entered into between itself and M/S. IDEMIA in its current name herein or in its former names of *Morpho, OT Morpho, SAFRAN Identity & Security* or otherwise howsoever; as the contracts were entered into in contravention of the mandatory provisions of sections 974 as read together with sections 975 and 979 of the Companies Act; and,
- **(e) THAT**, the Attorney General and the Cabinet Secretary for the National Treasury ensures compliance with the resolution of the House under recommendation 9 (b) and any state of public offer who contravenes the said resolution be held personally liable.

- THAT, notwithstanding the provisions of Standing Order 97(4), each speech in a debate on Bills sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party shall be limited as follows:- A maximum of forty five (45) minutes for the Mover, in moving and fifteen minutes (15) in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee), and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each (if the Bill is not sponsored by either of them); and that priority in speaking shall be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in that order.
- THAT, notwithstanding the provisions of Standing Order 97(4), each speech in debate on Reports of Committees, including a Report of a Joint Committee of the Houses of Parliament or any other Report submitted to the House for which limitation of time has not been specified, shall be limited as follows:- A maximum of sixty (60) minutes for the Mover in moving and thirty (30) minutes in replying, and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each; and that priority shall be accorded to the Leader of the Majority Party and the Leader of the Minority Party, in that order.
- **IV. THAT**, notwithstanding the provisions of Standing Order 97(4), each speech in a debate on any **Motion**, including a Special motion shall be limited in the following manner:- A maximum of three hours with not more than twenty (20) minutes for the Mover and ten (10) minutes for each other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each, and that ten (10) minutes before the expiry of the time, the Mover shall be called upon to reply; and that priority in speaking shall be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in that order.
