REJECTION OF THE NATIONAL ASSEMBLY'S AMENDMENTS TO THE COUNTY GOVERNMENTS (AMENDMENT) (NO. 2) BILL (SENATE BILL NO. 7 OF 2017)

The Speaker delivered the following Message from the Senate:

"Honourable Members, pursuant to the provisions of Standing Order 41, I wish to report to the House that I am in receipt of a Message from the Senate conveying the decision of the Senate on the County Governments (Amendment) (No. 2) Bill (Senate Bills No. 7 of 2017).

Honourable Members, you will recall that the County Governments (Amendment) (No. 2) Bill (Senate Bill No. 7 of 2017) was **passed** by the National Assembly **with amendments** on Tuesday, March 26, 2019. The Message reads in part, and I quote: -

"...on Thursday, 30th May, 2019, the Senate considered and <u>rejected</u> a Motion to consider the National Assembly amendments to the County Governments (Amendment) (No. 2) Bill (Senate Bills No. 7 of 2017) to clauses 2 and 3..."

Honourable Members, the import of the Senate's decision is that the Bill is now required to proceed for mediation, pursuant to the provisions of Article 112 of the Constitution and Standing Order 149 of the National Assembly Standing Orders.

Honourable Members, in light of this, I have therefore appointed the following Members to represent the National Assembly in the Mediation Committee on this Bill, in accordance with the provisions of Article 113 of the Constitution: -

- 1. The Hon. Didmus Barasa, MP;
- 2. The Hon. Amos Kimunya EGH, MP;
- 3. The Hon. Peter Kaluma, MP;
- 4. The Hon. Edward Oku Kaunya, MP; and
- 5. The Hon. Halima Mucheke, MP.

The Members are advised to liaise with their Senate Counterparts so as to expeditiously embark on the process of developing an agreed version of the Bill.

5. **PETITIONS**

i) The Speaker conveyed the following Petition-

PETITION REGARDING UNETHICAL CONDUCT BY THE REGISTRAR OF COMPANIES UNDER THE WATCH OF THE OF THE REGISTRAR GENERAL

Honourable Members, Standing Order 225(2) (b) requires the Speaker to report to the House any Petition, other than those presented by a Member. I therefore wish to report to the House that my office has received a Petition, submitted by Mr. Samuel Matheri Hungu on behalf of Midlands Limited as a shareholder.

The petitioner is praying that the House investigates the conduct of the Registrar of Companies and the Registrar General. The petitioner claims that by knowingly ignoring the fact that the above mentioned company has not held any Annual General Meetings since 13th January 2013, the two public officers are in breach of Article 48 of the company's Article of Association which states that Annual General Meetings should be held within a maximum interval of 15 months and Section 277 of the Companies Act, 2015 which provides for the convening of an extra ordinary General Meeting.

Honourable Members, the petitioner is of the opinion that the afore-mentioned public officers are keeping an illegitimate Board of Directors in office by denying calls to convene an extra ordinary general meeting. The petitioner is skeptical of the Board's intentions to transfer the farmers' company to an offshore entity, Primestar Holdings, in the West Indies and raises concern regarding the underlying intentions of the sale and the consequences it may inflict on the 12,000 rural households that are shareholders in the company.

Honourable Members, given the circumstances around the sale, the petitioner is apprehensive that there is intent to commit fraud by the public officers and the allegedly illegitimate board that could have dire consequences to the citizens who are shareholders in the company and greater, far reaching consequences for agro-processing in general.

Honourable Members, the petitioner prays that the House to investigate the conduct of the Registrar of companies and the Registrar General in relation to the matters raised in this Petition and launches an inquiry into the intended sale of Midlands Limited to the overseas entity and identifying the owners of Prime star Holding Ltd.

GUIDE ON THE PROCEDURE FOR CONSIDERATION OF BUDGET ESTIMATES FOR THE FY2019/2020 AND COMMITTEE OF SUPPLY

"Honourable Members, as you are aware, the House is scheduled to proceed to consider the Estimates for the FY 2019/2020 in the Committee of Supply to supply resources to the various Votes in state Ministries, Departments, agencies, Constitutional Commissions and Independent Offices. Several amendments have been proposed by Members on the said Estimates as published in the Order paper. You will note that, under each of those amendments, there is a disclaimer indicating that "the amendment is subject to the provisions of Article 114(2) of the Constitution". This is because, as required under Article 114(2) of the Constitution, I forwarded the proposed amendments to the Budget and Appropriations Committee for consideration and guidance on how the House may proceed.

In this regard, may I at this juncture, request the Chairperson, Budget & Appropriations Committee to pronounce the recommendations of the Committee as contemplated in Article 114(2) of the Constitution, **in respect of each amendment.**"

[At this Juncture, the Honourable Speaker allowed the Chairperson of the Budget and Appropriations Committee, Hon. Kimani Ichung'wah, to read his Statement on behalf of the Committee]

STATEMENT ON THE CONSIDERATION OF PROPOSED AMENDMENTS TO THE FY 2019/2020 BUDGET ESTIMATES

"Mr. Speaker, pursuant to Article 114(2) of the Constitution the following proposed amendments were forwarded to the Budget and Appropriations Committee. The Committee during its sitting held on 18th June 2019 met with affected Departmental Committee Chairpersons and respective Movers of Motions.

Mr Speaker, in this regard, the Committee proposes that the Committee of Supply proceeds further to consider the following amendments: In respect of-
