(i) Statement Pursuant to Standing Order 47(1)

Seneta wa Kaunti ya Mombasa (Sen. Mohamed Faki, MP) alitoa taarifa kuhusu hoja ya ki-eneo kuambatana na kifungu cha 47(1) cha Kanuni za Bunge la Seneti inayohusu mipango ya Serikali Kuu kujenga kwa niaba ya kaunti tano za Pwani, makao makuu ya Idara ya Uvuvi katika eneo la South C, Jijini Nairobi.

Seneta Mwinyihaji alilieleza Bunge la Seneti kuwa uvuvi ni moja wapo ya huduma ama shughuli ambazo zimegatuliwa kulingana na Katiba ya Nchi, hivyo basi huduma za uvuvi zinapaswa kutolewa na Serikali za Kaunti na maswala yote kuhusu uvuvi kusimamia na serikali zizo hizo.

Seneta Mwinyihaji alieleza kuwa lengo na madhumuni ya ujenzi wa makao makuu hayo ni kuinua hali ya uchumi wa watu wa Pwani wanaohusika na uvuvi wa Baharini na pia kuboresha miundo msingi katika maeneo ya Pwani ili kuinua hali ya maisha ya wakazi wanaotegemea uvuvi wa Baharini. Mradi huo unakusudiwa kufaidi Kaunti Tano, zikiwemo Mombasa, Kwale, Kilifi, Tana River na Lamu. Mradi huo unahusishwa na utafiti ambao utafanywa na Kenya Marine and Fisheries Institute ambao makao yake yako Mombasa.

Seneta Mwinyihaji alifahamisha Bunge la Seneti kwamba Wizara ya Kilimo na Uvuvi imetangaza zabuni ya ujenzi wa makao makuu ya Idara ya Uvuvi, yaani Fisheries House jijini Nairobi licha ya Kaunti za Mombasa, Kwale, Kilifi, Tana River na Lamu zina ardhi ya kutosha. Alielezea kuwa ujenzi wa mradi huo unafanywa chini ya usimamizi wa Wizara ya Kilimo na Uvuvi kupitia Taasisi ya Kenya Marine and Fisheries Institute ambayo makao makuu yake yako Jijini Mombasa kwa ufadhili wa Benki ya Dunia. Seneta Mwinyihaji alikariri kuwa kuwekwa kwa makao makuu ya uvuvi Jijini Nairobi itakuwa ni hujuma kwa Ugatuzi kwani maswali ya uvuvi yamegatuliwa kiukamilifu na kwamba Serikali inapaswa kulinda na kukuza maeneo ya kuvua samaki ili yasiingiliwe na wavuvi wa kimataifa.

Seneta Mwinyihaji alikariri kuwa iwapo makao hayo yatajengwa Nairobi, itakua vigumu na gharama kuu kwa wavuvi kutoka kwa mfano Vanga Kaunti ya Kwale ama Kiunga Kaunti ya Lamu kusafiri hadi Nairobi ili wapate huduma katika ofisi za Uvuvi.

(iii) Statement Pursuant to Standing Order 51(1)(a)

The Chairperson, Standing Committee on Labour and Social Welfare issued a statement on the Status Report on the payment of *Inua Jamii* Cash Transfer Beneficiaries for March/April and May/June, 2019 as reported by the Ministry of Labour and Social Protection in a letter dated 25th June, 2019.

Thereupon, the Chairperson informed the House that *Inua Jamii* is implanted through three programs namely- Older Persons Cash Transfer Program (OPCT), Orphans and Vulnerable Children (CT-OVC) and Persons living with Severe Disabilities (PWSD). The Ministry launched a new cash transfer model that migrated the beneficiaries from a card-based system to an account-based system administered through 4 banks, namely, the Cooperative Bank of Kenya, Equity Bank, Kenya Commercial Bank and Post Bank.

The Chairperson also informed the House that during Phase 1 (November 2018 to March 2019) and Phase 2 (April-May 2019) migrations, the Ministry opened bank accounts for 1,070,238 beneficiaries out of 1,233,329 registered. He then outlined the payment cycle for March/April and May/June 2019 as provided by the Ministry of Labour and Social Protection.

The Chairperson further informed the Senate that the Committee had invited the Cabinet Secretary for Labour and Social Protection to a meeting to be held in the County Hall Mini Chamber on Wednesday, 24th July, 2019 from 10:00 am and invited all Senators who had raised statements under the mandate of the said Ministry to attend the meeting.

18. MOTION - STAFF RATIONALIZATION IN COUNTIES.

Order read;

Motion made;

THAT, AWARE THAT the Senate represents the counties, and serves to protect the interests of the Counties and their governments;

FURTHER AWARE THAT, the launch of the Capacity Assessment and Rationalization of the Public Service (CARPS) Programme was launched by the Inter-Governmental Steering Committee (IGSC) on 14th July 2014 with the objective of transforming the Public Service for efficient and effective service delivery at both levels of Government;

NOTING THAT, the implementation timelines for the CARPS programme of two years specifically with regard to the capacity assessment, workload analysis and

staff redeployment and transfers, are of paramount importance in the Counties as the terms of all second term County Governors come to a close in 2022;

CONCERNED THAT, County governments are still engaged in uncontrolled hiring of staff in total violation of applicable laws, exposing a glaring imbalance between money spent on recurrent expenditure, versus budgets for development projects which are the essence of devolution;

CONCERNED FURTHER THAT, contrary to Section 15(2)(b) of the Public Finance Management (PFM) Act, in counties such as Nairobi, Machakos, Garissa, Kisumu, Wajir, Baringo, Narok, Nakuru and Nyamira, staff salaries consumed in excess of 75% of total expenditure, over and above the set limit of 35% as provided in Regulation 25 (1) of the Public Finance Management (County Governments) Regulations, 2015 during the FY 2018/2019;

DEEPLY CONCERNED THAT, although Section 65 of the County Governments Act requires that more than 30% of the vacancies at entry level be given to members of ethnic groups that are not dominant in their precincts, the 2016 Ethnic and Diversity audit launched by the National Cohesion and Integration Commission revealed that 68% of Counties have hired more than 70% of their staff from one ethnic group;

NOW THEREFORE in exercise of its oversight function, the Senate resolves that the Public Service Commission (PSC), Intergovernmental Relations Technical Committee (IGTRC) and the Council of Governors provide a comprehensive report on:

- 1. the progress and implementation status of the Capacity Assessment and Rationalization of the Public Service (CARPS) Programme indicating the County Governments that are compliant; and
- 2. the number of employees in each County Government showing the amount spent as wage bill vis a vis recurrent expenditure budgeted for FY 2018/2019. and submit these reports to the Senate within 60 days of this resolution.

THAT, AWARE THAT, Murang'a University of Technology (MUT) is a Chartered University established under Section 13 of the Universities Act, 2012, and is positioning itself to develop a distinctive profile as a progressive and international Technical University, growing its enrolment strategically;

FURTHER AWARE that the University is located in Murang'a County, the home County of the late politician Kenneth Njindo Matiba, who died a patriotic and political hero, with numerous achievements spanning four decades;

NOTING THAT, the late Matiba was a prolific industrialist in the hospitality and education sector, and an accomplished public servant having served as the first indigenous African Permanent Secretary for Education in 1963; Permanent Secretary for Commerce; Chairperson of the Kenya Football Federation from 1974-78; a member of parliament for Kiharu constituency; Cabinet Minister for Health; Culture & Social Services; and Transport & Communications;

FURTHER NOTING THAT, the late Matiba was part of the opposition alliance that led the liberation struggle for the restoration of multi-party democracy through the Forum for the Restoration of Democracy (FORD), later founding FORD –Asili under which he ran for presidency in 1992 general election;

COGNIZANT that under the Heroes Act, 2014, the state is obliged to confer recognition to the late statesman for his cardinal contributions to the political and economic growth of this country;

FURTHER COGNIZANT that other patriotic Kenyans like Jomo Kenyatta, Daniel arap Moi, Masinde Muliro, Dedan Kimathi and Jaramogi Oginga Odinga have been accorded such recognition;

NOW THEREFORE, the Senate urges the National Government in remembrance of Matiba's contribution to our Nation, to rename Murang'a University of Technology to Kenneth Matiba University of Technology.
