CHAIRPERSON'S FOREWORD

This report contains the Committee's proceedings of the consideration of the Senate amendments to the County Government Retirement Scheme Bill, 2018. The County Government Retirement Scheme Bill, 2018 was passed by the National Assembly on Wednesday, 17th October, 2018 and thereafter conveyed to the Senate in accordance with the provisions of Article 110(4) of the Constitution. Subsequently, the Senate considered the Bill and passed it with amendments on Wednesday, 31st July, 2019. The amendments were thereafter conveyed to the Departmental Committee on Finance and National Planning on Tuesday, 7th August, 2019. The Committee subsequently considered the amendments on Tuesday, 9th September, 2019 as contained in this report.

The Committee is grateful to the Offices of the Speaker and the Clerk of the National Assembly for the logistical and technical support accorded to it during the consideration of the Senate amendments to the Bill. Finally, I wish to express my appreciation to the Honorable Members of the Committee who made useful contributions towards the preparation and production of this report.

On behalf of the Departmental Committee on Finance and National Planning and pursuant to provisions of Standing Order 199 (6), it is my pleasant privilege and honour to present to this House the report of the Committee on its consideration of the Senate amendments to the County Government Retirement Scheme Bill (N.A. Bill No. 10 of 2018).

EXECUTIVE SUMMARY

The County Government Retirement Scheme Bill, 2018 was considered and passed with amendments by the Senate on **Wednesday**, 31st **July**, 2019. The amendments were then sent to the National Assembly for consideration vide a message from the Speaker of the Senate to the Speaker of the National Assembly. The amendments were then committed to the Departmental Committee on Finance and National Planning for consideration on **Wednesday** 7th **August**, 2019.

The Bill seeks to establish to establish the County Governments' Retirement Scheme as a mandatory Scheme for all County Government Officers; provide for the establishment of the Scheme's Board of Trustees and provide for the Scheme's management and administration. The Bill proposes to have the scheme offer lump sum payments as provident, periodic payments as pensions and income draw-downs. The proposed Scheme will provide one universal scheme for all the forty-seven county governments besides being open to other persons approved by the Board.

1 PREFACE

1.1 Establishment of the Committee

- The Departmental Committee on Finance & National Planning is one of the fifteen Departmental Committees of the National Assembly established under *Standing Order 216* whose mandates pursuant to the *Standing Order 216 (5)* are as follows:
 - To investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned ministries and departments;
 - ii. To study the programme and policy objectives of Ministries and departments and the effectiveness of their implementation;
 - iii. To study and review all the legislation referred to it;
 - iv. To study, access and analyze the relative success of the Ministries and departments as measured by the results obtained as compared with their stated objectives;
 - v. To investigate and inquire into all matters relating to the assigned Ministries and departments as they may deem necessary, and as may be referred to them by the House;
 - vi. To vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order No. 204 (Committee on appointments);
 - vii. To examine treaties, agreements and conventions;
 - viii. To make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;
 - ix. To consider reports of Commissions and Independent Offices submitted to the House pursuant to the provisions of Article 254 of the Constitution; and
 - x. To examine any questions raised by Members on a matter within its mandate.

1.2 Mandate of the Committee

- 2. In accordance with the Second Schedule of the Standing Orders, the Committee is mandated to consider, public finance, monetary policies, public debt, financial institutions (excluding those in securities exchange), investment and divestiture policies, pricing policies, banking, insurance, population revenue policies including taxation and national planning and development.
- 3. In executing its mandate, the Committee oversees the following government Ministries and departments;
 - a. The National Treasury and Ministry of Planning
 - b. Ministry of Devolution and ASAL
 - c. The Commission on Revenue Allocation
 - d. Office of the Controller of Budget

2 COMMITTEE CONSIDERATION OF THE SENATE AMENDMENTS TO THE PUBLIC PRIVATE PARTNERSHIPS (AMENDMENT) BILL, 2017

2.1 BACKGROUND INFORMATION

- 5. The County Government Retirement Scheme Bill, 2018 was considered and passed with amendments by the Senate on Wednesday, 31st July, 2019. The amendments were then sent to the National Assembly for consideration vide a message from the Speaker of the Senate to the Speaker of the National Assembly. The amendments were then committed to the Departmental Committee on Finance and National Planning for consideration on Wednesday 7th August, 2019.
- 6. The Committee proceeded to consider the amendments as proposed by the Senate.

2.2 SENATE AMENDMENTS TO THE COUNTY GOVERNMENT RETIREMENT SCHEME BILL, 2018

7. The Senate considered the County Governments Retirement Scheme Bill, 2018 and passed the following amendments:-

Clause 3

- 8. THAT clause 3 of the Bill be amended by inserting the following new paragraph immediately after paragraph (e)-
 - (f) protect the benefits of the members of the Scheme.

Clause 4

- 9. THAT clause 4 of the Bill be amended in subclause (3) by inserting the following new paragraph immediately after paragraph (c)-
 - (ca) gratuity; and

Clause 6

10. THAT the Bill be amended by deleting clause 6 and substituting therefor the following new clause-

Board of Trustees of 6(1) The management of the Scheme shall vest in a Board of Trustees of the

the Scheme.

Scheme.

- (2) The Board shall consist of-
 - (a) the chairperson elected by the Trustees from among the members under paragraph (c), (d), (e) and (f);
 - (b) the Principal Secretary responsible for matters relating to finance or a representative;
 - (c) a person nominated by Council of County Governors;
 - (d) a person nominated by County Public Service Boards;
 - (e) a person nominated by County Assembly Service Boards;
 - (f) five persons nominated by most representative trade unions representing employees of county governments of whom at least two shall not be of the same gender as follows
 - i. four persons from trade unions representing the employees within the county executive; and
 - ii. a person from trade unions reprepresenting the employees within the county assemblies' service; and
 - (g) the chief executive officer who shall be an ex officio member and the secretary to the Board with no voting rights.
- (3) The vice-chairperson of the Board shall be elected by the Trustees from among their number.
- (4) The chairperson and vice-chairperson shall be of the opposite gender.
- (5) The Cabinet Secretary shall ensure that not more than two thirds of the members of the Board are of the same gender.
- (6) The Cabinet Secretary shall appoint the persons nominated under subsection (2) by notice in the gazette.
- (7) The procedure for nomination and appointment of Trustees under subsection (2) shall be prescribed in the regulations.

Clause 10

11. THAT clause 10 of the Bill be amended in subclause (1) by deleting the word "three" appearing immediately after the words "absence from" appearing in paragraph (e) and substituting therefor the word "two".

Clause 16

12. THAT the Bill be amended by deleting clause 16 and substituting therefor the following new clause-

Remuneration of

(16) The Trustees shall be paid such remuneration as the Authority may determine

in accordance with the Retirement Benefits Act.

Clause 18

- 13. THAT clause 18 of the Bill be amended by inserting the following new subclause immediately after subclause (4)-
 - (4a) The chief executive officer shall hold office for a term of three years and may be eligible for re-appointment for a further final term of three years.

Clause 21

14. THAT clause 21 of the Bill be amended in paragraph (d) by deleting the words "provide regular information" appearing immediately before the words "on investment strategy" and substituting the words "submit reports on a quarterly basis".

Clause 22

- 15. THAT clause 22 of the Bill be amended in sub-clause (1) by inserting the following new paragraph immediately after paragraph (f)-
 - (fa) submit to the Board a report on a quarterly basis, of the reconciliations with respect to the funds held by the Custodian;

Clause 23

- 16. THAT clause 23 of the Bill be amended in sub-clause (2) by-
 - (a) inserting the word "at least on a quarterly basis" immediately after the words "including access" in paragraph (d);
 - (b) inserting the following new paragraph immediately after paragraph (d)-
 - (da) keep and maintain proper books of accounts of the scheme;

Clause 24

- 17. THAT clause 24 of the Bill be amended
- (a) by deleting sub-clause (1) and substituting therefore the following new sub-clause-
 - (1) A member shall, so long as the member remains in the employment of a sponsor, contribute not less than twelve percent of that member's pensionable emoluments to the Scheme.

- (b) in sub-clause (2) by inserting the words "not less than" immediately after the words "contribute to the scheme".
- (c) In sub-clause (5) by deleting the words "on each occasion" appearing immediately after the words "salary of the contributor" and substituting therefor the words "in each month".

Clause 44

- 18. THAT clause 44 of the Bill be amended by deleting sub-clause (1) and substituting therefor the following new sub-clause-
- (1) The Scheme shall be reviewed by an actuary appointed by the Board as provided for in the Retirement Benefits Act.

Clause 46

19. THAT clause 46 of the Bill be amended in the introductory phrase in sub-clause (2) by inserting the word "actuary" immediately after the words "fund manager".

Clause 48

- 20. THAT clause 48 of the Bill be amended-
- (a) In sub-clause (1) by deleting the words "two years" appearing immediately after the words "imprisonment for a term not exceeding" at the end of the sub-clause and substituting therefor the words "five years".
- (b) By inserting the following new sub-clause immediately after sub-clause (2)-
 - (3) A person who is convicted of an offence under subsection (1)(c) shall, in addition to any fine that may be imposed, refund to the Scheme three times the value of any loss that may be incurred by the scheme by reason of the commission of the offence.

Clause 55

- 21. THAT clause 55 of the Bill be amended by inserting the following new sub-clauses immediately after sub-clause (6)-
 - (7) The Auditor General shall cause an actuarial audit and valuation to be carried out with respect to the closed schemes within six months upon the commencement of this Act to ascertain the following for the purpose of transitional management-
 - (a) assets acquired by the schemes:
 - (b) liabilities accrued by the schemes; and
 - (c) employees of the schemes.

(8) The Auditor General shall submit a report on the findings of the audit and valuation to the Board, the Senate and the National Assembly within three months of carrying out of the audit under sub-section (7).

Clause 56

- 22. THAT clause 56 of the Bill be amended by deleting sub-clause (6) and substituting the following new sub-clause-
 - (6) The Retirement Benefits Authority shall, within five years from the commencement of this Act, ensure the implementation of this section.

Clause 59

23. THAT the Bill be amended by inserting the following new clause immediately after clause 58-Amendment of 59. The County Governments Act is amended by deleting section 132. section 132 of Act no. 17 of 2012

First Schedule

- 24. The First Schedule is amended in paragraph 2 by deleting subparagraphs (1) and (2) and substituting therefor the following new sub-paragraphs-
 - (1) The quorum of a meeting of the Board shall be five Trustees present and voting and shall include at least two Trustees appointed under section 6(2)(b), (c), (d) or (e) and at least three Trustees appointed under section 6(2)(f).
 - (2) For special meetings, the quorum shall be six Trustees present and voting shall include at least three Trustees appointed under section 6(2)(b), (c), (d) or (e) and at least four Trustees appointed under section 6(2)(f).

3 COMMITTEE OBSERVATION AND RECOMMENDATION

- 25. The Committee considered the proposed Senate amendments to the County Government Retirement Scheme Bill, 2018 and agreed with the amendments as proposed by the Senate as they are aligning the Bill with corporate governance measures established under the Retirement Benefits Act, 1997.
- 26. The Committee therefore **recommends** to the House that the Senate amendments to the County Government Retirement Scheme Bill, 2018 be passed by the House without amendments.

CONSIDER THE FINANCE BILL, 2019

The Chairperson invited Hon. Moses Kuria, MP to make his submission on the Finance Bill, 2019. He submitted as follows:-

- 1. That his proposal was seeking to amend the current provision section 33B of the Banking Act so as to require that banks maintain a credit score rating for its customers to ensure that loans issued are based on an individual's credit score. He proposed that a window of negotiation be placed at six points above the Central Bank Rate and the banks would then use the credit score to price the credit facilities and determine the actual interest rate payable.
- 2. That the country is not ready for the repeal of interest caps because there are not enough checks and balances to ensure that banks do not revert to very unaffordable credit facility.

Members Deliberations

- i. The meeting was of the opinion that continued government borrowing has continued to crowd out the private sector as the government borrowing is considered less risky. The Committee proposed that there was need for control of government domestic borrowing to ensure that banks are compelled to lend to the SMEs.
- ii. The meeting noted that it is important for banks to be obligated to give their clients credit score which will make it possible for them to access credit according to their scores.
