#### The House resolved on Wednesday, February 13, 2019 as follows:-

- **THAT**, notwithstanding the provisions of Standing Order 97(4), each speech in a debate on any **Sessional Paper** shall be limited as follows:- A maximum of two and a half hours, with not more than twenty (20) minutes for the Mover in moving and five (5) minutes for any other Member speaking, **including** the Leader of the Majority Party and the Leader of the Minority Party and that ten (10) minutes before the expiry of the time, the Mover shall be called upon to reply; and further that priority in speaking shall be accorded to the Leader of the Majority Party and the Leader of the Minority Party, in that order.
- THAT, notwithstanding the provisions of Standing Order 97(4), each speech in debate on Reports of Committees, including a Report of a Joint Committee of the Houses of Parliament or any other Report submitted to the House for which limitation of time has not been specified, shall be limited as follows:- A maximum of sixty (60) minutes for the Mover in moving and thirty (30) minutes in replying, and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each; and that priority shall be accorded to the Leader of the Majority Party and the Leader of the Minority Party, in that order.
- THAT, notwithstanding the provisions of Standing Order 97(4), each speech in a debate on any Motion, including a Special motion shall be limited in the following manner:- A maximum of three hours with not more than twenty (20) minutes for the Mover and ten (10) minutes for each other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each, and that ten (10) minutes before the expiry of the time, the Mover shall be called upon to reply; and that priority in speaking shall be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in that order.
- THAT, notwithstanding the provisions of Standing Order 97(4), each speech in a debate on Bills sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party shall be limited as follows:- A maximum of forty five (45) minutes for the Mover, in moving and fifteen minutes (15) in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee), and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each (if the Bill is not sponsored by either of them); and that priority in speaking shall be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in that order.

397/2019 The Member for Gichugu (Hon. Robert Gichimu Githinji, MP) to ask the Cabinet Secretary for Water, Irrigation and Sanitation-

Are there plans to provide the residents of Gichugu Constituency with water from the *Mega Kerugoya-Kutus Water Supply Project* being undertaken by the Tana Water Services Board?

- 420/2019 The Member for Bobasi (Hon. Innocent Obiri Momanyi, MP) to ask the Teachers Service Commission: -
  - (i) Could the Commission provide details why nine (9) head teachers in *Bobasi* Constituency were interdicted on 25<sup>th</sup> April, 2019?
  - (ii) Could the Commission explain why these teachers were not granted an opportunity to be heard before the action of interdicting them was taken?
  - (iii) Could the Commission consider lifting the interdictions and allow them to return to their workstations?

Sori Road that serves Rangwe, Ndhiwa, Gwasi, Uriri, Nyatike and Homabay Constituencies in Homabay and Migori Counties is still impassable, and has been in a state of disrepair for the past one year thereby impacting negatively on emergency evacuation, businesses and local commuters?

- (ii) Why was the Rodi Kopany Sori Road transferred from Kenya National Highways Authority (KENHA) to Kenya Rural Roads Authority (KeRRA despite the fact that it transverses Homa Bay, Ndhiwa and Nyatike Constituencies, and what is the current classification of the road?
- (iii) Could the Cabinet Secretary confirm which State Department is responsible for emergency repairs and maintenance of the said roads, provide a give a list of contractors and the amount of money disbursed to them for the said road from year 1990 to date, and finally confirm the timelines for repairing the road?

- (ii) What steps has the Ministry taken to address the challenge occasioned by the reduction in view of the fact that most tea farmers had already taken upfront loans at a rate of Ksh 30 per kilogram of tea in anticipation of tea bonus rate of Ksh 50 per kg?
- (iii) What long-term plans does the Government have in sustaining the tea and coffee sector in view of the fact that farmers have already started uprooting their tea and coffee crops?
