4. **COMMUNICATION FROM THE CHAIR**

The Speaker conveyed the following Communication -

Speaker's Roundtable with Kenya Private Sector Alliance

Topics of interest aimed at bolstering the roles of the two institutions are deliberated upon for prosperity and development of the Nation's Economy. 6. **NOTICE OF MOTION**

The following Notice of Motion were given -

Biometric Clocking-in in Public Institutions

THAT, aware that public offices have been established to provide government services to the Kenyan people; further aware that, provision of quality services by public institutions has been a matter of great public outcry due to absenteeism and negligence by officers; concerned that this goes against the principle of value for money for services offered and goods supplied to Government; further concerned that public officers in a number of key offices in government departments have been reported to be unavailable at their work stations to attend to Kenyans yet they continue to earn salaries; deeply concerned that in many cases, this lack of provision of services has led to loss of money, goods and even life, especially in public hospitals; this House **urges** the Government to speedily roll out installation of a biometric clocking-in system in all public institutions,

prominently display their service charters, and make provision for regular and mandatory checks at all offices to curb the menace of lax working conditions and absenteeism in all public institutions.

8. **STATEMENTS**

- a) The Member for Endebess (Hon. (Dr.) Robert Pukose, MP) sought an update regarding guidance pertaining to appearance by Chief Administrative Secretaries to respond to Questions before Departmental Committees on behalf of Cabinet Secretaries. The Honourable Speaker undertook to issue a Communication on the matter in due course.
- b) The Member for Tongaren (Hon.(Dr.) David Eseli Simiyu) rose on a Point of Order seeking the indulgence of the Honourable Speaker in directing the Departmental Committee on Agriculture and Livestock to conduct an inquiry into the woes facing the Coffee Research Institute exemplified by prevalence of Coffee Berry Disease in the Institute's own coffee crop, delayed staff remuneration, insufficient research funding, among other challenges. The Honourable Speaker acceded to the request, and pursuant to Standing Order 218(2), directed the Departmental Committee on Agriculture and Livestock to undertake an inquiry into the aforementioned matters

and other related concerns thereto, and to report to the House its findings and recommendations as soon as practically possible.

- c) The Member for Soy (Hon. Caleb Kositany, MP) congratulated Kenyan athletes who had broken multiple world records in various fields.
- d) Pursuant to Standing Order 43(1), the Member for Nandi Hills (Hon. Alfred Keter), sought the indulgence of the Honourable Speaker to pay accolades to national heroes from various backgrounds under *Zero Hour Statements*. The Honourable Speaker, having ascertained that the Statement had diverse elements and high interest, directed that the Statement be converted into a Motion for Adjournment of the House under Standing Order 33 for its scheduled discussion at 1800hrs.

9. <u>MOTION - PETITION BY THE EXECUTIVE FOR THE VARIATION OF THE</u> BOUNDARIES OF MOUNT ELGON FOREST RESERVE

Motion made and Question proposed -

THAT, this House **adopts** the Report of the Departmental Committees on Environment and Natural Resources and Lands on their consideration of a Petition by the Executive regarding the Variation of the Boundaries of Mount Elgon Forest Reserve, laid on the Table of the House on Thursday, July 4, 2019, and pursuant to the provisions of section 34(5)(b) of the Forest Conservation and Management Act, 2016 and noting the finding of the Committees that the Petition discloses ground for variation of boundaries of the particular forest, this House-

- (i) **approves** the variation of the boundaries of Mount Elgon Forest Reserve to exclude Chepyuk Phases II and III comprising of a total area of 4,607 Hectares; and
- (ii) <u>resolves</u> that the Government secures the remaining forest area within Mount Elgon Forest Reserve particularly in Chepkitale area in line with the need to achieve the United Nation's recommended ten percent forest cover in the country.

Debate interrupted on Wednesday, October 09, 2019 (Afternoon Sitting) resumed;

The Member for Luanda (Hon. Christopher Omulele) drew the attention of the Honourable Speaker to the fact that the Environment Impact Assessment (EIA) License issued by the National Environment Management Authority (NEMA) for the said variation had expired in 2013, having been issued in 2011;

Consequently, the Honourable Speaker ruled that the Motion for adoption of the said Report be stood down in view of the fact that the expired license from NEMA offended Section 34(4)(a) of the Forest Conservation and Management Act 2016, and thus run the possibility of invalidating the consideration of the Petition by the National Assembly;

The Honourable Speaker therefore directed the two Committees to jointly engage the National Environment Management Authority with a view to obtaining, and subsequently tabling by 14th November 2019, a fresh EIA License, following which the two Committees will resolve on whether to amend the Report and its resultant Motion or retain them in their current form;

Business dropped pending update by the Joint Committee on the Environment Impact Assessment License.

11. MOTION OF ADJOURNMENT TO DISCUSS URGENT MATTER OF NATIONAL IMPORTANCE UNDER STANDING ORDER 33

Motion made:-

"Honourable Speaker,

Pursuant to the provisions of Standing Order 43, I wish to raise a matter regarding several national heroes who have achieved much this week.

Honourable Speaker.

On Saturday, October 12, 2019, we celebrated with the world us as one of our own, Eliud Kipchoge, ran a 42km marathon in one hour, fifty-nine minutes and forty seconds, the first human being to ever do so. The same weekend, Brigid Kosgei broke a sixteen-year old record in the women's marathon, running it in two hours, fourteen minutes and four seconds. We also had our Kenya Navy and other agencies which managed to retrieve the vehicle that had sunk to a depth of over fifty metres in the Likoni Channel about two weeks ago. Several General Service Unit (GSU) officers also lost their lives in the line of duty while conducting security patrols in the Garissa area, while our soldiers are still fighting in Somalia as part of the AMISOM forces. These Kenyans have and continue to undertake extraordinary national duties, bringing high acclaim to our nation, and as we prepare to celebrate *Mashujaa* Day, they deserve special recognition for their contribution to and sacrifice on behalf of Kenya.

Honourable Speaker,

It is therefore against this background that I seek your leave to raise this matter during today's Statement Hour.
