#### 5. STATEMENTS

#### (a) **Pursuant to Standing Order 48(1)**

(i) The Senator for Isiolo County (Sen. Fatuma Dullo, MP) sought a statement from the Standing Committee on Land, Environment and Natural Resources on Legal Notice No. 150 of 27<sup>th</sup> August, 2019 by the Ministry of Lands and Physical Planning that seeks to open up land in Isiolo County for Adjudication.

## (b) Pursuant to Standing Order 51(1)(a)

The Chairperson, Standing Committee on Finance and Budget made a Statement on a matter for which the Committee was responsible, namely the stoppage of funds to County Governments.

#### (No. 090)

The Chairperson drew the attention of the House to a question raised on the floor of the Senate on Thursday, 21<sup>st</sup> November, 2019 regarding the purported stoppage of transfer of funds to county governments by the Cabinet Secretary (CS) of the National Treasury and Planning and to the fact that the Speaker had directed that the Committee meet the Cabinet Secretary and present a report on the issue to the Senate.

The Chairperson reported that the Committee had held a meeting with the CS as directed by the Speaker and gathered the following:

- (a) That the CS had, issued Circular No. 20/2019 Ref: IGFR/Pending Bills/01/A(24) invoking Section 97 of the Public Finance Management Act to stop transfer of equitable share of revenue for the Financial Year 2019/2020 with effect from 1<sup>st</sup> December, 2019 for various counties that had not made any effort to clear pending bills between 1<sup>st</sup> July, 2019 and end of October, 2019. The CS informed the Committee that additionally, no conditional grants would be released to the said counties.
- (b) That, vide a letter dated 25<sup>th</sup> November, 2019, the CS had forwarded the said Circular to both Houses of Parliament, seeking parliamentary approval for the same.

The Chairperson highlighted the provisions of Article 225 of the Constitution, specifically Clauses 4 - 7, which set out the procedure for the stoppage of funds to counties, as well as the provisions of Section 96(1) of the PFM Act regarding the same. The Chairperson informed the Senate that in light of the foregoing, the Controller of Budget was obligated to investigate the matter and submit a report to Parliament for consideration.

In conclusion, the Chairperson urged the Controller of Budget to expedite the investigations and submit a report on or before 3<sup>rd</sup> December, 2019 to enable Parliament make a decision on the matter on or before 18<sup>th</sup> December, 2019.

#### (c) Pursuant to Standing Order 51(1)(b)

The Vice Chairperson, Standing Committee on Roads and Transportation, issued a Statement relating to the activities of the Committee for the period 1<sup>st</sup> July to November, 2019.
