9. MOTION - SUSPENSION OF THE SITTINGS OF THE SENATE OUTSIDE NAIROBI FOR THE FOURTH SESSION, 2020

(The Senate Majority Leader)

THAT, AWARE THAT, pursuant to Article 126 (1) of the Constitution and Standing Order 31 (1) of the Senate, the Senate, by Resolution passed on 21st June, 2018, resolved that a sitting of the Senate be held away from the traditional premises in Parliament Buildings in Nairobi and that such sittings take place in all regions during the term of the Third Senate;

RECOGNISING THAT, the COVID-19 pandemic has continued to persist in the country, resulting in disruptions to the conduct of business of the Senate and of Parliament as a whole;

APPRECIATING THAT, in accordance with the World Health Organization and the Ministry of Health advisory for the containment of the pandemic, a set of guidelines have been issued for both Senate Plenary and committee to contain the spread of the pandemic in Parliament in particular, and in Kenya as a Whole;

NOW THEREFORE, the Senate resolves that, notwithstanding the Resolution of 21st June, 2018, the sittings outside Nairobi for the Fourth Session, 2020, be suspended.

10. EXTENSION OF MANDATE OF THE AD-HOC COMMITTEE ON MANAGED MEDICAL EQUIPMENT SERVICES

(Chairperson, Ad-hoc Committee on Managed Medical Equipment Services)

THAT, AWARE that the on 19th September, 2019, Senate resolved to establish a select Committee comprising nine (9) Senators to investigate and establish the facts surrounding the leasing of the Medical Equipment, in the now 119 beneficiary hospitals country wide;

APPRECIATING, that the initial mandate of the Select Committee lapsed on 5th October 2019, and extensions of the same approved by the Senate on 12th November, 2019, on 4th March, 2020, and on 14th July, 2020, respectively;

REGRETING, that due new evidence arising from the hearings revealed important gaps that need to be addressed in the inquiry, and further owing to the sheer scale and magnitude of the investigations, and the amount of documentation involved;

NOW THEREFORE, the Senate resolves to renew the mandate of the Committee by a further period of thirty-four (34) days to enable the Ad-hoc Committee to conclude its work and table its report in the Senate on or before 8th September, 2020.

THAT, AWARE THAT under Article 217 of the Constitution, the Senate by resolution is required to determine the basis for allocating among the counties the share of national revenue that is annually allocated to the county level of government;

FURTHER AWARE THAT, the Senate mandated the Standing Committee on Finance and Budget to consider the recommendations of the Commission on Revenue Allocation, and consulted the Cabinet Secretary responsible for Finance and the Council of Governors among others and subsequently conducted public participation pursuant to Article 118(1)(b) of the Constitution, as documented in the report tabled in the Senate on Monday, 13th July, 2020;

NOW THEREFORE the Senate resolves that pursuant to Article 217 (1) of the Constitution, the third Basis for sharing revenue among counties, for the Financial Year 2020/2021 to 2024/2025 be as follows –

a) Equitable share not exceeding Kshs. 316.50 billion

13. MOTION - PROVISION OF CEMETERY, FUNERAL PARLOURS AND CREMATORIA IN ALL COUNTIES

(Sen. (Dr.) Alice Milgo, MP)

THAT, AWARE THAT under Article 61 of the Constitution of Kenya, land in Kenya is classified into three categories, public, Community and private land;

FURTHER AWARE THAT, public land is vested in both the County and National Governments and is managed on their behalf by the National Land Commission, and that Article 62 (2) clarifies the distribution of public land between the two levels of government.;

COGNIZANT THAT, the Fourth Schedule of the Constitution delegates cemeteries, funeral parlours and crematoria as a function of County Governments;

CONCERNED THAT, cemeteries in the Country are filling up, and counties are finding it increasingly difficult to identify land to allocate as "public" for use as a cemetery with the knowledge that any cemetery or burial-place that is crowded and therefore dangerous to health is defined as constituting a nuisance in the Public Health Act;

NOW THEREFORE, the Senate calls upon the county governments to ensure that funds are allocated in the County Annual Development Plans for FY 2020/2021, towards the planning and development of cemetery, funeral parlours and crematory facilities.
