Amendment of section
8 of Cap. 196.

2. Section 8 of the Parliamentary Pensions Act is
amended –

(a) in sub-section (1) (b) by deleting the word “two” and
substituting therefor the word “one”; and

(b) by inserting the following new subsection
immediately after subsection (2)-

“(3)Notwithstanding subsection (2), a former Member of
Parliament who, having served in Parliament between
1st July, 1984 and 1st January, 2001 and is entitled to
pension under this section, and whose monthly pension
amounts to less than one hundred thousand shillings,
shall be entitled, with effect from 1st July, 2010, to a
monthly pension of one hundred thousand shilling.”
