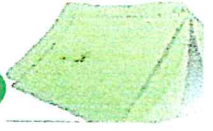

**RE: PETITION TO THE SENATE CONCERNING INTERGRATED  
INTERNALLY DISPLACED PERSONS 2007/2008 RESETTLEMENT  
PROGRAMME**

**We IDPs,**

Citizen of the Republic of Kenya and residents of Kibera-Kibra sub county:

**Draw the attention of the Senate to the following:**

**1. PARLIAMENT ACT**

1.1 THAT, Parliament establishes a law that protects and preserve the rights of all IDPs in Kenya-IDPs Act 2012.

THAT, all bon-afide internally Displaced persons (IDPs) who were evicted during 2007/2008 post election skirmishes qualify for a government kitty for compensation.

**2. BUDGET**

2.1 THAT, Parliament discussed and passed a budget of fiscal year 2016/2017 of 6 billion for internally displaced persons- integrated resettlement.

2.2 THAT, another allocation of 1.9 billion via supplementary budget of 2017/18 was added to the figure.

## **PETITION TO THE SENATE BY KIBERA IDPS CONCERNING RESETTLEMENT**

2.3 THAT, only over 2 billion was used to resettle a few post election violence victims of 2007/2008.

2.4 THAT, the remaining amount was never accounted for.

2.5 THAT, the chairman of NCCC- Aden Wachu confirmed that over 90,000 integrated IDPs were to be resettled with this amount.

2.6 THAT, the government of Kenya has the list for internally displaced persons who genuinely deserve allocation through the National Coordination consultative Committee (NCCC) Office.

### **3. LIST APPROVAL**

3.1 THAT, the government accepted the Kibera IDPs through then the District Commissioner for fund payment and resettlement.

3.2 THAT, those who flee from Kibera, were intergrated at Kibera, Kawangware, Waithaka, Ngando villages in Nairobi County.

3.3 THAT, they originally qualified for ten thousand kitty funds during their first government kitty – Operation Rudi Nyumbani programme.

3.4 THAT, they were genuinely displaced person intergrated.

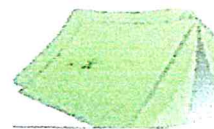
3.5 THAT, Many members were left out of the government disbursement allocation.

4. THAT, we have made the best efforts to have these matter addressed by the relevant authorities all of which have failed o give a satisfactory response.

## PETITION TO THE SENATE BY KIBERA IDPS CONCERNING RESETTLEMENT

5. THAT, none of these issues raised in this petition is pending in any Court of law, Constitutional and any other legal body.

Wherefore, your humble petitioners pray that the Senate

1. Fully compensate the entire IDPs as per the list.
2. THAT the total agreed amount of Kshs.200, 000 should be disbursed to the said group of persons.
3. THAT there should be thorough scrutiny of the record of payments by the NCCC office.
4. THAT office of the National Co-ordination Consultative Committee on IDPs office should be operational to serve its Citizenry.
5. THAT all IDPs should get equal share as per the resettlement programme including land.
6. THAT all members appearing in government records be recognized.
