- (iii) When will the Ministry cause cancellation of the title deed that was obtained fraudulently with respect to the parcel meant for Mr. Lali Bakari Lali?
- (iv) Could the Cabinet secretary clarify whether the land currently occupied by the government offices was compulsory acquired, whether the owners were compensated and if so, how much was paid and to whom?
