4. MESSAGES

The Fourth Chairperson conveyed the following Message from the Senate -

Passage of the County Allocation of Revenue Bill (Senate Bill No, of 2020)

Honourable Members, pursuant to the provisions of Standing Order 41, I wish to report to the House that I have received a Message from the Senate regarding its passage of the *County Allocation of Revenue Bill (Senate Bill No. 7 of 2020).*

Honourable Members, the Message reads in part, and *I quote*, "the Senate considered and **passed** the said Bill on Tuesday, 29th September, 2020 **with amendments**"

Honourable Members, the County Allocation of Revenue Bill is an annual legislation introduced in accordance with the provisions of Article 218 of the Constitution with the objective of equitably allocating the share of national revenue amongst the forty seven (47) Counties. Given the urgency of the passage of this Bill and in furtherance to the provisions of Standing Order 124(2)(a), the Budget and Appropriations Committee is directed to expedite consideration of the Bill to enable the House to consider the Bill in all stages during the sitting of Tuesday, October 6, 2020, and unlock the budget processes in the forty seven (47) Counties.

Honourable Members, May I also take this opportunity to remind the House of the provisions of Article 111(2) of the Constitution which provides the voting thresholds for amending a special bill, (and I quote)-

"The National Assembly may amend or veto a special Bill that has been passed by the Senate only by a resolution supported by at least two-thirds of the members of the National Assembly."

A County Allocation of Revenue Bill is a special Bill concerning county governments in terms of Article 110(2)(a)(ii) of the Constitution. This implies that any amendment

proposed in this House on the Bill shall require to be supported by at least two-thirds of **all** the Members of this House for it to pass. The House is accordingly guided.
