Please clarify if it's possible to base this requirement on minimum or maximum dimensions based on the switch length and width needed	Bidders are advised that item 6 on page 30 "Dimensions (with power supply) 4.4 x 44.5 x 44.9 (centimetres)" shall be "19inch rack mountable"
