## CHAIRPERSON'S FOREWORD

Article 118(1) (b) of the Constitution provides that, "Parliament shall facilitate public participation and involvement in the legislative and other business of Parliament and its Committees". Standing Order 127 (3) provides that "the Departmental Committee to which a Bill is committed shall facilitate public participation and take into account the views and recommendations of the public when the Committee makes its report to the House"

The National Hospital Insurance Fund (Amendment) Bill (National Assembly Bill No. 21 of 2021) underwent First Reading on 9<sup>th</sup> June, 2021 and was committed to the Departmental Committee on Health for consideration and reporting to the House.

This report contains deliberations on the Bill. Most importantly, the Bill seeks to amend the National Hospital Insurance Fund Act, 1998, to establish the National Health Scheme and to enhance the mandate and capacity of the National Hospital Insurance Fund to facilitate and deliver the Universal Health Coverage.

Following placement of advertisements in the print media on 10<sup>th</sup> June, 2021 requesting for comments on the Bill from members of the public and relevant stakeholders pursuant to the provisions of Article 118(1)(b) of the Constitution of Kenya and Standing Order 127(3), the Committee received memoranda from ten (10) stakeholders namely; The Ministry of Health, The National Hospital Insurance Fund, Kenya Medical Practitioners, Pharmacists and Dentists Union, Dr. Kahura Mundia, the National Gender and Equality Commission, the Central Organization of Trade Unions (COTU), Federation of Kenya Employers, British-American Insurance Company Limited (BRITAM), the Kenya Association of Private Hospitals, and the Kenya Union of Nutritionists and Dietitians. The public participation meetings was held via the ZOOM video online platform on 30<sup>th</sup> June, 2021.

On behalf of the Departmental Committee on Health and pursuant to the provisions of Standing Order 199 (6), it is my pleasant privilege and honour to present to this House the Report of the Committee on its consideration of the National Hospital Insurance Fund (Amendment) Bill (National Assembly Bill No. 21 of 2021). The Committee is grateful to the Offices of the Speaker and the Clerk of the National Assembly for the logistical and technical support accorded to it during its sittings. The Committee further wishes to thank all stakeholders who submitted their comments on the Bill. Finally, I wish to express my appreciation to the Honourable Members of the Committee and the Committee Secretariat who made played significant role in preparation and production of this report.

It is my pleasure to report that the Committee has considered the National Hospital Insurance Fund (Amendment) Bill (National Assembly Bill No. 21 of 2021) and have the honour to table in the House the Committee's report on the Bill with recommendation that the House passes it with amendments as proposed.

## **PART I**

## 1 PREFACE

## 1.1 ESTABLISHMENT OF THE COMMITTEE

- 1. The Departmental Committee on Health is established pursuant to the provisions of Standing Order No. 216 of the National Assembly and in line with Article 124 of the Constitution which provides for the establishment of the Committees by Parliament. The mandate and functions of the Committee are:
  - a) Investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned Ministries and departments;
  - b) Study the programme and policy objectives of the Ministries and departments and the effectiveness of the implementation;
  - c) Study and review all legislation referred to it;
  - d) Study, assess and analyse the relative success of the Ministries and departments as measured by the results obtained as compared with its stated objectives;
  - e) Investigate and inquire into all matters relating to the assigned Ministries and departments as they may deem necessary, and as may be referred to them by the House;
  - f) Vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order 204;
  - fa) Examine treaties, agreements and conventions;
  - g) Make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;
  - h) Consider reports of Commissions and Independent Offices submitted to the House pursuant to the provisions of Article 254 of the Constitution; and
  - i) Examine any questions raised by Members on a matter within its mandate

## **PART II**

## 2.0 OVERVIEW OF THE NATIONAL HOSPITAL INSURANCE FUND (AMENDMENT) BILL, NATIONAL ASSEMBLY BILL NO. 21 OF 2021

#### 2.1 ANALYSIS OF THE BILL

6. The Bill seeks to amend the National Hospital Insurance Fund Act, 1998, to establish the National Health Scheme and to enhance the mandate and capacity of the National Hospital Insurance Fund to facilitate and deliver the Universal Health Coverage.

Clause 1 of the Bill sets out the short title of the proposed Act.

Clause 2 of the Bill proposes to amend the long title of the Act in order to include the establishment of the National Health Scheme in the long title of the Act.

Clause 3 of the Bill proposes to amend section 2 of the Act by inserting definitions of new terms and phrases and deleting terms that have become obsolete or no longer appear in the body of the Act.

Clause 4 of the Bill proposes to amend section 5 of the Act to define the role of the Minister in the setting of the criteria for the empanelment and contracting of health care providers for the purposes of this Act and the Board's mandate in facilitating attainment of Universal Health Coverage including communication and stakeholder engagement.

Clauses 5 and 6 of the Bill propose to amend sections 9 and 10 of the Act to provide for the manner of determining the benefits payable to the members of the Board and define the qualifications for appointment as the Chief Executive Officer of the Board.

Clause 7 of the Bill proposes to insert a new section 10A in the Act to provide for the appointment of the Corporation Secretary to comply with the "Mwongozo"-Code of Conduct for State Corporations.

Clause 8 of the Bill proposes to amend section 11 of the Act by removing superfluous words from the section.

Clause 9 of the Bill defines the role of the Corporation Secretary in the handling of the Board's Common Seal.

Clause 10 of the Bill proposes to amend section 15 of the Act to provide for the liability of employers to make a matching contribution to the Fund equal to that which the employee is liable and make it mandatory for Kenyan residents to contribute to the Fund.

Clause 11 of the Bill proposes to insert a new section 15A to make it mandatory for any person who has attained the age of eighteen years and is not a beneficiary to register as a member of the Fund.

Clause 12 of the Bill proposes to amend section 16 of the Act to provide for the liability of employers to pay a matching contribution under section 15 and not deduct such contributions from the salary or other remuneration of the employee.

Clause 13 of the Bill proposes to amend section 18 of the Act to prescribe a penalty for late payment of standard and matching contributions.

Clause 14 of the Bill proposes to amend section 19 of the Act to harmonise penalties in all classes of enterprises.

Clause 15 of the Bill proposes to repeal section 20 of the Act to remove the voluntarily contribution provision since contributions towards the Fund shall be mandatory.

Clause 16 of the Bill proposes to amend section 21 of the Act to eliminate the outdated identification through cards and mandates the Board to prescribe means by which a beneficiary of the Fund may be identified.

Clause 17 of the Bill proposes to amend section 22 of the Act to mandate the Board to pay from the Fund, a benefit to an empanelled and contracted health care provider for an expense incurred by the provider, for the provision of health care services to the number of beneficiaries determined by the Board and to provide for an element of first charge where a beneficiary has a private health insurance cover.

Clause 18 of the Bill proposes to amend section 23 of the Act by deleting obsolete provisions relating to cards and receipts and provide for statement of account for contributors.

Clause 19 of the Bill proposes to repeal section 24 of the Act which provides for stamps that would no longer be used as evidence of contribution.


Clause 20 of the Bill proposes to amend the Act in section 25 to enhance the penalty for those found culpable for the commission of an offence under the Act.

Clause 21 of the Bill proposes to amend section 26 of the Act to remove the reference to stamps as stamps would no longer be used as evidence of contribution.

Clause 22 of the Bill proposes to amend section 30 of the Act to mandate the Board, in consultation with the relevant accreditation bodies, to publish the list of empanelled health care providers for purposes of the Act.

Clause 23 of the Bill proposes to amend section 32 of the Act to provide for inspection of empanelled and contracted health care providers and to enhance the penalty for those found culpable for the commission of an offence under the Act.

Clause 24 of the Bill proposes to amend section 34 of the Act to mandate the Board to invest in the procurement and acquisition of essential medical equipment and supportive infrastructure to empanelled and contracted healthcare providers.



Clause 25 of the Bill proposes to repeal section 41 of the Act as the mandate to prosecute is vested in the Director of Public Prosecutions.

Clause 26 of the Bill proposes to amend section 43 of the Act to make reference to the Work Injury Benefits Act, 2007.

Clause 27 of the Bill proposes to amend section 45 of the Act to enhance the penalty for those found culpable for the commission of an offence under the Act.

Clause 28 proposes to amend the Second Schedule to the Act to change the quorum for meetings from the current nine members to two thirds of its number.

#### **PART III**

# 3.0 PUBLIC PARTICIPATION AND STAKEHOLDER ENGAGEMENT ON THE BILL

- 7. Following placement of advertisements in the print media of 10<sup>th</sup> June, 2021 seeking views on the Bill from members of the public and relevant stakeholders pursuant to Article 118(1)(b) of the Constitution of Kenya and Standing Order 127(3).
- 8. The Committee received memoranda from ten (10) stakeholders namely; The Ministry of Health, the National Hospital Insurance Fund, the Kenya Medical Practitioners Pharmacists and Dentists Union, Dr. Kahura Mundia, the National Gender and Equality Commission, the Central Organization of Trade Unions (COTU), Federation of Kenya Employers, British-American Insurance Company Limited (BRITAM), the Kenya Association of Private Hospitals, and the Kenya Union of Nutritionists and Dietitians.
- 9. The public participation exercise was held virtually on 30<sup>th</sup> June, 2021.

# 3.1 THE MINISTRY OF HEALTH AND THE NATIONAL HOSPITAL INSURANCE FUND

The Ministry of Health and the National Hospital Insurance Fund submitted as follows-

- 10. The Government of Kenya adopted Universal Health Coverage (UHC) as one of the Big Four priority agenda, with an aspiration that by 2022, all citizens will have access to quality healthcare services that they need without getting into financial difficulties.
- 11. For the Government to realise and sustain UHC, there is need for the development and implementation of adequate policy, legal and institutional frameworks, including the transformation and repositioning of the National Hospital Insurance Fund (NHIF) as the key driver and strategic purchaser of healthcare services for Kenyan residents. Among the key recommendations proposed to reposition NHIF as a key driver for UHC in Kenya is the amendment of the NHIF Act.
- 12. The Bill proposes one of the concepts that is practised globally where the private health insurance is the primary payer while the social health insurer becomes the second payer. This will allow the social insurer to cater for the cost of treatment more comprehensively for the vulnerable populations in the society with a limited ability to purchase insurance or even health services.
- 13. The Bill also proposes that employers match the employees' contribution, and those on the voluntary scheme will retain their current monthly contributions of Kshs. 500 (annual contribution of Kshs. 6,000).

- 14. This will be made mandatory, and all households with the ability to pay must contribute to the kitty. However, for those unable to pay, the National and County Government will step in and pay. Approximately, 20% of the 5.1 million poor and vulnerable households have been identified across all the 47 Counties.
- 15. To cater for its members' holistic wellness, the Bill proposes that NHIF be transformed into a National Health Scheme, meaning the focus will be placed on primary care, preventive, promotive and palliative care.
- 16. Finally, to reduce the turnaround time in service delivery and deter fraudulent activities, the Bill proposes complete digitisation of the NHIF processes.
- 3.2 KENYA MEDICAL PRACTITIONERS, PHARMACISTS AND DENTISTS UNION & DR. KAHURA MUNDIA, DEPUTY NATIONAL CHAIRPERSON, KMPDU
- 17. Kenya Medical Practitioners Pharmacists and Dentists Union & Dr. Kahura Mundia, Deputy National Chairperson, KMPDU proposed amendment to the Bill as follows-

18. Clause 3 of the Bill be amended in Section 2 on interpretation and definitions of 'empanelment', 'contracting' and 'healthcare provider'.

## Justification

Change clause and provide for all registered healthcare providers to provide services under the act as per the scope of practice provided by a professional regulatory authority.

- 19. Clause 4 of the Bill be amended in subsection 4(b)- by changing the clause and provide for all registered healthcare providers to provide services under the act as per the scope of practice provided by a professional regulatory authority.
- 20. The clause be further amended by adding new paragraph (g)- to separate the Board functions.

## Justification

- i. To guard against corruption.
- ii. Criteria for registration and licencing are already established under professional regulatory authorities.

## **CLAUSE 5**

21. Clause 5 of the Bill be amended in Section 9- Benefits of Board members to be paid under consolidated Fund.

### Justification

To minimise over-exploitation of funds resources in the form of Board and administration expenses.

## **CLAUSE 9**

22. Clause 9 of the Bill be amended by introducing term limit.

### Justification

To have a term limit for the Corporation Secretary serving the Fund in the observance of sound principles of governance.

23. Clause 10 of the Bill be amended to provide for regulation of the self-employed persons in Section 15- (Contribution to the Fund)

### Justification

To ensure Universal Health Care service provision, all persons who are citizens of Kenya need to qualify for a basic essential care package through the NHIF.

#### **CLAUSE 13**

24. Clause 13(b) and 13(c) of the Bill be amended as follows-

13(b)- increment is unjust and punitive.

### Justification

The amendment in the Bill provides a standard penalty of twenty-five per cent of the contribution.

25. 13(c)- Maintain penalty for the government as well where it doesn't pay up its standard and matching contribution for unemployed, indigents and vulnerable persons.

## **CLAUSE 15**

26. Clause 15 of the Bill be amended to provide directions for the self-employed instead of doing a repeal of the section.

## **CLAUSE 16**

27. Clause 16 of the Bill be amended to indicate that the only proof of contribution in Section 21(1) should be a payment record and NHIF fund payment statement and not payslips.

- 28. Clause 17 of the Bill be amended as follows
  - i. The Board should provide benefits within established regulatory frameworks.
  - ii. NHIF Fund should take first priority in covering the basic essential care package, and thereafter, persons with private insurance can use their covers.

## Justification

To ensure NHIF doesn't employ monopolistic healthcare financings such as abuse of buyer power and enforcement of restrictive trade practices.

## **CLAUSE 22**


29. Clause 22 of the Bill be amended to provide for requirements for empanelling and follow the guidelines of registration and licensing given by professional regulatory bodies.

## **CLAUSE 24**

30. Clause 24 of the Bill be amended to create a specialist scholarship fund.

## Justification

- (i) Delete the whole section as it serves to create a loophole for over-exploitation and abuse of NHIF funds
- (ii) Funds can be used to train specialists and healthcare providers through the establishment of the scholarship fund



## 3.3 FEDERATION OF KENYA EMPLOYERS

31. The Federation of Kenya Employers proposed amendments to the Bill as follows-

## **CLAUSE 10**

- 32. Clause 10 of the Bill be amended as follows
  - 10(a)- employers should not be compelled to match the employees' contribution.
  - 10(c)- contributions to the Fund be made by all persons in formal employment.
  - 10(e)- contribution to the Fund should be voluntary.

## Justification

- i. It will affect the wage bill and destroy the capacity of enterprises to create new jobs
- ii. All persons aged 18 years and above to mandatorily contribute is not feasible.

## **CLAUSE 17**

33. Clause 17(e) of the Bill be amended to maintain the current practice in the health insurance industry.

## Justification

- i. It is the government's responsibility to cater for primary health services.
- ii. It will increase the cost of private medical insurance.

## **CLAUSE 20**

34. Clause 20 of the Bill be amended to adopt technology to reduce non-compliance.

### **Justification**

The penalties are inclined toward punishing employers rather than ensuring compliance.

## 3.4 BRITAM HOLDING PLC

35. British-American Insurance Company Limited (BRITAM) Holding PLC proposed amendments to various sections of the Bill as follows-

### **CLAUSE 10**

36. Clause 10 of the Bill be amended in subsection 10(a) - by introducing an "opt out" option for the matching contribution specifically for employers who are able to sponsor their employees for a private medical cover.

#### Justification

To avoid a negative impact on the insurance industry through reduced premiums.

#### **CLAUSE 17**

37. Clause 17 of the Bill be amended in Subsection 17(e) - NHIF should cater for primary care since it is a statutory mandatory cover.

## Justification

To avoid low uptake of private medical insurance.

## 3.5 KENYA ASSOCIATION OF PRIVATE HOSPITALS

38. The Kenya Association of Private Hospitals proposed amendments to the Bill as follows-

### **CLAUSE 17**

- 39. They noted as follows in Clause 17 of the Bill
  - i. Clause 17(a)- gives the Board unfettered discretion on the limits of beneficiaries which may be abused by the Board.
  - ii. Clause 17(e)- discriminatory on the value of equity.

## **Justification**

The amendment is prejudicial and unjust to the private health insurance

40. Clause 20(e) of the Bill be amended to indicate the process of removal from the register of health care providers

## Justification

Article 50 of the Constitution advocates for the right to a fair hearing.

## **CLAUSE 27**

41. Clause 27 of the Bill be amended by reducing the penalty which is unjust and highly punitive

## Justification


It may be abused by the Fund.

# 3.6 CENTRAL ORGANISATION OF TRADE UNIONS, (KENYA)

- 42. The COTU (K) proposed that the Government withdraws the Bill in its entirety. The Union noted that the Amendments as proposed aim to disband the current formation and structure of the NHIF.
- 43. The Union further noted that NHIF had been tapped to drive the Universal Health Coverage (UHC) agenda; however, as currently constituted, the Fund would not be able to manage the funds being proposed.
- 44. The Union proposed that Universal Health Coverage (UHC) be executed through a body managed and constituted outside the current management structure of the NHIF, with a Board that is directly answerable to the National Treasury.

# 3.7 NATIONAL GENDER AND EQUALITY COMMISSION

- 45. The Commission noted that the Bill amendments are insufficient to implement a National Health Scheme effectively. If implemented through the proposed amendments, the new law may fail to meet its intended objectives.
- 46. The Commission recommended that the Government withdraws the Bill and instead initiate repeal of the NHIF Act through consultation with stakeholders followed by tabling of a comprehensive, robust new NHIF Act.



# **PART IV**

# 4.0 COMMITTEE RECOMMENDATION

47. After considering the National Hospital Insurance Fund (Amendment) Bill, National Assembly Bill No. 21 of 2021, the Committee recommends that the House approves the Bill with amendments as proposed in the schedule.

#### **PART V**

#### 5.0 SCHEDULE OF PROPOSED AMENDMENTS

48. The Committees proposed the following amendments to be considered by the House in the Committee stage:

#### **CLAUSE 4**

49. **THAT**, clause 4 of the Bill be amended in paragraph (b) by deleting the word "Minister" appearing in the proposed new paragraph (c) and substituting therefor the words "Cabinet Secretary".

#### Justification

The amendment seeks to ensure the use of the term "Cabinet Secretary" as provided in the Constitution.

### **CLAUSE 5**

After lengthy deliberations, the Committees proposed amendments to the National Hospital Insurance Fund (Amendment) Bill, 2021, National Assembly Bill No. 21 of 2021 as follows:

#### **CLAUSE 4**

**THAT**, clause 4 of the Bill be amended in paragraph (b) by deleting the word "Minister" appearing in the proposed new paragraph (c) and substituting therefor the words "Cabinet Secretary".

#### Justification

The amendment seeks to ensure the use of the term "Cabinet Secretary" as provided in the Constitution.

#### **CLAUSE 5**

THAT, clause 5 of the Bill be amended by deleting the words "relevant government agencies" and substituting therefor the words "Salaries and Remuneration Commission".

#### Justification

The amendment seeks to ensure the express reference to the Salaries and Remuneration Commission as the body constitutionally mandated to advise the national and county governments on the remuneration and benefits of all other public officers.

#### CLAUSE 6

**THAT**, clause 6 of the Bill be amended by inserting the following new subsection immediately after the proposed new subsection (4)—

"(5) The Chief Executive Officer shall be an ex officio member of the Board."

#### Justification

The amendment seeks to expressly provide that the Chief Executive Officer shall be an ex officio member of the Board, which is necessary for the effective implementation of the decisions of the Board by the Chief Executive Officer.

#### **CLAUSE 10**

THAT, clause 10 of the Bill be amended-

- (a) in paragraph (a), by deleting the proposed new subsection (1A); and
- (b) in paragraph (b), by deleting the proposed new paragraph (c).

The amendment seeks to remove the mandatory requirement of obligating employers' compulsory contributions to the NHIF in respect of each of their employees.

The obligation on employers to make matching contributions to the NHIF will affect the wage bill and destroy the capacity of enterprises to create new jobs, as well as lead to the decline by employers in offering private health insurance for their employees.

#### **CLAUSE 12**

THAT, clause 12 of the Bill be amended-

- (a) by deleting paragraph (a);
- (b) by deleting paragraph (b);
- (c) in paragraph (c), by deleting sub-paragraph (i); and
- (d) in paragraph (f), by deleting sub-paragraph (i).

#### Justification

The amendment seeks to remove the provisions relating to the requirement of employers to make matching contributions to the NHIF in respect to all their employees.

# **CLAUSE 13**

THAT, clause 13 of the Bill be amended-

- (a) by deleting paragraph (a);
- (b) in paragraph (b), by deleting the words "or matching" wherever they appear in the proposed new subsection (1); and
- (c) by deleting paragraph (d).

#### Justification

The amendment seeks to remove the provisions relating to the requirement of employers to make matching contributions to the NHIF in respect to all their employees.

#### **CLAUSE 14**

THAT, the Bill be amended by deleting clause 14 and inserting the following new clause-

Amendment of 14. Section 19 of the principal Act is amended—section 19 of

(a) in subsection (2), by deleting the words "five times"

and substituting therefor the words "ten per cent of"; and

(b) by deleting subsection (3).

#### Justification

The amendment seeks to reduce the penalty for non-remittance of special contributions by self-employed persons, from five times to ten per cent of the amount of contribution due. This is necessary so as to ensure a realistic payment of penalty, as the non-remittance by the contributor may be occasioned by a lack of funds occasioned by lack of income.

The amendment further seeks to eliminate the double penalty for non-remittance as contained in subsection (3).

#### **CLAUSE 15**

THAT, the Bill be amended by deleting clause 15 and inserting the following new clause-

Amendment of 15. Section 20 of the principal Act is amended by inserting the section 20 of words "by the youth" immediately after the words "voluntary No. 9 of 1998. contributions".

#### Justification

The amendment seeks to allow for a provision of voluntary contributions to be made by the youth, so as to ensure that any youth who may not have a stable source of income but wishes to make contributions to the Fund is allowed to do so.

#### **CLAUSE 16**

THAT, clause 16 of the Bill be amended—

- (a) in the proposed new subsection (2), by deleting the words "or matching";
- (b) in the proposed new subsection (3), by deleting the words "or matching" appearing in paragraph (a).

#### Justification

The amendment seeks to remove the provisions relating to the requirement of employers to make matching contributions to the NHIF in respect to all their employees.

#### **CLAUSE 20**

THAT, clause 20 of the Bill be amended-

(a) in paragraph (a), by deleting the word "ten" and substituting therefore the word "one"; and

The amendment seeks to reduce the penalty for the offences of making false statements or impersonation to one million shillings, so as to ensure that there is a difference in the penalty prescribed for individuals and health facilities.

#### **CLAUSE 21**

**THAT,** clause 21 of the Bill be amended in paragraph (b) by deleting the words "under this Act".

#### Justification

The amendment is necessary to retain the words "under this Act", so as to ensure that the contributions referred to in the section are only the contributions made under the Act.

#### **CLAUSE 23**

THAT, clause 23 of the Bill be amended-

- (a) in paragraph (b), by deleting the words "and matching" appearing in sub-paragraph (i); and
- (b) by deleting paragraph (c) and inserting the following new paragraph-

"(c) in subsection (3) by deleting the words "ten thousand shillings" and substituting therefor the words "one million shillings or to imprisonment for a term not exceeding twenty four months" appearing in the closing statement."

#### Justification

The amendment seeks to remove the provisions relating to the requirement of employers to make matching contributions to the NHIF in respect to all their employees.

The amendment further seeks to correct a grammatical error caused by the amendment as contained in the Bill.

### **CLAUSE 24**

THAT, the Bill be amended by deleting clause 24 and inserting the following new clause-

Amendment of 15. Section 34 of the principal Act is amended in subsection (1) section 34 of by deleting paragraph (b).

The amendment seeks to ensure that the funds under the NHIF shall only be used for purposes for which the Fund is established, which is to offer benefits and payments to the contributors in respect of medical expenses incurred in healthcare institutions.

#### **CLAUSE 28**

**THAT**, clause 28 of the Bill be amended by deleting the words "two-thirds of the" and substituting therefor the word "five".

### Justification

The amendment seeks to ensure that the quorum for a meeting of the Board shall be five members, since the Board shall be composed of nine members.

The Ministry of Health and the National Hospital Insurance Fund presented as follows on the National Hospital Insurance Fund (Amendment) Bill, National Assembly Bill No. 21 of 2021:

The Government of Kenya adopted Universal Health Coverage (UHC) as one of the Big Four priority agenda, with an aspiration that by 2022, all citizens will have access to quality healthcare services that they need without getting into financial difficulties.

For the Government to realise and sustain UHC there is need for the development and implementation of adequate policy, legal and institutional frameworks, include the transformation and repositioning of the National Hospital Insurance Fund (NHIF) as the

key driver and strategic purchaser of healthcare services for Kenyan residents. Among the key recommendations proposed to reposition NHIF as a key driver for UHC in Kenya is the amendment of the NHIF Act.

The Bill proposes one of the concepts that is practised the world over where the private health insurance is the primary payer while the social health insurer becomes the second payer. This will allow the social insurer to cater for the cost of treatment more comprehensively for the vulnerable populations in the society with a limited ability to purchase insurance or even health services.

The Bill also proposes that employers match the employees' contribution, and those on the voluntary scheme will retain their current monthly contributions of Kshs. 500 (annual contribution of Kshs. 6,000).

This will be made mandatory, and all households with the ability to pay must contribute to the kitty. However, for those unable to pay, the National and County Government will step in to pay. Approximately 20% of the 5.1 million poor and vulnerable households have been identified across all 47 Counties.

To cater to its member's holistic wellness, the Bill proposes that NHIF be transformed into a National Health Scheme, meaning the focus will be placed on primary care, preventive, promotive and palliative care.

Finally, to reduce the turnaround time in service delivery, deter fraudulent activities, the Bill has allowed for the complete digitisation of the NHIF processes.
