RE: SUBMISSION OF NOMINEES THE NATIONAL CONSTITUENCIES DEVELOPMENT **FUND** COMMITTEES FOR NATIONAL ASSEMBLY APPROVAL

Further to our letter ref. no. NG-CDFB/CEO/KNA/VOL V (20) dated December 01, 2020 that re-forwarded the fifteenth batch of three (3) Constituencies as well as one (1) re-submitted Constituency we wish to present two (2) Constituencies based on the following premise as outlined below.

Section 43 subsections (1.) and (2.) of the National Government Constituencies Development Fund (NG-CDF) Act 2015 as amended in 2016 states that:

"(1) there is established a National Government Constituency Development Fund Committee for every constituency.

(2) Each Constituency Committee shall comprise—

- (a.) The national government official responsible for coordination of national government functions:
- Two men each nominated in accordance with subsection (3), one of whom shall be a youth at the date of appointment;
- (c.) Two women nominated in accordance with subsection (3), one of whom shall be a youth at the date of appointment;
- one person with disability nominated by a registered group representing persons with disabilities in the constituency in accordance
- (e.) two persons nominated by the constituency office established under

Regulations made pursuant to the Parliamentary Service Act"; Further, Subsections (3), (4) and (10) provide that: -

- "(3.) the seven persons referred to in subsection (2) (b), (c), (d) and (e) shall be selected in such manner and shall have such qualifications as the Board may, by regulations, prescribe.
- (4.) The names of the persons selected under subsection (3) shall be submitted by the Board to the National Assembly for approval before appointment and gazettement by the Board
- (10.) Whenever a vacancy occurs in the Constituency Committee by reason of resignation, incapacitation or demise of a member the vacancy shall be filled from the same category of persons where the vacancy has occurred within a period of thirty davs"

Pursuant to the above, two constituencies have filled vacancies that occurred in the current membership of their committees by re-convening Selection Panels in accordance with Regulation 5 of the Regulations to the NGCDF Act.

In accordance to Sections 43(4) and 43(8) of the NG-CDF Act of 2015 & Regulation 5(10), which provide for National Assembly approval of the nominees for re-appointment or fresh appointment to the National Government Constituencies Development Fund Committees, prior to gazettement by the National Government Constituencies Development Fund Board, as afore stated, we hereby forward the following names for approval by the National Assembly as appear hereunder:-
