# 8. STATEMENTS

# a) Pursuant to Standing Order 47(1)

The Senator for Vihiga County (Sen. George Khaniri, MP) made a statement on an issue of general topical concern, namely, frequent road accidents at the Kaburengu junction area, along the Eldoret-Turbo-Kaburengu-Webuye highway.

Thereupon, the Senator registered his condolences to the families, relatives and friends of the six accident victims that occurred on Saturday 21<sup>st</sup> August, 2021. He stated that losing a family is very painful; but losing 5 members of a family at the same time can be excruciating, noting that he attended the burial of the four victims in Ebwali Village, Luanda Sub County in Vihiga and the sense of loss and pain was palpable.

The Senator stated that the matter of Kaburengu junction stretch on the Eldoret-Turbo-Kaburengu- Webuye highway, and accidents was a matter of great concern as there has been four major accidents since 2017, and two of the accidents have claimed the lives of Vihiga residents. In his contribution, the Senator stated that from the accidents that had occurred at the spot, the stretch of the road was not just a blackspot but a death trap to road users.

In conclusion, the Senator requested that the Standing Committee on Roads and Transportation conduct a proper interrogation of the stretch of the road and recommend corrective measures.
