6. COMMUNICATION ON THE ANNUAL REPORT BY THE NATIONAL TREASURY
ON PUBLIC DEBT MANAGEMENT FOR FINANCIAL YEAR 2020/2021 AND
THE 2021 BUDGET REVIEW AND OUTLOOK PAPER FOR THE FINANCIAL
YEAR 2022/2023 AND THE MEDIUM TERM BUDGET

The Speaker conveyed the following Communication from the Chair:-

"Honourable Senators,

Vide a letter referenced DMD 4/128, dated 30th September, 2021, the National Treasury submitted to the Senate, the Annual Report on Public Debt Management for Financial Year 2020/2021, and the 2021 Budget Review and Outlook Paper for the Financial Year 2022/2023 and the Medium Term Budget.

Section 200 (1) and (2) of the Public Finance Management Regulations, 2015 provides that-

- (1) Not later than three months after the end of each financial year, the Cabinet Secretary shall prepare and submit an annual report to Parliament on public debt in the format set by the Cabinet Secretary.
- (2) The annual public debt report under paragraph (1) shall include the following information—
 - (a) Review of previous year's financing of budget deficit;
 - (b) composition of External debt;
 - (c) publicly guaranteed debt;
 - (d) on-lent loans and contingent liabilities;
 - (e) debt strategy and debt sustainability;
 - (f) outlook for the medium term; and

- (g) any commitment fees and penalties paid on any undisbursed amounts of a loan."
- Section 26 (3) of the Public Finance Management Act 2012 provides that;
 - (3) Not later than seven days after the Budget Review and Outlook Paper has been approved by Cabinet, the National Treasury shall—
 - (a) submit the Paper to the Budget Committee of the National Assembly to be laid before each House of Parliament; and
 - (b) publish and publicise the Paper not later than fifteen days after laying the Paper before Parliament."

Honourable Senators,

These reports are consequently committed to the Standing Committee on Finance and Budget which may scrutinize the contents and make observations and recommendations thereon by way of a Report to the Senate.

8. STATEMENTS

i) Pursuant to Standing Order 47 (1)

(i) Nominated Senator (Sen. (Arch.) Sylvia Kasanga, MP) made a statement on the commemoration of the World Mental Health Day, 2021.

Thereupon, the Senator informed the Senate that the World Mental Health Day is commemorated on 10th October every year. She informed the House that the day was first celebrated in 1992 at the initiative of the World Federation for Mental Health to create awareness on mental health.

The Senator stated that Kenya was ranked sixth among African countries with the highest number of depression cases by a 2017 World Health Organization report. The report further stated that one in four people in Kenya is likely to suffer from a mental illness. Information from the Kenya Mental Health Policy (2015-2030) indicated that mental disorder cases had risen exponentially in Kenya such that 20-25% of outpatients seeking primary healthcare present symptoms of one mental illness or another.

The Senator observed that as the country commemorates the World Mental Health Day, it was important to note that owing to the COVID-19 pandemic situation, there has been an increase in mental health illnesses due to stress and anxiety associated with the impact of the pandemic on job losses, failed careers, dwindling income and marital disputes.

Sen. Kasanga appreciated the effort the Government was making in curbing this rising trend of mental illness and informed the House that on Wednesday 9th June, 2021, the Ministry of Health launched the Kenya Mental Health Action Plan (2021-2025), that will provide a framework for both National and County Governments and stakeholders to implement the Mental Health Policy through strategic objectives with specified priority targets and indicators.

In conclusion, the Senator appreciated the support Senators gave when contributing to the Mental Health (Amendment) Bill (Senate Bills No. 28 of 2020) which was passed by the Senate and referred to the National Assembly. She called upon the Ministry of Health and the county governments to expand mental health funding and human resource as this area of health was underfunded resulting in difficulties in implementation of programs geared towards improvement of mental health services.

(ii) Nominated Senator (Sen. (Dr.) Gertrude Musuruve Inimah, MP) made a statement concerning commemoration of the World Teachers' Day.

Thereupon, the Senator informed the Senate that on 5th of October every year, the world celebrates the International Teachers' Day. The day was set aside to commemorate the anniversary of the adoption of the 1966 ILO/UNESCO recommendations concerning the status of teachers. Further, the day sets international benchmarks regarding the rights and responsibilities of teachers and standards for their initial preparation, recruitment, and employment, further education, teaching and learning conditions.

The Senator noted that, the World Teachers' Day provides an opportunity to celebrate the teaching profession worldwide, take stock of achievements and draw attention to the voices of teachers, who are at the heart of efforts to achieve the global education target of *leaving no one behind*. She also noted that, the day highlights the critical role played by teachers in achieving inclusive and quality education for all.

She informed the House that as the world continues to celebrate the World Teachers' Day, the role played by teachers in imparting knowledge could not be gainsaid especially during the prevailing COVID-19 global pandemic. She lauded the commitment and efforts of Kenyan teachers to continue their work during the pandemic. She called upon the National government to invest more in the teaching profession by allocating more funds towards teacher training, capacity building and promotion of teachers.

In conclusion, the Senator decried disparities in the payment made to Early Childhood Development (ECD) teachers, noting that the amounts were too low and not enough to enable teachers meet their daily needs. She called upon the county governments to review and harmonize the remuneration structure for ECD teachers.
