2.0 CORRUPTION IN TENDERING AND RECRUITMENT

In contravention of the constitution personal staff have been recruited without proof of academic and professional qualifications as is required by the jurisprudence guiding Kisii County Public Service Board and Kisii county assembly service board.
- 2.3: THAT there is failure to involve the members of the County Economic Budget Forum in decision making, and ensure due and proper participation, in breach of Article 10 of the Constitution of Kenya and \$137 of the Public Finance Management Act 2012.

 - ii) That there has allegedly been irregular recruitment processes whereby personal staff have been recruited without proof of academic and professional qualifications as required by the jurisprudence guiding the Kisii County Public Service Board and the Kisii County Assembly Service Board;
 - iii) That, the county government has allegedly failed to deliver civic education and conduct public participation on public policy matters in the County;
 - iv) That, the Kisii County Government has allegedly obstructed access to information pursuant to Article 35 of the Constitution of Kenya; and
 - v) That, there has allegedly been failure to involve the members of the County Economic Budget Forum in decision making as required, pursuant to Section 137 of the Public Finance Management Act, 2012;

The Petitioner therefore prays that the Senate investigates the issues raised in the Petition and make appropriate recommendations thereon.
