PETITION BY THE RESIDENTS OF BUXTON ESTATE ON THE
EVICTION AND DEMOLITION OF THE BUXTON ESTATE.

To,
The Speaker of the Senate
Parliament Buildings ,
NAIROBI

1. The humble Petition of the Residents of Buxton Estate, Mvita Constituency of Mombasa County who state as follows;
2. That your Petitioners were Residents of Buxton Estate owned by the County Government of Mombasa until on Friday 5th March 2021 ,when they were forcibly Evicted from the said Houses by the County Government Inspectorate personnel.
3. That sometimes in 2016 or thereabouts, the County Government of Mombasa came up with a Vision 2035 Project which sought to re-develop all the County Housing Estates and replace them with modern dwellings.
4. That Buxton Estate was one of the Estates , and the Residents went to Court to challenge the Project on the grounds among others that there was no Public Participation done before Approval of the Project and that the

proposed Resettlement Plan did not comply with the Law and International Conventions of Eviction of People.

5. That the Land an Environment Court ordered the Developer then to provide a proper Resettlement program that would comply with the Laws and International Conventions .
6. That the Project did not take off and the Developer did not implement the Court Ruling.
7. That sometimes in 2020, a new Developer came upon an Award of the fresh Tender to redevelop the Estate. The Developer then did a Public Participation forum but the issues raised therein by the Residents were not properly addressed.
8. That the Residents again went to Court and sought Injunctive Orders to stop the project until our issues are addressed.
9. That on 4th March 2021 the Land and Environment Court dismissed our Injunction application . On 5th March 2021 the County Inspectorate moved in very early in the morning and started the demolition, initially of the Kiosks and other structures. Later on they proceeded to remove the doors and windows from the Houses in a brazen attempt to evict us from the Houses.
10. That some of the Residents had not collected their compensation cheques and neither had they signed the Resettlement agreement to enable a smooth handover of possession.
11. That our rights as Citizens were grossly violated as the Evictions were one without any Notice to us and without any regard to human dignity and property.

12. That we seek the intervention of the Senate as our Rights under the Constitution, the Relevant Laws and the United Nations Conventions have been grossly violated.
13. That apart from the Human Rights issues, there is also the whole issue of how the Bidding for the Tender was conducted and there might have been further violations of the Public Procurement and Disposal Act .
14. That the Contract between the County Government of Mombasa and the Developer has been shrouded in mystery and the Residents efforts to see the Contract and seek information from the County Government of Mombasa have been fruitless.
15. That to date, we as the Residents do not know what the County Government of Mombasa is getting from the deal in return for the Land and the developments which are now being demolished.
16. That in the circumstances we pray that the Senate do investigate these issues with a view to address our grievances.
