EXECUTIVE SUMMARY

Pursuant to Section 50 of the National Government Constituencies Development Fund (NG-CDF) Act of 2015, the Committee is mandated to oversee the policy framework and legislative matters that may arise in relation to the Fund and continually review the framework set out for the efficient delivery of development programs financed through the fund and to consider and report to the National Assembly, with recommendations, names of persons required to be approved by the National Assembly under this Act. Kiambaa Constituency has filled vacancies that occurred in the current membership of their Committees by re-convening selection panels in accordance with regulations 5 of the regulations to the NG-CDF Act.

In accordance to section 43(4) and 43(8) of the NG-CDF Act of 2015 and regulations 5(10), which provide for National Assembly approval of the nominees for re-appointment or fresh appointment To the National Government Constituencies Development Fund Committees, prior to gazettement by the National Government Constituencies Development Fund Board forwarded names for approval by the National Assembly.

The Committee is grateful to the offices of the Speaker and Clerk of the National Assembly for the logistical and technical support accorded to it during its sittings. Finally, I wish to express my appreciation to the Honorable members of the Committee and the Committee secretariat who made useful contributions towards the preparations and production of this report.

Section 43 (1) and (2) of the National Government constituencies Development Fund (NG-CDF) Act, 2015 as amended in 2016 states that:

- "(1) there is established a National Government constituencies Development Fund Committee for every Constituency.
- (2) Each constituency Committee shall comprise-
 - (a) The national government official responsible for coordination of national government functions:
 - (b) Two men each nominated in accordance with subsection (3) one of whom shall be youth at the date of appointment;
 - (c) Two women nominated in accordance with subsection (3) one of whom shall be a youth at the date of appointment.
 - (d) One person with disability nominated by a registered group representing persons with disability in the constituency in accordance
 - (e) Two person nominated by the constituency office established under regulations made pursuant to parliamentary Act":

Further, Subsection (3), (4) and (10) provide that:

- "(3) The seven person referred to in section (2) (b), (c), (d) and (e) shall be selected in such manner and shall have such qualifications as the Board may, by regulations, prescribe.
- (4) The names of the persons selected under subsection (3) shall be submitted by the Board to the National Assembly for approval before appointment and gazettement by the Board.
- (10) Whenever a vacancy occurs in the Constituency Committee by reason of resignation, incapacitation or demise of a member the vacancy shall be filled from the same category of persons where the vacancy has occurred within a period of thirty days"


