I. SENATE AMENDMENTS TO THE PUBLIC PRIVATE PARTNERSHIPS BILL (NATIONAL ASSEMBLY BILL NO. 6 OF 2021)

CLAUSE 6

Senate Amendment

THAT, clause 6 of the Bill be amended by deleting paragraph (c) and substituting therefor the following new paragraph-

(c) the Principal Secretary in the State department responsible for matters relating to infrastructure.

CLAUSE 33

Senate Amendment

THAT, clause 33 of the Bill be amended in subclause (3) by inserting the words "within twenty-one days of receipt of the evaluation report" immediately after the words "the Committee shall".

CLAUSE 75

Senate Amendment

THAT, clause 75 of the Bill be amended-

- (a) in subclause (2)-
 - (i) by deleting the word "five" appearing immediately before the words "other persons with" in paragraph (bb) and substituting therefor the word "four"; and
 - (ii) by deleting the word "one person" appearing immediately before the words "not being a member" in paragraph (cc) and substituting therefor the words "two persons".
- (b) by inserting the following new subclause immediately after subclause (6)-
 - (6A) A person aggrieved by the decision of the Committee may, within seven days of the decision, make an application for review to the Committee in the prescribed form.

NEW CLAUSES

Senate Amendments

THAT, the Bill be amended by inserting the following new clauses immediately after clause 75-

Secretary.

- **75A.** (1) The Cabinet Secretary shall designate a public officer to serve as the Secretary to the Committee.
- (2) A person designated under subsection (1) shall be an Advocate of the High Court of Kenya of at least seven years standing.

Remuneration.

75B. The members of the Committee shall be paid such salaries and allowances as the Cabinet Secretary shall, in consultation with the Salaries and Remuneration Committee, determine.

Conflict of interest.

75C. A member of the Committee who has a direct or indirect interest in a matter before the Committee shall declare the interest and shall not participate in any proceedings of the Committee on the matter.

Offences.

75D. (1) A person shall not—

- (a) without reasonable cause or lawful excuse, obstruct or hinder, assault or threaten a member of the Committee acting under this Act;
- (b) without justification, fail to provide information required by the Committee under this Act;
- (c) without justification, fail to provide information within reasonable time that is required by the Committee under this Act;
- (d) submit false or misleading information to the Committee;
- (e) misrepresent to or knowingly mislead a member of the Committee acting under this Act; or
- (f) interfere with or exert undue influence on any member of the Committee.
- (2) A person who contravenes subsection (1) commits an offence and is liable, on conviction, to a fine not exceeding five hundred thousand shillings or to imprisonment for a term not exceeding one year, or to both.

Decree.

75E. The Committee shall issue a decree setting out its decision in a particular matter and the decree shall be enforceable in the same manner as a decree of the Court.

Notice is given that the Chairperson of the Departmental Committee on Finance and National Planning intends to move the following amendment to the Perpetuities and Accumulations (Amendment) Bill, 2021 at the Committee Stage—

CLAUSE 3

THAT clause 3 of the Bill be amended in the proposed new section 19 by deleting the proposed subsection (2) and substituting therefor the following subsections-

- (2) Subject to special and general power of maintenance and advancement or as predicted by the terms of the trust or as otherwise provided, income which is not accumulated shall be distributed.
- (3) At all times any income that is not accumulated shall be distributed to the intended beneficiaries.

LIMITATION OF DEBATE

The House resolved on Wednesday, February 10, 2021 as follows-

Limitation of Debate on Senate amendments to a National Assembly Bill

Order 146 (Consideration of Senate amendments to Bills originating in the National Assembly) shall be limited as follows:- a maximum of one hour and thirty minutes, with not more than fifteen minutes (15) for the Mover in moving, fifteen minutes (15) for the Chairperson of the relevant Departmental Committee, and five (5) minutes for any other Member speaking, including the Leader of the Majority Party and the Leader of the Minority Party (if the Bill is not party-sponsored), and THAT five (5) minutes before the expiry of the time, the Mover shall be called upon to reply; and further THAT priority in speaking shall be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in THAT order.

Limitation of Debate on Bills sponsored by Parties or Committees

IV. THAT, each speech in a debate on Bills sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party shall be limited as follows:- A maximum of forty five (45) minutes for the Mover, in moving and fifteen minutes (15) in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee), and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each (if the Bill is not sponsored by either of them); and **THAT** priority in speaking shall be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in **THAT** order.

<u>Limitation of Debate on Reports of Audit Committees</u>

V. THAT, each speech in debate on Reports of Audit Committees (PIC, PAC & SFAC) shall be limited as follows:- A maximum of sixty (60) minutes for the Mover in moving and thirty (30) minutes in replying, and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each; and THAT priority be accorded to the Leader of the Majority Party and the Leader of the Minority Party, in THAT order.

Limitation of Debate on Motions

VI. THAT, each speech in a debate on any Motion, including a Special motion shall be limited in the following manner:- A maximum of three hours with not more than twenty (20) minutes for the Mover and ten (10) minutes for each other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each, and THAT ten (10) minutes before the expiry of the time, the Mover shall be called upon to reply; and THAT priority in speaking shall be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in THAT order.
