6. **STATEMENTS**

a) Pursuant to Standing Order 47 (1)

Nominated Senator (Sen. Abshiro Halake, MP) made a statement concerning preparation for the 2022 General Elections.

The Senator informed the Senate that in July, 2021, the Government, through the Ministry of Foreign Affairs, issued a *Note Verbale* to all diplomatic missions, international organizations and other foreign entities interested in supporting Kenya's preparations for the 2022 General Elections, which directed them to wait for the expression of such need from the Government. The Government further required all the said organizations that were engaged

in any programs or activities related to the General Elections to inform the Ministry of Foreign Affairs of such support in order to formalize such arrangements.

The Senator emphasized the role of non-state actors such as civil society organizations in provision of civic education and information to citizens in marginalized communities and alleged that the directive by the Government ws a dangerous direction that may stifle preparations towards the General Elections as it affected many players in the management and support for free and fair electoral process. The Senator argued that the directive by the Government was an affront to the democratic gains that Kenya had made over the years and could only be interpreted as an attempt to claw back such gains.

The Senator concluded by calling upon the Government to reverse the directive and noted that this would build the confidence of the population and the global community in the country's political and electoral process leading to the 2022 General Elections.
