The bidder must provide the specification for scanner. PSC will procure it separately. Bidders to provide technical specifications for scanners

5.	General	The servers and storage value can be determined if we know the quantity of the documents PSC is going to store. Without that it becomes very difficult to give a quote for the same.  Query:  The response mentioned in above requires more clarification:	PSC requires the bidders to provide the cost for 6 TB of storage space per month to be used by 2000 users of PSC for integrated Communication System (e-Mail and e-File/office system) for a period of 2 years for cloud hosting.  In an event of additional storage space requirement by PSC, PSC shall procure the additional storage space from the cloud service provider.
6.	General	How many applications you have to integration with Zimbra Collaboration	We have not mentioned any specific application in the RFP such as Zimbra. Bidders are requested to propose for any collaboration tool/ solution as long as it meets PSC requirements i.e. open source or equivalent.
