## 5. STATEMENT PURSUANT TO STANDING ORDER 47 (1)

The Senator for Nandi County (Sen. Samson Cherarkey, MP.) made a statement concerning the high cost of food and farm inputs in Kenya.

The Senator noted that according to data availed from the Kenya National Bureau of Statistics (KNBS) food prices rose by 8.89% in January, thereby making it hard for millions of Kenyans to meet their daily food needs. The Senator highlighted a number of household items such as wheat flour, maize flour, electricity and fuel, which had risen, exacerbating the problem of food for families.

The Senator drew the attention of the Senate to the high cost of farm inputs such as fertilizer, which retails at Kshs. 6,000 from Kshs. 2,500. This situation has made it difficult for farmers to afford fertilizer for planting, and as a result, threatens the country's food security agenda.

In this regard, the Senator called upon the National Executive to institute modalities that would enable the prices of the basic commodities to come

down and cushion Kenyans from the high cost of living. He highlighted a number of proposals made such as provision of an additional Kshs. 2 billion which would be used for drought mitigation and a further Kshs. 5 billion for fertilizer subsidy program to address the cost of fertilizers in the country.

He concluded by calling the National Assembly to ensure that above measures were captured in the proposed budget for FY 2022/2023.
