#### CHAIRPERSON'S FOREWORD

This report contains the Committee's proceedings on the consideration of the Military Veterans Bill (National Assembly Bill No. 4 of 2022) that was read a First Time on Tuesday, 22<sup>nd</sup> February, 2022, and committed to the Departmental Committee on Defence & Foreign Relations pursuant to Standing Order 127.

The Military Veterans Bill, 2022 sponsored by Hon. Amos Kimunya, MP, Leader of the Majority Party, is a Government-sponsored Bill that seeks to establish a regulatory and institutional framework for the management of military veterans' affairs; for the provision of benefits to military veterans and military veterans' dependants; to establish the Dependants' Education Fund; to establish the Defence Forces Retirement Home.

The Committee called for memoranda from the public pursuant to Article 118(1)(b) of the Constitution and Standing Order 127(3), and received responses from four stakeholders. The Committee further held a meeting with the chief practitioner and consumer of the Bill, the Ministry of Defence, on 1<sup>st</sup> April, 2022.

The stakeholders proposed certain amendments that have been exhaustively addressed in Part III of this report, with the Committee's final decision reflected therein and in the attached schedule.

On behalf of the Departmental Committee on Defence and Foreign Relations and pursuant to provisions of Standing Order 199 (6), it is my pleasant privilege and honour to present to this House the Report of the Departmental Committee on Defence and Foreign Relations on the Military Veterans Bill, 2022. The Committee is grateful to the offices of the Speaker and Clerk of the National Assembly for the logistical and technical support accorded to it during its sittings. The Committee further wishes to thank all stakeholders who submitted their comments on the Bill. Finally, I wish to express my appreciation to the Honourable Members of the Committee and the Committee Secretariat who made useful contributions towards the preparation and production of this report.

It is my pleasure to report that the Committee has considered the Military Veterans Bill, 2022 and has the honour to report back to the National Assembly with the recommendation that the Bill should be approved with amendments.

#### PART I

#### 1.0 PREFACE

#### 1.1 Establishment and Mandate of the Committee

- 1. The Departmental Committee on Defence and Foreign Relations is established under Standing Order No. 216. Its mandate pursuant to SO 216 (5) with the following terms of reference;
  - i) investigate, inquire into and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned Ministries and Departments;
  - ii) study the programme and policy objectives of the Ministries and Departments and the effectiveness of the implementation;
  - iii) study and review all legislation after First Reading subject to the exemptions under Standing Order 101 A (4);
  - iv) study and review all legislation referred to it;
  - v) study, assess and analyze the relative success of the Ministries and Departments as measured by the results obtained as compared with its stated objectives;
  - vi) investigate and inquire into all matters relating to the assigned Ministries and Departments as they may deem necessary, and as may be referred to them by the House or a Minister; and
  - vii) make reports and recommendations to the House as often as possible, including recommendations of proposed legislation.
- 2. The Committee is mandated to consider the following subjects:
  - i) Defence
  - ii) intelligence,
  - iii) foreign relations
  - iv) diplomatic and consular services,
  - v) international boundaries,
  - vi) international relations,
  - vii) agreements,
  - viii) treaties and
  - ix) Conventions.
- 3. In executing its mandate, the Committee oversees the following government Ministries, departments and or agencies, namely:
  - i) Ministry of Defence
  - ii) Ministry of Foreign Affairs
  - iii) Ministry of East African Community & Regional Development
  - iv) The National Intelligence Service

#### **PART II**

## 2.0 OVERVIEW OF THE MILITARY VETERANS BILL, 2022

- 6. The Military Veterans Bill (National Assembly Bills No. 4 of 2022), seeks to establish a regulatory and institutional framework for the management of military veterans' affairs; for the provision of benefits to military veterans and military veterans' dependants; to establish the Dependants' Education Fund; to establish the Defence Forces Retirement Home.
- 7. It is to be noted that the Kenya Defence Forces Act (No. 25 of 2012) provides for the functions, organization and administration of the Kenya Defence Forces pursuant to Articles 232 and 239(6) of the Constitution; gives effect to Article 241 and other relevant Articles of the Constitution, provides for disciplinary matters, among other things. However, it does not address what the Bill seeks to achieve.
- 8. The Bill contains 23 clauses.

## B. OVERVIEW OF THE BILL

- 9. The Bill contains six Parts. These are:
  - Part 1- Preliminary
  - Part 2- Military Veterans' Benefits
  - Part 3- Administration
  - Part 4- Dependants' Education Fund
  - Part 5- Defence Forces Retirement Home
  - Part 6- Regulations
- 10. Clause 1 of the Bill contains the short title.
- 11. Clause 2 of the Bill contains definitions of key terms used in the Bill.
- 12. Clause 3 of the Bill provides for the principal objects of the Act including the management of military veterans' affairs; the provision of benefits to military veterans and military veterans' dependants; the establishment of the Dependants' Education Fund; and the establishment of the Defence Forces Retirement Home.
- 13. Clause 4 of the Bill provides for the guiding principles of the Act including principles relating to military veterans; policies relating to military veterans and principles for the management of funds relating to military veterans.
- 14. Clause 5 of the Bill provides that the benefits conferred under the Act shall not be conferred on a person merely because that person is a military veteran as defined under the Act.
- 15. Clause 6 of the Bill provides for the meaning of "military veteran", that is, a person who has retired from military service and who had served in the Kenya Defence Forces, the Kenya Armed Forces after 1963, or in the Kings African Rifles before 1963; has completed service in the Armed Forces or Kenya Defence Forces, receives a military pension and who was not dishonourably discharged from military service.
- 16. Clause 6 also provides that a person who was discharged or retired from the Armed Forces or Kenya Defence Forces on medical grounds shall, whether or not that person receives a pension, be regarded as a military veteran except if the person suffers from a physical or mental disability that was self-inflicted or occasioned by the use of narcotic drugs or psychotropic substances.

- 17. Clause 7 of the Bill provides for the benefits conferred under the Act to military veterans and military veterans' dependants; the role of the Defence Council in the provision of those benefits; the obligations of Government ministries, the departments and agencies; and the role of the Principal Secretary in the ministry responsible for military veterans.
- 18. Under clause 7, the benefits that may be conferred on a military veteran are:
  - Counselling and treatment for post-traumatic stress or related conditions
  - Physical rehabilitation for any condition arising out of military service
  - Honouring and memorializing fallen military veterans
  - Education, training and skills development
  - Facilitation or advice on employment placement
  - Facilitation or advice on business opportunities.
- 19. Under clause 7, the following benefits may be conferred on a military veterans' dependants:
  - Counselling and treatment for post-traumatic stress or related conditions
  - Facilitation or assistance in education placement for children of military veterans
  - Facilitation or advice on employment placement
  - Facilitation or advice on business opportunities
- 20. Clause 8 of the Bill provides for the powers of the Defence Council under the Act. It provides that the Defence Council shall have the following powers:
  - Develop a policy on military veterans
  - Consider proposals by the Cabinet Secretary, the Chief of Defence Forces or the Director regarding the policy on military veterans, funding and budgeting in connection with military veterans' affairs
  - Commission research or studies on any issue affecting military veterans
  - Promote the implementation of programmes relating to military veterans' affairs under the Act
  - Take such steps as may be necessary for the achievement of the objects of the Act
- 21. Clause 9 of the Bill establishes the office of the Director of Military Veterans and places it under the supervision of the Chief of Defence Forces. It also provides for the revocation of the appointment of the Director or the Director's redeployment by the Defence Council.
- 22. Clause 10 of the Bill provides for the functions of the Director.
- 23. Clause 11 of the Bill provides for the establishment of the Advisory Committee on Military Veterans, its membership and the appointment of its members. It provides that the Advisory Committee shall comprise:
  - A chairperson appointed by the President on the recommendation of the Defence Council
  - Six other members appointed by the Defence Council
- 24. Clause 12 of the Bill provides for the qualifications of the members of the Advisory Committee. It provides that a person shall be qualified to be appointed as the chairperson or member of the Advisory Committee if that person—
  - In the case of the chairperson, is a retired general officer of the Armed Forces or Kenya Defence Forces
  - In the case of a member appointed under subsection 11(2) (b, is a military veteran

- Meets the requirements of Chapter Six of the Constitution
- Has not acted in a manner that is prejudicial to national security since the end of his or her military service
- 25. Clause 13 of the Bill provides for the procedure for the filing of vacancies in the Advisory Committee.
- 26. Clause 14 of the Bill provides for the tenure of the members of the Advisory Committee.
- 27. Clause 15 of the Bill provides for the determination of the remuneration and allowances of the members of the Advisory Committee.
- 28. Clause 16 of the Bill provides for the procedure for the removal from office of a member of the Advisory Committee.
- 29. Clause 17 of the Bill provides for the manner in which a vacancy may arise in the Advisory Committee including notice periods in case a member wishes to resign from office.
- 30. Clause 18 of the Bill provides for the functions of the Advisory Committee.
- 31. Clause 19 of the Bill provides for the reports of the Advisory Committee to the Defence Council.
- 32. Clause 20 of the Bill provides for the procedure for the convening of the meetings of the Advisory Committee and the obligation to declare conflicts of interest regarding any matter being considered by the Advisory Committee.
- 33. Clause 21 of the Bill provides for the establishment of the Dependants' Education Fund to provide scholarships for the children of members of the Kenya Defence Forces, military veterans or deceased service members or deceased veterans. It provides that the Defence Council shall establish a fund to be known as the Dependants' Education Fund. It further provides that the Defence Council shall prescribe regulations for the administration of the Fund including the procedure for processing applications for scholarships from the Fund.
- 34. Clause 22 of the Bill provides for the establishment of the Kenya Defence Forces Retirement Home to provide residential and other services to military veterans. It further provides that the Defence Council shall prescribe Regulations for the achievement of the objects of the section and provide for—
  - persons who shall be eligible to reside in the Defence Forces Retirement Home
  - the services to be provided in the Defence Forces Retirement Home
  - contributions to be made by members of the Kenya Defence Forces with respect to the Defence Forces Retirement Home
  - any other relevant matter relating to the Defence Forces Retirement Home
- 35. Clause 23 of the Bill provides for the making of Regulations by the Cabinet Secretary for the better carrying out of the provisions of the Act. The regulations will provide for:
  - The manner of accessing any benefit provided under the Act
  - Any matter required or permitted to be prescribed by or in accordance with the Act

#### **B. PUBLIC PARTICIPATION**

- 36. The Committee is required, pursuant to Article 118(1)(b) of the Constitution and Standing Order 127(3), to facilitate public participation on the Bill through an appropriate mechanism including-
  - (a) Inviting submission of memoranda;
  - (b) Holding public hearings;
  - (c) Consulting relevant stakeholders in the sector;
  - (d) Consulting experts on technical subjects.
- 37. The requirement for the Committee to conduct public participation on the Bill is a constitutional imperative flowing from Article 118 of the Constitution which provides that Parliament shall-
  - (a) conduct its business in an open manner, and its sittings and those of its committees shall be open to the public; and
  - (b) facilitate public participation and involvement in the legislative and other business of Parliament and its committees.
- 38. It is important to note that Standing Order 127(4) requires the Chairperson of the Departmental Committee to which a Bill is committed or a Member designated for that purpose by the Committee to present the Committee's report to the House to inform debate within twenty-one calendar days of such committal and upon such presentation, or if the Committee's report is not presented when it becomes due, the Bill shall be ordered to be read a Second Time on such day as the House Business Committee shall, in consultation with the Member or the Committee in charge of the Bill, appoint.

#### **PART III**

#### 4.0 PUBLIC PARTICIPATION/ STAKEHOLDER ENGAGEMENT

- 39. Following call for memoranda from the public through the placement of advertisements in the print media on 24<sup>th</sup> February, 2022 requesting for comments from the public on the Bill.
- 40. The Committee received memoranda from the following stakeholders;
  - i. Ministry of Defence
  - ii. National Gender and Equality Commission
  - iii. Mr. Ernest Kinyua Kamau through Lawyer, Miller & Co. Advocates
  - iv. Ugunya/Ugunja Veteran Development Group
  - v. Creative Industrial Arts Technologists Association of Kenya
- 41. The stakeholders made submissions as elaborated in the clauses below, with the Committee observations thereunder;
  - a) Creative Industrial Arts Technologists Association
- 42. The Creative Industrial Arts Technologists Association proposed for the initiation of technology and business development initiatives to form the specified field of technology acquired from retired members of the security forces.
- 43. The Committee observed that this is proposal that can be considered once the structures are instituted as it falls with the mandate of the Advisory Committee.
  - b) Miller and Company advocates instructed by Capt (Rtd) Ernest Kinyua Kamau (20813)
- 44. The Firm proposed the following:
- THAT Section 11(d) and Section 9(e) of the proposed Bill are discriminative as they require one to have completed service to be eligible for the benefits under the Bill.
- 45. The Committee observed that this is in line with the guiding principles of honouring those who served and made sacrifices to protect the country. Completing service or at least attaining the 10 and 12 years in service for officers and service members respectively distinguishes those entitled to the benefit from those who quit service prematurely.
  - c) National Gender and Equality Commission
- 46. The Commission proposed the following:
  - (a) to define a military veteran as a person who served in the army, air force or navy and has not been dishonourably discharged. The Committee observed that the definition contained in the bill is all encompassing as the armed forces and the Kenya defence Forces is comprised of the three services:
  - (b) Composition to include representation as stipulated in the Mwongozo to include the parent ministry, department of social protection, faith-based organizations, an elderly veteran and a veteran with disabilities. The Committee observed the following on the above proposals
    - i) the faith element is likely to invite controversy;
    - ii) representation among ranks is the established practice which should be maintained; and
    - iii) the Department of Veteran Affairs is established under the Defence Council and is not a state corporation.
  - (c) Delete establishment of Veteran's Education fund as it does not meet the thresholds stipulated in the PFMA Act. The Committee observed the following—

- i) To operationalize the fund, the Act has enabled the Defence Council to make regulations to attain its objects; and
- ii) MDAs are to co-operate with Veterans affairs to realize attainment of the benefit which includes National Treasury promulgating regulations under the PFMA.
- (d) Define a retirement home, consider establishing more than one centre for the retirees to access and include the provision on the source of funds. The Committee observed that this can be considered once the structures are duly established.
- 47. Following deliberations with the Ministry of Defence and taking into consideration memoranda from the various stakeholders, the Committee proposed the following amendments to the Bill with justifications in the following manner—

#### **PART IV**

#### COMMITTEE'S PROPOSED AMENDMENTS

#### 48. LONG TITLE

THAT, the long title to the Bill be amended by deleting the words "to establish the Defence Forces Retirement Home"

#### **49. CLAUSE 2**

#### THAT, Clause 2 of the Bill be amended—

(a) by deleting the definition of the term "child" and substituting therefor the following new definition—

"Child" means a child of a Kenya Military Veteran under the age of eighteen years;"

(b) by inserting the following new definition in its proper alphabetical sequence—

"private entity" means any person or private group, organization, proprietorship, partnership, trust, cooperative, association, corporation, or other commercial or non-profit entity duly established and/or registered under applicable laws in Kenya or in other jurisdictions that accept to co-operate and voluntarily fund any object and/or activity envisaged under this Act including an officer, employee, or agent thereof.

#### 50. CLAUSE 3

THAT, Clause 3 of the Bill be amended by deleting paragraph (d).

#### 51. CLAUSE 6

THAT, Clause 6 of the Bill be amended by—

- (a) deleting paragraph (a);
- (b) deleting paragraph (b); and
- (c) deleting paragraph (c).

#### 52. CLAUSE 21

THAT, Clause 21 of the Bill be amended in sub clause (1) —

- (a) in paragraph (a), by deleting the words "members of the Kenya Defence Forces and";
- (b) in paragraph (b), by deleting the words "deceased members of the Kenya Defence Forces

or"

#### 53. CLAUSE 22

THAT, the Bill be amended by deleting Clause 22.







#### 1. LONG TITLE

THAT, the long title to the Bill be amended by deleting the words "to establish the Defence Forces Retirement Home"

#### 2. CLAUSE 2

Hon. Peter Odoyo the Chief Administrative Secretary at the Ministry of Defence informed the Committee that the objective of the Bill was to promote the welfare of retired military personnel by enabling them transition from military to citizens. He welcomed the Lt Gen. (Rtd) Humphrey Njoroge who provided a background of the necessity of the Bill by making the following submission regarding the Military Veterans Bill, 2022;-

- i) Highly trained retirees who can still contribute to achievement of National Security Strategy objectives that entails a balanced orchestration of the military, diplomatic and economic instruments of power are relegated to activities such as farming yet they are still capable of being absorbed into both the private and public sectors to offer their expertise;
- ii) Passing of the bill will be a game changer that will provide the legal and institutional framework to structure utilization of highly skilled veterans in transforming Kenya's economy;
- iii) It's important that such personnel with relevant skills to be reabsorbed and considered for government openings to utilize the acquired skills once they retire;
- iv) That the Bill would be important towards addressing the welfare of retired military personnel:
- v) The pension currently paid to retired Generals who retired during president Moi's time was quite low i.e. the retired Gen. Musumba is paid a monthly pension of Kshs. 7,000;
- vi) That the pension of retirees needs to be reviewed since private soldiers who are retiring currently are receiving a monthly pension of over Kshs. 30,000.
- vii) The guiding principle of the Bill is honoring the sacrifices made by military veterans during military service and their role in defense of the Republic of Kenya.
- The Bill will accord special benefits to military veterans that suffer physical or viii) mental disability from their service to the Country;
- ix) Further the Bill will provide a smooth and seamless transition from military service to civilian life by restoring the capability of those with disabilities to the greatest extent possible thereby improving their quality of life.
- x) The Bill does not entitle a person defined as a military veteran under the Bill or that person's dependant to any benefit conferred under the Bill or any other written law merely on the ground of such definition.

#### **Members Observations**

- i) Definition of "Child" in the Bill deviates from the definition in the Children Act.
- ii) A private entity needs to be defined in the Bill.
- iii) Military veterans with specialized skills can be absorbed in the private sector once they retire. The Committee noted that Kenya is a developing Country with limited employment opportunities in the private sector with the option of also engaging them on non-monetary and part time basis;
- iv) The Committee observed that retirement homes can create dependency hence discouraging personal investments by the Military personnel, Further, the Committee noted that the practice was considered alienating and depressing as well as inconsistent with the social culture of family and community;
- v) Modalities of establishing an education fund was not clear and whether the fund is to be financed by tax payers;
- vi) The Committee noted that the Bill should be structured in a manner that it is not depicted as a money bill and accordingly restructured so that it highlights the organization and the internal affairs of veterans;
- vii) The committee noted that a strong justification be provided to differentiate the nature of duty in the defense forces from other agencies such as the police.

#### Committee Recommendations

- i) Reconcile definition of "Child" with the Children's Act. *Justification*: The bill should be amended to align to the definition in the Children's Act; "child" means a child of a Kenya Military Veteran under the age of 18 years.
- ii) Use of the term 'private entity' in clause 7 (3) needs to be defined in the interpretations section to avoid ambiguities. *Justification*: The Proposed definition to be considered for adoption means any person or private group, organization, proprietorship, partnership, trust, cooperative, association, corporation, or other commercial or non-profit entity duly established and/or registered under applicable laws in Kenya or in other jurisdictions that accept to co-operate and voluntarily fund any object and/or activity envisages under this Act including an officer, employee, or agent thereof.
- iii) The reference to Government Ministries, Departments and Agencies involved with military veterans shall co-operate with the Ministry responsible for veterans' matter needs to be redrafted *Justification*: so that the bill does not appear to legislating on existing laws that confer powers and functions to other entities. The Clauses should therefore be redrafted.
- iv) Clause 21 (1) (a) on the Education fund appears to suggest fees will be paid for serving personnel's children, *Justification*: It was agreed that the clause be redrafted to cater for only veterans' children;
- v) In regards to excluding entitlement to benefits for self-inflicted physical and mental disability, *Justification*: It was resolved that the provision be maintained to cater for mischief of personnel who self-inflict injuries as a result of indiscipline or to avoid being deployed or assigned duty. Further, for cases where drug and substance abuse is occasioned by defiance despite interventions.
- vi) Retirement homes should be through contributions by serving military personnel and other staff welfare schemes. They should not overburden the tax payers.
- vii) A private entity should be clearly defined in the bill.

# MIN. NO.NA/DDC.DFR/2022/058: BRIEFING BY LEGAL COUNSEL ON THE MILITARY VETERANS BILL, 2022

The Committee was taken through the Military Veterans Bill, 2022 as follows: -

 The Bill seeks to establish a regulatory and institutional framework for the management of military veterans' affairs; for the provision of benefits to military veterans and military veterans' dependants; to establish the Dependants' Education Fund; to establish the Defence Forces Retirement Home;

ii) It is to be noted that the Kenya Defence Forces Act (No. 25 of 2012) provides for the functions, organization and administration of the Kenya Defence Forces pursuant to Articles 232 and 239(6) of the Constitution; gives effect to Article 241 and other relevant Articles of the Constitution, provides for disciplinary matters, among other things. However, it does not address what the Bill seeks to achieve;

iii) Clause 1 of the Bill contains the short title;

iv) Clause 2 of the Bill contains definitions of key terms used in the Bill;

v) Clause 3 of the Bill provides for the principal objects of the Act including the management of military veterans' affairs; the provision of benefits to military veterans and military veterans' dependants; the establishment of the Dependants' Education Fund; and the establishment of the Defence Forces Retirement Home;

vi) Clause 4 of the Bill provides for the guiding principles of the Act including principles relating to military veterans; policies relating to military veterans and principles for the

management of funds relating to military veterans;

vii) Clause 5 of the Bill provides that the benefits conferred under the Act shall not be conferred on a person merely because that person is a military veteran as defined under the Act;

viii) Clause 6 of the Bill provides for the meaning of "military veteran", that is, a person who has retired from military service and who had served in the Kenya Defence Forces, the Kenya Armed Forces after 1963, or in the Kings African Rifles before 1963; has completed service in the Armed Forces or Kenya Defence Forces, receives a military pension and who was not dishonorably discharged from military service;

ix) Clause 6 also provides that a person who was discharged or retired from the Armed Forces or Kenya Defence Forces on medical grounds shall, whether or not that person receives a pension, be regarded as a military veteran except if the person suffers from a physical or mental disability that was self-inflicted or occasioned by the use of

narcotic drugs or psychotropic substances;

x) Clause 7 of the Bill provides for the benefits conferred under the Act to military veterans and military veterans' dependants; the role of the Defence Council in the provision of those benefits; the obligations of Government ministries, the departments and agencies; and the role of the Principal Secretary in the ministry responsible for military veterans;

xi) Under clause 7, the benefits that may be conferred on a military veteran are Counseling and treatment for post-traumatic stress or related conditions, Physical rehabilitation for any condition arising out of military service, Honoring and memorializing fallen military veterans, Education, training and skills development,

Facilitation or advice on employment placement and Facilitation or advice on business

opportunities;

xii) Under clause 7, the following benefits may be conferred on a military veterans' dependants: Counseling and treatment for post-traumatic stress or related conditions, Facilitation or assistance in education placement for children of military veterans, Facilitation or advice on employment placement and Facilitation or advice on business opportunities;

xiii) Clause 8 of the Bill provides for the powers of the Defence Council under the Act;

xiv) Clause 9 of the Bill establishes the office of the Director of Military Veterans and places it under the supervision of the Chief of Defence Forces;

xv) Clause 10 of the Bill provides for the functions of the Director;

xvi) Clause 11 of the Bill provides for the establishment of the Advisory Committee on Military Veterans, its membership and the appointment of its members;

xvii) Clause 12 of the Bill provides for the qualifications of the members of the Advisory

Committee;

xviii) Clause 13 of the Bill provides for the procedure for the filing of vacancies in the Advisory Committee;

xix) Clause 14 of the Bill provides for the tenure of the members of the Advisory Committee;

xx) Clause 15 of the Bill provides for the determination of the remuneration and allowances of the members of the Advisory Committee;

xxi) Clause 16 of the Bill provides for the procedure for the removal from office of a

member of the Advisory Committee;

Clause 17 of the Bill provides for the manner in which a vacancy may arise in xxii) the Advisory Committee including notice periods in case a member wishes to resign from office;

Clause 18 of the Bill provides for the functions of the Advisory Committee; xxiii)

Clause 19 of the Bill provides for the reports of the Advisory Committee to the xxiv) Defence Council;

xxv) Clause 20 of the Bill provides for the procedure for the convening of the meetings of the Advisory Committee and the obligation to declare conflicts of interest regarding

any matter being considered by the Advisory Committee;

Clause 21 of the Bill provides for the establishment of the Dependants' xxvi) Education Fund to provide scholarships for the children of members of the Kenya Defence Forces, military veterans or deceased service members or deceased veterans;

Clause 22 of the Bill provides for the establishment of the Kenya Defence xxvii) Forces Retirement Home to provide residential and other services to military veterans;

Clause 23 of the Bill provides for the making of Regulations by the Cabinet Secretary for the better carrying out of the provisions of the Act.

#### Committee Resolution

The meeting noted that the bill was bulky and required adequate time for its perusal, article by article. The committee resolved to undertake a retreat with the Ministries of Defence and East African Community & Regional Development in Mombasa County from 31st to 4th March, 2022, to consider the Military Veterans Bill, 2022 and the Regional Development Authorities Bill, 2021. During the said retreat the Committee will also meet with the Ministry of Foreign Affairs on the Asset Acquisition and Maintenance Policy and the operationalization of the Foreign Service Act.

- 1. The meeting was informed that the Ministry of Defence had invited seven members of the Committee to attend the pass out graduation for Cadets at the Kenya Military Academy, Nakuru on Thursday, 31<sup>st</sup> March, 2022. Members were requested to confirm attendance with the secretariat.
- 2. The secretariat reported that they had received letters from both the Director of Criminal Investigations (DCI) and the Inspector General of National Police Service (NPS) apprising the Committee on the steps taken to ensure justice for Ms. Agnes Wanjiru, allegedly murdered by the British soldier(s) based in Nanyuki. The letter indicated as follows;
  - i) That the homicide detectives have concluded investigations in Kenya and the remaining bit was both Kenya and the United Kingdom teams to get information from the witnesses in the United Kingdom for harmonization of the revised Mutual Legal Assistance guidelines (MLA);
  - ii) The DCI team investigating the matter has been in contact with the Royal Military Police of the United Kingdom of Great Britain informally to establish the all Mutual Legal Assistance issues are well addressed and properly identified;
  - iii) The United Kingdom Authorities have already identified the residential mapping of all the possible witnesses and the suspect in the United Kingdom for logistical and operation purposes;
  - iv) The Mutual Legal Assistance has already been forwarded to the Hon. Attorney General for onward transmission to the United Kingdom, Central Authority and waiting for their consent for the DCI team to travel to the United Kingdom to finalize the investigation and commence extradition process of the suspects.



Our client has perused the said bill and the same is a noble idea. He however wants to bring your attention to page 75, Part 11 6 (1) (d) and (e) which states:

A Kenyan Citizen shall be regarded as a military veteran for the purposes of this Act if that Kenyan Citizen: -

- d) Has completed service in the Armed Forces or Kenya Defense Forces;
- e) Receives a pension from the Armed Forces or Kenya Defense Forces;

Our client is of the humble view that Sections (d) and (e) are discriminatory in as far as they imply that you must serve to the end of your service or have reached retirement age with a pension in order to qualify as a veteran.

#### Section 6 (2) states:

Despite Subsection (1) a person who has discharged or retired from the Armed Forces or Kenya Defense Forces on medical grounds shall, whether or not that person receives a pension, be regarded as a military veteran.

Section 6 (2) above seems to imply that the only way one can be a veteran is either through medical discharge, and if not that then Part II Section 6 (1) (d), (e) and (f) then apply.

The problem with this is that it discriminates against those who retire or terminate and are not on pension, and were not dishonourably discharged.

Serving military officers do also retire or terminate on compassionate grounds or voluntarily and this seems to have been omitted from the draft bill herein.

Page 75, Section 6 Part 11 (1) (d) and (e) need to be deleted.

**VETERANS BILL, 2022** (NATIONAL ASSEMBLY BILL NO 4 OF 2022)

Reference is made to your call for the submission of memoranda on the Military Veterans Bill, 2022.





The Government can use the already acquired Technology skills from the retired veterans of the Defense Forces for national industrialization process.

Many military personnel serve as team leaders where they have analyzed situations and options, made appropriate decisions, given directions, followed through with a viable plan, and accepted responsibility for the outcome.
- **3.Ability to Get Along with and Work with All Types of People:** The veterans attracts all types of Technologists regardless of race, gender, economic status, age, religion, attitude, intelligence, or physical conditions. In the Service, military personnel have worked for and with people of all types of backgrounds, attitudes and characteristics. This experience has prepared veterans and their families to work with all types of people on a continuing basis.
- **4.Ability to Work Under Pressure and to Meet Deadlines:** One definite characteristic of the military service is that service members must perform. They must do their job, do it right the first time and do it in a timely manner. They are continuously setting priorities, meeting schedules and accomplishing their missions. Pressure and stress are built into this, but service members are taught how to deal with all these factors in a positive and effective manner. They enjoy working together
- **5.Ability to Give and Follow Directions:** People in the military know how to work under supervision and can relate and respond favorably to

others. They understand accountability for their actions and for their subordinates' actions. They also understand and use discipline in their lives and when dealing with others. They have learned to respect and accept legitimate authority.

- **6. Drug Free:** With an honorable discharge, service members are certified drug free and are able to create a drug free nation by creating Creative Industrial Arts Exhibition Demonstration Centers in every county. Kenyans will view this as a distinct advantage.
- 7. Systematic Planning and Organization: Most military operations require thorough planning and workload management. Carefully considered objectives, strengths and limitations of other people, resources, time schedules, supplies, logistics, and various other factors are always considered. Organization, evaluation and adjustment are continuously being assessed. The ability to participate, direct or establish systematic planning is highly valued in business.
- **8. Change Environment:** Military has ability to change any environment to be conducive for habitation. They can wasteland land into creative recreational parks.
- **9. Emphasis on Safety:** Military safety training is among the best in the world. Service members understand the considerable cost in lives, property and objectives when safety is ignored. Both the control and the emphasis on safety are valued in the civilian work force.
- **10.Familiarity** with Records and Personnel Administration: Service members are familiar with the necessity of keeping accurate records and completing all paperwork. There is always the requirement for accountability. Service members are also familiar with all facets of personnel administration.
- 11. Ability to Conform to Rules and Structure: In any large organization, and especially the military, there must be rules and structure to avoid chaos and internal breakdown. Individuals in the service have learned and followed rules every day in their working environment. While in this environment, they have also learned loyalty to their units and their leaders. Companies always value employees who will be "company players" and team members that follow "the rules" of the organization.
- 12. Flexibility and Adaptability: All individuals in the service have learned to be flexible and adaptable to meet the constantly changing


needs of any situation and mission. Last minute changes are not uncommon in any military or civilian working environment. Also based on their military background, former soldiers are able to adapt quickly to physical and safety demands.

- 13. **Self-Direction:** Many service members understand difficult and often complex issues and solve these issues or problems on the spot without step-by-step guidance from above.
- 14. Educated: All military soldiers have at least a K.S.C.E. and the majority of them have high school diplomas. Many have attended college to further their education.
- 15. **Initiative:** Many military personnel have the ability to originate a plan of action or task to answer and solve many unusual problems regarding supplies, logistics, resources and transportation.
- 16. Work Habits: People in the military stay and finish their projects and are known and are recognized for completing their missions in a timely fashion and in an effective, efficient manner. These work habits are a definite result of social maturity, integrity, determination and self-confidence that they have learned, earned and experienced in their military service. Their military background has instilled pride, enthusiasm and perseverance for their work. This constitutes their eligibility and recognition for promotion.
- 17. Standards of Quality and Commitment to Excellence: Service personnel are continually striving to attain and surpass their standards of quality for themselves and their units. These standards of quality are meeting their unit's mission, training standards, physical requirements and educational goals. There is a commitment to excellence in all of these fields.
- 18. Global Outlook: Many people in the military have been stationed and served their country in various locations around the world. This residency and international experience have broadened their outlooks in regards to customs, economies, languages and cultures of other countries.
- 19. Client and Service-Oriented: Many military personnel are in the service industry. Their jobs are to facilitate, explain and expedite their patrons and clients needs, wants and actions, such as administrative, medical, dental, postal, financial and recreational.

- 20. Concerned About the Community and Family Environment: Service personnel have a vested interest in their areas where they reside. Many are committed to making their locations a better place to live. They are dedicated to the quality of life for their family members and their fellow residents. They participate and volunteer in youth sports, scouting activities, family and unit outings, area clean-up days, seasonal and unit parties and gatherings, and developmental programs. They are able to make Industrial Arts Exhibition Demonstration and Recreational Centers within our 47 counties
- 21. Specialized Advanced Training: All service personnel receive advanced training in their fields. Their career fields designate a specialized focus and skill building for their individual jobs. Advanced training and cross-referenced training can be in the computerized, financial, medical, engineering, administrative, personnel, technical, mechanical, and security fields. This training can be completed in the classroom, in the office, on the location, in the laboratory, or on the job.
- **22. Charging and discharging skills:** Many young people admire military on performing art drills parade. The military are well charged with creativity skills and are able to discharge these skills to the apprentices throughout the country as they enjoy their retirement years.

### **CREATIVE THNKING**



### PUBLIC PARTICIPATION (SUBMISSION OF MEMORANDA)

Article 118(1)(b) of the Constitution provides that, "Parliament shall facilitate public participation and involvement in the legislative and save housenesses of participant and its Committees, National Assembly Standing Order (S.O.) 127(3) provides that "the Departmental Committee to which a Bill is committeed shall facilitate public participation and take into account the views and recommendations of the public when the Committee makes its report to the House".

The Persons With Disabilities Bill (National Assembly Bill No. 61 of 2021), sponsored by the Leader of the Majority Party, was read a First Time on Tuesday, 22° February 2022 and thereafter committed to the Departmental Committee on Labour and Social Violates for consideration and reporting to the House. The Bill seeks to give effect to Article 54 of the Constitution to restricture the National Council for Persons with Disabilities and to provide for its functions and provers to provide for the Institutional framework for protecting, promoting and monitoring the rights of persons with disabilities, and for connected purposes.

The Military Veterans Bill (Matlonal Assembly Bill No. 4 of 2022), sponsored by the Leader of the Majority Party was read a First Tense on Tuesday, 22° february 2027 and thereafter committed to the Departmental Committee on Defence and Foreign fieldstons for consideration and reporting to the House. The Hill seeks to establish a regulatory and institutional framework for the transpersent of military veterans' effairs, for the provisions of benefits to military veterans and military veterans' dependants; to establish the dependants' Education Fund, to establish the Defence Forces Retirement House and for connected purposes.

Now therefore, in compliance with Article 118 (1) (b) of the Constitution and National Assembly Standing Order 127(3), the Communities benefity invite the general public and stakeholders to submit memoranda on the two Bills.
