MESSAGE FROM THE CABINET SECRETARY



It is my privilege and distinct honour to present the Annual Performance Report for the Ministry of Defence for the Financial Year 2020/2021. The Report is prepared and submitted in fulfilment of Article 153 (4) (b) of the Constitution and Section 10(h) of the Kenya Defence Forces (KDF) Act.

The role of the Ministry of Defence (MoD) is to provide national defence policy direction and general administrative support to the KDF in order to fulfil its Constitutional Mandate as stipulated in Article 241 (3) (a), (b) & (c) of the Constitution.

The period under review had various challenges but the Ministry remained steadfast in achievement of the goals and objectives of its Strategic Plan.

One of the notable challenges was the advent of the Covid-19 pandemic that saw budget cuts across the Government Ministries, Departments and Agencies. MoD was not spared the axe as it too was affected immensely.

Despite the challenges, most of the MoD earmarked programmes were undertaken as per the Performance Contracting milestones for the Financial Year 2020/2021. KDF continued to play its vital role of defending and protecting the sovereignty and territorial integrity of the Republic and providing support to civil authorities whenever called upon. During the review period, KDF continued to intensify border patrols, Kenya's air space and territorial waters and engaged in Humanitarian Civic Actions that were intended to spur economic growth of the country.

Among the key civil projects undertaken in FY 2020/2021 were: the rehabilitation of the Port of Kisumu, revamping of the Kenya Meat Commission, drilling of boreholes and construction of open air water pans across various counties, rehabilitation of the Meter Gauge Railway lines, distribution of relief food and environmental conservation.

The Ministry also made progress towards achieving its human resource capacity building objectives of a lean and efficient work force. Training and education at different levels was undertaken across the rank and file of the KDF. We endeavour to institutionalise excellence which is an integral part of our service. This urges us to seek perfection in everything we do, to commit ourselves to high morals and ethical values and to be gentle when dealing with others.

Recruitment of both civilian and military personnel was conducted. In the fulfilment of the Constitutional requirement, the Ministry ensured that the exercise reflected the diversity and inclusivity of the Kenyan people in equitable proportions.

We are alive to the fact that Al-Shabaab continues to pose a grave threat to our security, the stability of the region and to the international economy. Our troops will continue to work under the umbrella of AMISOM which has played a crucial role in stabilising Somalia for the past 14 years, and now set to transition to the African Union Transition Mission to Somalia (ATMIS) by the end of March 2022. We continued to promote regional and international peace in South Sudan, Darfur in the Sudan, DRC, Mali, Central Africa

Republic and in many other countries as military observers and staff officers.

I applaud the Ministry for its exemplary performance in achieving its targets in the Performance Contract. I thank all staff both civilian and military whose expertise, commitment and cooperation ensured the Ministry met its targets and received a clean record of accounts from the Office of the Auditor General.

The Ministry is mandated by the Constitution to defend and protect the sovereignty and territorial integrity of the Republic and provide support to Civil Authority when called upon and authorised by the National Assembly.

In order to deliver this mandate, the Ministry continued to strengthen its capability and capacity in the key functional areas of command and control, information and intelligence, force capability enhancement, modernization, research and development and troop morale and sustainability.

While accomplishing its obligations, the Ministry realized its set objectives of defending and protecting the sovereignty and territorial integrity of the Republic providing support to Civil Authority, Defence Modernization Programmes and the implementation of the Kenya Vision 2030 programmes.

The Ministry through KDF conducted its primary role in Deep and Close Operations resulting to major outcome that had positive impact on National Security. The Ministry will endeavour to monitor and liaise with other stakeholders in undertaking all assigned roles by the Government.

The civilian component has been supported in the period under review through training, welfare and equipment in order to effectively provide support to delivery of Defence. Key priority areas included delivery of administrative support services, policy development and implementation and implementation of defence diplomacy, strategic communications and infrastructure development.



Section 1

1.0 INTRODUCTION

This Annual Performance Report for the FY 2020/21 for the Ministry of Defence is presented in conformity with Article 153 (4) (b) of the Constitution of Kenya 2010 and Section 10 (h) of the KDF Act, which mandates the Cabinet Secretary for Defence to submit a written report to the President and Parliament on the expenditure work and accomplishments of the Ministry.

Information on Ministry's performance is based on the Ministerial Performance Contract, Strategic Plan, Work Plan and Purchase Plans, guided policies and guidelines as issued by the Government from time to time. The report focuses on the key deliverables, highlights the challenges during the implementation period and proposes recommendations on efficient and effective delivery of Defence to meet the National Security objectives.

1.1 BACKGROUND

The MoD continued to execute its mandate as provided for in Article 241 of the Constitution and Executive Order No. 1 of 14 January 2020. To effectively deliver on its mandate and informed by the emerging threats and prevailing economic situation, MoD focused on its thematic areas of: Command and Control, firepower, information and intelligence, force protection, mobility and sustainment.

To augment these six functional areas, the Ministry endeavoured to promote its research, innovation and

development capability, strengthening the Civilian Component through budget restructuring and training, infrastructure development and modernization, improving defence policy formulation, enhancing defence diplomacy and strategic communication and promoting spare technology.

The Ministry also continued to promote regional and international peace and security and was actively involved in Peace Support Operations (PSO) in Somalia, South Sudan, Darfur in the Republic of the Sudan, DRC, Mali and Central Africa Republic under the auspices of AMISOM, UNMISS, UNAMID, MONUSCO & QRF, MINUSMA and MINUSCA. The MoD also participated in Regional Mechanisms (RMs) and Regional Economic Communities (RECs) activities within the FAC, IGAD, EASF and ICGLR.

1.2 PURPOSE

The Report provides an overview of the Ministry of Defence's performance in the FY 2020/21.

To defend and protect the sovereignty and territorial integrity of the Republic, assist and cooperate with other authorities in situations of emergency or disaster and restore peace in any part of Kenya affected by unrest or instability as assigned.

The core functions of the Ministry of Defence - as stipulated in the Executive Order No. 1/2020 of 14 January 2020 - are:

- 1.7.1 National defence, policy and management.

- 1.7.4 Defence intelligence.
- 1.7.5 Coordinate and regulate space-related activities within the country.

2.0 MINISTERIAL PROGRAMMES


2.1 In accordance with the National Security Sector Report for FY 2016/17 to 2018/19, the Ministry planned to undertake the following key programmes:

2.1.1 Defence and protection of the Republic of Kenya, the objectives of which are the maintenance and protection of the sovereignty and territorial integrity and promotion of regional and international peace and stability.

2.1.2 General administration of the Ministry of Defence, the objectives of which are: formulation, coordination and implementation of policies; administrative support services; and defence diplomacy and strategic communications.

2.1.3 Aid to civil authority, the objectives of which is to assist and cooperate with other authorities in situations of emergency or disaster and participate in National development.



During the period under review, the MoD accomplished the following:



- 3.1 Performed its core mandate of ensuring the sovereignty and territorial integrity of the Republic.




KDF recruits undergoing military training at the Recruits' Training School (RTS), Eldoret.

3.2 KDF maintained its operational readiness by attaining manning availability levels of 71.79% through expansion of the establishment.

3.3 To ensure that the KDF has the requisite professional skills for the accomplishment of its constitutional mandate, availability of key trained personnel was achieved at 95%.







The KDF has over the years invested in basic education through the establishment of schools in military barracks. Education and training play a key role in enhancing social mobility, national cohesion and socio-economic development. In recognition of the critical role of education in enhancing the KDF mission readiness, KDF has endeavored to provide holistic basic education by sponsoring public schools within its various Formations, Bases and Units. Currently, there are 16 primary and 14 secondary schools. The schools were established out of the realization that children of parents serving in the military should not be disadvantaged especially in admissions because of their parents' nature of duty. The KDF personnel are always away from their families for a prolonged period.

In recognition of education as a basic right, quality and accessibility of education are integral welfare components to the service personnel families. The Schools also provide educational opportunities to children of civilian parentage. The overall management of Kenya Defence Forces Sponsored Schools (KDSS) has remained a shared responsibility between the Sponsor and Ministry of Education. KDF expectation is for the schools to transcend the cognitive aspects of learning and nurture the potential of each learner to enhance holistic development.

3.4 During the period, operational equipment readiness - which includes Infantry, Armour, Artillery, Engineers, Communications, Air and Naval systems - stood at 68.96% through acquisition of new systems and repair of existing ones.

3.5 The development of the regional hospitals to cater for needs of the KDF personnel and their families has been initiated.



3.6 Further, following the Covid-19 outbreak, the KDF's Directorate of Medical Services (DMS) embarked on sensitization of KDF personnel on various ways to mitigate the pandemic:



- Observing the Ministry of Health (MoH) guidelines on social distancing, wearing masks, hand washing/sanitization and regular temperature checks.
- Roll-out of the vaccination drive to frontline healthcare workers and other military personnel including those who have retired from the Service.
- Reduction in number of visitors to the camp, screening of staff and visitors as they enter the camp, testing of those with symptoms and close contacts of those affected.
- Establishment of an Isolation ward at Sorsobie for suspected cases.
- Provision of home-based care for the asymptomatic and those with mild symptoms.
- One chamber preserved for Covid-19 VIPs at Mashujaa.
- Reduction of routine physical meetings e.g. major ward round and Monday rhythm meetings.
- Set-up of 140 bed capacity General Ward and 10 ICU-bed capacity hospital at Kabete for Covid 19 treatment.




KDF service personnel receiving Covid-19 jab at the Defence Memorial Hospital

3.11 The Ministry conducted several humanitarian civic activities in various parts of the country in the fulfillment of its Constitutional mandate on Aid to Civil Authority as provided for in Article 241-3(b). Some of these activities included:


3.11.1 Provision of water: The Ministry sank community boreholes and assisted locals to harvest rain water through construction of water pans, dams, shallow wells and underground water collection tanks. These projects have benefitted the locals by supplying clean potable water for human & livestock needs and for small-scale farming. The water projects in dry areas, especially the north-eastern parts, reduced movements in search of water for livestock.






The Ministry assisting local community in Sandaró Sangailú in the construction of an open-air water pan (Sianga)

3.11.2 Rehabilitation of Meter Gauge Railway line: The Ministry embarked on the rehabilitation of the old, dilapidated and vandalized railway lines to allow for movement of people and goods as it had been before. The already restored lines during the review period are the Nairobi - Nanyuki, Nairobi - Nakuru - Kericho and Gilgil - Ol Kalou. Rehabilitation of other sections is ongoing to enable the whole railway network to be functional.





11.3 Distribution of Relief Food: Kenya Defence Forces (KDF) troops and the Multi-Agency team operating in Lamu County airlifted relief food from Mijikila to Ozi-Kipini within the Beni enclave. 



3.12 Information Management. The Ministry upgraded its website from the previous one that had been overtaken by current web technologies. The new system is secure and provides MoD with an online platform for informing the public on issues happening within the Ministry. The website is more informative, interactive and meets the demands of modern technology.

3.13 Shipyard Construction. The completion of the shipyard will strengthen the ship construction and repair capability of the Kenya Navy. This shipyard is set as a national strategic capability with the clientele from other Ministries, Departments and Agencies (MDAs). This facility will create employment, generate revenue, reduce overseas repair costs and spur national and regional technology transfer.

3.14 The Ministry supported the government policy on Youth Internship/Industrial Attachment/ Apprenticeship by providing industrial attachment for 65 youths in its institutions.

3.15 Towards achieving the 30% award of procurement opportunities to youth, women and persons with disability through the Access to Government Procurement Opportunities (AGPO) programme, the MoD awarded contracts/tenders worth KShs. 1,186,892,103.20 to this group in the FY 2020/21.

3.16 Under the 40% policy on promotion of local content in procurement, the Ministry spent a total of KShs. 2,519,157,613.85 (35% of general procurement budget) on procurement of local goods and services.

3.17 **Environmental Security:** In support of the Government effort on environmental sustainability in line with SDGs and Kenya's Vision 2030, MoD has actively participated in environmental conservation efforts through planting of trees in designated areas within the Kenya forests. The Ministry through the Environmental Soldier Programme (ESP) planted a total of 1,486,29 seedlings in cantonments and wetlands and adopted funds allocated by the Ministry of Environment and Forestry. This was achieved by working in partnership with other supporting agencies and organizations.


3.18 The Ministry implemented the Government Policy on National Cohesion and National Values as provided for in Article 10 of the Kenya Constitution 2010 by performing exemplarily in the National Cohesion and Values criterion in the year under review.

3.19 Under the directive of the PS as the accounting officer for the Ministry KShs. 5,514,655,835.00 was collected, as proceeds from UN reimbursements, fees paid to learning institutions, rent from institutional houses, sale of tender documents and proceeds from auction of obsolete assets and stores among others.

3.20 Flagship Projects


The Ministry had two flagship projects, which are in various levels of implementation as follows:

3.20.1 The design and construction of the 4000-ton slipway at Mtongwe is meant to enable Kenya perform mid-life fitting and manufacture of own ships and also extend to the neighbours and the world for commercial gains. The project is on schedule as planned and 90% completed as at the end of the period under review. Commissioning of the project is earmarked for end of 2021.




3.20.2 KDF Food Processing Factory (KDF-FPF), Gilgil

Technicians' training at the Defence Forces Technical College (DEFTEC) as well as in other various KDF schools/colleges was undertaken. 3.25.1.2 Operationalization of EMECP Action Plans (Solar/Wind Powering):

High energy bills and adverse effects of conventional energy on the environment have made renewable energy sourcing the preferred future option. Services and Defence Controlled Units (DCUs) have been sensitized on the effects of exploiting energy-saving opportunities and are expected to give feedback on progress. The energy audits whose aim was reducing energy consumption and bills through identifying energy-saving opportunities and applying renewable energy technologies resulted in several other EMECP programmes that were implemented in the FY 2020/21. They include:

- a. Changing lighting technologies to more efficient LED in KDF units.
- b. A Pilot 10kw Solar PV powering installed at the Ulinzi Complex corridor and a few basement offices. Training of technicians already done. The system is currently at Defect Liability Period (DLP) phase where its performance is being monitored.
The Ministry is further monitoring additional solar systems installed at KDF Units (e.g. renewable energy project survey conducted at Modika Barracks; and solar water pumping at the KDF-FPF). Output of these projects will be the basis for replication of similar projects within KDF.
- c. Biogas pilot project at Embakasi.
The project entails pressurizing the biogas to give it industrial burning capabilities, making the project to be suitable for large-scale use.
Now working on the stabilization of gas production.

3.25.2 Design and Fabrication of Medical Equipment.
After the equipping of KDF personnel with solid works Computer Aided Design (CAD) software technology, the designs for Ilizarov and production of Braun Splint have been completed. The cutting of Alizarov was completed while assembly is being worked on.

3.26 Corruption Prevention.

To combat and prevent corruption and unethical practices and instead promote standards and best practices in governance, the KDF constituted court martial for those who were suspected of malpractices during military recruitment.

3.27 Fight Against HIV/AIDS Infection


With regards to the fight against HIV/AIDS infection, the Ministry continued with the awareness and prevention campaigns in the period under review by domesticating Public Sector HIV/AIDS workplace policy, establishing and operationalization of HIV/AIDS Control Unit based on NACC's guidelines. An annual workplan was developed and resources were allocated for HIV/AIDS activities/programmes. Effort was put into promoting attainment of UHC at the workplace through offering services for disease prevention and wellness promotion for at least 80% of staff and family members.

3.28 Cancer Awareness and Prevention

Appreciating the challenges that cancer poses and the heavy burden it has brought to households and the health infrastructure, the KDF implemented several programmes and activities aimed at creating awareness and prevention of the disease.

3.29 Implementation of Presidential Directives

The Ministry fully implemented Presidential Directives and Circulars, and Executive Orders communicated to the Ministry as need arose.








6.5 Engagements with other MDAs will be increased and structured for the collective approach in National Defence and Development
