CHAIRPERSON'S FOREWORD

Standing Order 200A (1) and (2) of the National Assembly Standing Orders provides that "(1) A Committee which is unable to complete its work before the expiry of its term shall table an exit report to the Assembly detailing reasons for such inability; and (2) The report shall be available to the succeeding committee which may consider it in preparing its work plan".

The Exit Report is an important tool of gauging the Committee's performance in the Twelfth Parliament. It gives details of the business transacted by the Committee from November 2017 to June 2022 and offers a starting point for the succeeding Committee as it highlights the business pending before the Committee at the end of the Sixth Session.

In line with Article 118 of the Constitution which requires Parliament to facilitate public participation and involvement in legislative and other business of the Parliament, two hundred sixty nine published Regulations were referred to the Select Committee on Delegated Legislation in the 12th Parliament; whereby eight (8) Regulations were in draft format that was required to be tabled in the House before publication i.e. IEBC Regulations, the Breast Milk Substitute (Regulation and Control) (General) Regulations, 2021. The Committee executed most of the work referred to it despite the challenging COVID-19 Pandemic period where Members had to work under unprecendeted arrangements that prohibited physical meetings because of the Covid 19 dangers to human life.

Through its work, the Committee positively impacted the country in several ways including among others, scrutiny and approval of Land Registration (Electronic Transactions) Regulations, 2020. The Regulations outlines framework for roll-out of electronic land transactions system, conduct of searches on an electronic system, valuation for online payment of stamp duty and registration of interests in the electronic land register. The Regulations also make provision for the execution of instruments using electronic signatures by parties. Prior to the Regulations, the property records of each registration unit throughout the country have been kept at the Lands Registry of that registration unit in physical form in the deed files.

Moreover, most Arid and Semi-Arid Lands (ASALs) in Kenya experience perennial draught due to lack of adequate rainfall. The effects of prolonged drought aggravated food insecurity situation and lead to decreased pasture for livestock as well as increasing potential for resource-based conflicts. In that regard, the Committee approved Public Finance Management (National Drought Emergency Fund) Regulations, 2021 following its commital to the Committee. The purpose of the Regulations - among others - was to improve the effectiveness and efficiency of drought risk management in the country as wells as to provide common basket emergency fund and resources to primarily facilitate faster, transparent, predictable and accountable release of fund for drought risk management and mitigation.

I wish to most sincerely thank The Speaker of National Assembly and The Office of the Clerk for the invaluable support accorded to the Committee in discharge of its mandate.

Finally, on behalf of the Members of the Select Committee on Delegated Legislation, and pursuant to Standing Order 200A (1), it is my pleasure and humble duty to present to the House the Exit Report of the Committee.

1. PREFACE

1.1 Establishment of Committee

- The power of each House of Parliament to establish committees and to make Standing Orders for the orderly conduct of its proceedings, including the proceedings of its committees is provided under Art. 124 of the Constitution of Kenya, 2010.
- 2. The National Assembly Standing Orders has established various committees of the House with distinct Mandates. These Committees under the Directorate of Audit, Appropriations and Other Select Committees play a pivotal role of facilitating the National Assembly fulfill its constitutional mandate of allocation of national revenue, appropriation of funds and oversight over national revenue, expenditure and State organs.
- The Committee on Delegated Legislations is established pursuant to Standing Order No. 210.

1.2 Mandate of the Committee

- 4. The Committee is mandated to consider statutory instruments submitted to Parliament for consideration. The Committee is expected to consider in respect of any statutory instrument, whether it:
 - a) is in accordance with the provisions of the Constitution, the Act under which it is made, or other relevant written laws. is in accordance with the provisions of the Constitution, the Act under which it is made, or other relevant written laws;
 - b) infringes on fundamental rights and freedoms of the public;
 - c) contains a matter which in the option of the Committee should more properly be dealt with in an Act of Parliament;
 - d) contains imposition of taxation;
 - e) directly or indirectly bars the jurisdiction of the court;
 - f) gives retrospective effect to any of the provisions in respect to which the Constitution does not expressly give any such power;
 - g) it involves expenditure from the consolidated fund or other public revenues;
 - is defective in its drafting or for any reason form or part of the statutory instrument calls for any elucidation;
 - appears to make some unusual or unexpected use of the power conferred by the Constitution or the Act under which it is made;

- j) appears to have had an unjustifiable delay in its publication or laying before Parliament;
- makes rights, liberties, or obligations unduly dependent upon non-renewable decisions;
- makes rights, liberties, or obligations unduly dependent on insufficiently defined administrative powers;
- m) inappropriately delegates legislative powers;
- imposes a fine, imprisonment, or other penalties without express authority having been provided for in the enabling legislation;
- o) appears for any reason to infringe on the rule of law;
- p) inadequately subjects the exercise of legislative power to Parliamentary scrutiny; and
- q) accords to any other reason that the Committee considers fit to examine.

- 18. Art. 93 (1) of the Constitution of Kenya establishes Parliament of Kenya which consists of the National Assembly and the Senate. Further, Art 95 provides for the role of the National Assembly amongst others to:
 - (i) deliberate on and resolve issues of concern to the people;
 - (ii) enact legislations
 - (iii)determine allocation of national revenue between the two levels of governments the National government and County governments;
 - (iv) appropriate funds for expenditure by the national government and national State organs;
 - (v) exercise oversight over national revenue and its expenditure;
 - (vi)exercise oversight over State organs; and
 - (vii) review the conduct in the office of the President, Deputy President and other State officers and initiate the process of removal from office.
- 19. In addition, Art 124 of the Constitution empowers Parliament to establish Committees and to make Standing Orders for orderly conduct of its proceedings including the proceedings of its Committee.
- 20. The National Assembly Standing Orders has established various Committees of the House with distinct mandates
- The Committee on Delegated Legislation considers statutory instruments submitted to Parliament for consideration.

5. IMPLICATIONS OF THE REGULATIONS

5.1 Impact of the Approval and Annulment of Statutory Instruments

Status of Regulations/ Instruments committed to the Committee

1. Scrutiny of Regulations

25. The Committee has had engagement with various Regulatory making Authorities in the development of Regulations during prepublication stage pursuant to section 5 (1) of the Statutory Instrument Act, 2013.

2. Consultation / Public participation - Section 5 of the SI Act

26. On public participation, the Committee was keen that consultations are undertaken as required by law. Articles 10 and 118 of the Constitution, sections 5, 5A, 13(a) and (m) of the Statutory Instruments Act require that the regulation-making authority conducts public participation and sufficient consultation with the stakeholders and persons likely to be affected by the Regulations.

Lack of adequate public participation led to the annulment of Regulations.

3. Regulatory Impact Statement - Sections 6, 7 & 8 of the SI Act

27. Sections 6, 7, and 8 of the Act requires the regulatory-making authority to carry out a regulatory impact assessment and submit to Parliament a Regulatory Impact Statement if the proposed regulation has significant cost or impact to the community or a sect of the community.

4. Statutory Timelines - Section 11 of the SI Act

 The Committee was also keen on the statutory timeline contemplated under section 11(1) of the Statutory Instruments Act (No 23 of 2013).

5. Penalties - section 13 (a) of the SI Act

29. On penalties – The Committee was also keen to know whether fees imposed on Kenyans by a proposed subsidiary Legislation was expressly in the parent Act. Section 13(a) of the Statutory Instruments Act requires Regulations to be in conformity with the parent Act.

6. Section 13(k) of SI Act

30. Section 13(k) of SI Act generally checks whether a statutory instrument was meant to among others promote the values, principles and general spirit of the Constitution with regards to Articles 28 on the Right to Human Dignity. The Committee also advises the Regulatory making Authorities that Regulation to be drafted in simple language and easily implemented by being facilitative to the users instead of punitive.

7. Inappropriate delegation of legislative powers - Section 13 (m) of the SI Act

31. Section 13(m) of the Act requires the Committee to carry out its scrutiny by considering whether Regulations inappropriately delegates legislative powers. Any other reason that the Committee considers fit to examine – Section 13 (q) of SI Act

Some of the Regulations approved by the House and which have had an impact on the general population are:-

(i) Housing Regulations, 2018

32. The Committee engaged with the Ministry of Transport, Infrastructures, Housing, Urban Development and Public Works, as part of the big four agenda the Committee considered and approved the Housing Regulations, 2018.

(ii) Engineers Rules

33. The Committee approved the Engineers Rules to ensure that there were enough professional engineers who are registered to mentor the graduate engineers for the recommended period of three years.

(iii) Public Finance Management (Parliamentary Catering Fund) Regulations, 2019

34. The Committee approved the Public Finance Management (Parliamentary Catering Fund) Regulations, 2019 which proposed the creation of a Catering Account in the Parliamentary Fund dedicated to the provision of catering services to Members of Parliament.

(iv) Crops (Irish Potato) Regulations

- 35. The Committee approved Crops (Irish Potato) Regulations to streamline the production, trade and problematic interactions among key players in the Irish Potato sub-sector. The Committee made sure that the Ministry through KEPHIS that was in-charge of seed regulation had put in place mechanisms to control illegal importation of seed potato and that there's a provision in the Regulation that put maximum weight of potato bags.
- 36. The Committee also considered various draft Crops (Food Crops) Regulations, 2019, Crops (Horticultural) Regulations, 2019 and Tea, Coffee, Sugar, Pyrethrum sub sectors regulations.

(v) Regulations by the Retirement Benefits Authority

37. The Committee also considered and approved the Retirement Benefits Act (The Retirement Benefits (Post-Retirement Medical Funds) Guidelines, 2018 and Retirement Benefits (Good Governance Practices) Guidelines, 2018 which has positive impact on the retirees and pensioners.

(vi) Public Finance Management (Biashara Kenya Fund) Regulations, 2019

- The Committee considered the following published Regulations from the National Treasury and Planning –
- (a) the Public Finance Management (Biashara Kenya Fund) Regulations, 2019 (LN No. 78 of 2019);
- (b) the Public Finance Management (Uwezo Fund) (Revocation)Regulations (LN No.79 of 2019),
- (c) the Public Finance Management (Women Enterprise Fund) (Revocation) Regulations, 2019 (LN No. 80 of 2019); and
- (d) the Public Finance Management (Youth Enterprise Development Fund) (Revocation) Regulations (LN No. 81 of 2019)
- 39. The Committee was not for the view of collapsing the existing affirmative action funds and establishes a new Fund to be known as the Biashara Kenya Fund.
- 40. The justification given for the merger is that the establishment of a new Fund seeks to operationalise Articles 27, 55 (b) (c) and 56 (b)(c) which provide for affirmative action programmes and other resources in respect to disadvantaged groups and youth aimed at ensuring equitable development of the State. The Regulations are also intended to operationalise the Presidential Taskforce on Parastatal Reform Report of 2014 which recommended the merger of the existing affirmative action Funds.

(vii) Public Finance Management (Tourism Promotion Fund) Regulations, 2018 & the Air Passenger Service Charge Act (Apportionment) Order 2018

41. The Committee considered the aforementioned statutory instruments relating to Tourism Promotion, Branding and Marketing.

(viii) Control of Public Health (Control of Shisha Smoking) Rules, 2017

42. The Committee noted that the Cabinet Secretary for Health issued Regulation vide legal notice number 292 of 2017 banning the importation, manufacture, sale and offer for sale, advertising and promotion of Shisha in Kenya, pursuant with Section 36(m) of the Public Health Act (Cap 242). Shisha was an emerging harmful product majorly consumed by young Kenyans and especially women of reproductive age. The product is illegally imported in Kenya as there is no legal entity licensed to import Shisha in Kenya.

Kenya Crops (Tea Industry) Regulations, 2020

43. In order to address various challenges in the Tea Industry, the government instituted reforms in the sector which were aimed at raising farmers' earnings and improving the tea value chain

- by addressing corruption and exploitation of farmers, low prices and bonuses, fluctuating net earnings to farmers as well as delayed payments.
- 44. The Kenya Crops (Tea Industry) Regulations, 2020 were published on 22nd May, 2020 and submitted to the House for consideration. The Regulations seek to bring into effect the requirements of section 40 of the Crops Act with a purpose of guiding the development, promotion and regulation of the tea industry for the benefit of the tea growers and other stake holders in the industry.
- 45. In line with Article 118 of the Constitution which requires Parliament to facilitate public participation and involvement in legislative and other business of the Parliament and its committees, the Committee undertook extensive public participation exercises in the tea growing areas of including Meru, Nyeri, Muranga, Kirinyaga, Kiambu, Nandi, Kericho, Bomet, Nyamira, and Vihiga Counties, holding multiple meetings with various stakeholders in the Tea Industry including tea farmers, and tea traders to receive their views on the proposed tea regulations with the Committee. The regulations were subsequently approved on 26th October, 2020.
- 46. The Ministry of Agriculture, Agriculture, Livestock, Fisheries and Co-operatives, is in the process of implementing the regulations.

Public Finance Management (National Drought Emergency Fund) Regulations, 2021

- 47. Most Arid and Semi-Arid Lands (ASALs) in Kenya experience perennial draught due to lack of adequate rainfall. The effects of the prolonged dry season aggravate the food insecurity situation and lead to decreased pasture for livestock as well as increasing the potential for resource-based conflicts.
- 48. The Public Finance Management (National Drought Emergency Fund) Regulations, 2021 were tabled before the House on 21st March, 2021 and committed to the Committee for consideration. The purpose of the Regulations is among others, to improve the effectiveness and efficiency of the drought risk management symptoms in the country as wells as to provide a common basket emergency fund in order to facilitate faster, transparent, predictable and accountable release of fund for drought risk management.
- 49. To this end, the regulations establishes a national Draught emergency fund with an initial capital of Kshs. 2 billion to cushion the drought affected areas from the effects of famine and

also manage the famine situation in the country. The regulations were approved by the House on 13th May, 2021.

The Land Registration (Electronic Transactions) Regulations, 2020

- 50. The Land Registration (Electronic Transactions) Regulations, 2020 were tabled before the House and committed to the committee for consideration. The regulations provide the framework for the roll-out of an electronic land transactions system, the conduct of searches on an electronic system, valuation for payment of stamp duty online and registration of interests in land on the electronic land register. The Regulations also make provision for the execution of instruments using electronic signatures by parties.
- 51. These regulations have revolutionalised the Land Management system in the country by introducing the electronic land registry and further requiring Registrars to maintain an electronic land register which provide information on the proprietorship or ownership of the property; any encumbrances i.e. any rights or interests by other parties that are registered against the title to the property such as well as any other feature required under any law or deemed necessary by the Cabinet Secretary.
- 52. Prior to the Regulations, the property records of each registration unit throughout the country have been kept at the Lands Registry of that registration unit in physical form in the deed files.

Petroleum Development Levy (Amendment), Order, 2020

- 53. The Petroleum Development Levy Order, 2020 was published as Legal Notice No. 124 on 10th July, 2020. The Order was considered and approved by the National Assembly's Select Committee on Delegated Legislation at its sitting on 17th February 2021. However, upon approval of the Instrument by the Committee, the Ministry discovered that the AGO (Diesel) was omitted from the First Schedule.
- 54. The Order therefore sought to amend the Petroleum Development Order, 2020, (LN No. 124 of 2020) with the effect of inserting Automotive Gas Oil (AGO or Diesel) to legally incorporate it in the First Schedule of the Petroleum Development Levy Order, 2020. As it had been erroneously omitted from the First Schedule to the Order.
- 55. The Committee in considering the amendment Order found that it is a Statutory Instrument on its own published under a different legal notice (No.77 of 2021) and with the implications on the rates of levy chargeable on AGO (Diesel) hence the Ministry ought to have conducted public participation as required under the Constitution and the relevant laws, and not chosen

- to ride on public participation conducted for LN. No124 of 2020 which did not contain AGO (Diesel) in the schedule. The Committee therefore in its report annulled the order which had the implication of bringing down the cost of diesel.
- Kenya Defence Forces (Pensions and Gratuities) (Officers and Service Officers) Regulations,
 2021
- 57. Kenya Defence Forces (Pensions and Gratuities) (Officers and Service Members) Regulations, 2021 were made pursuant to Section 304 (1) (aa) of the Kenya Defence Forces Act, 2012. The objective of the regulations is to provide for efficient and effective processing of pension payments for retirees in the Defence Forces.
- 58. The Kenya Defence Forces has been without pensions since the committee annulled of the 2017 Regulations and no payment had been done as there was no body or committee to carry out the needed assessment to make recommendations to the Director General of Pensions.
- 59. On annulment, the Committee had proposed several amendments which had been addressed in the revised Kenya Defence Forces (Pensions and Gratuities) (Officers and Service Officers) Regulations, 2021 .The KDF had further conducted adequate public Consultations and stakeholder engagements on the revised regulations.
- 60. The approval of the regulations has now paved way for the processing of over 700 pending cases of pension which had stalled due to due to lack of this regulations.

The Traffic (Driving Schools, Driving Instructors and Driving Licenses) Rules, 2020

- 61. The Rules were made by the Cabinet Secretary for Transport, Infrastructure ,Urban Development, Public Works and Housing pursuant to powers conferred under section 119(1)(ga) of the Traffic Act (Cap 403) Laws of Kenya and published in the Gazette as LN. No 28 of 2020 on 10th of March, 2020.
- 62. The Rules were however not laid on the table of the House as required under the Statutory Instruments Act that led them to be inter alia subject of Petition No. E251 of 2020, in the High Court of Kenya at Nairobi (Constitutional and Human Rights Division) between Kenya Driving Schools Association Vs the National Transport and Safety Authority & 3 others and the National Assembly and the Senate enjoined as 1st and 2nd Interested Parties accordingly.
 - 63. Orders issued by the Court on the 27th of January, 2021

Mrima J, issued orders to the effect that-

- (a) the implementation of the Traffic (Driving Schools, Driving Instructors and Driving Licenses) Rules, 2020 be stayed and suspended pending a reconsideration of the Rules by both Houses of Parliament.
- (b) the Cabinet Secretary in the Ministry of Transport, Infrastructure, Housing, Urban Development and Public Works to re-transmit a copy of the Traffic (Driving Schools, Driving Instructors and Driving Licenses) Rules, 2020, the Explanatory Memorandum together with a copy of [this] judgment to the Speakers of both Houses of Parliament within 14 days from the date of the Judgement.
- (c) that in view of the remainder of the terms of the Houses of Parliament, the respective Speakers of Parliament shall take steps to ensure that the Traffic (Driving Schools, Driving Instructors and Driving Licenses) Rules, 2020 are expeditiously dealt with by the respective Houses.
- (d) that in the event that any or both Houses of Parliament are/is unable to finalize the dealing with Traffic (Driving Schools, Driving Instructors and Driving Licenses) Rules,2020 within the remainder of the current terms of the Houses of Parliament, the said Rules shall be dealt with in the next term of Parliament.
- 64. Following the Court Ruling, the NTSA suspended implementation of the rules and disabled the NTSA portal which had the implication of suspension of all services offered by the NTSA, including drivers training and examination, issuance of driving licences and logbooks, among others.
- 65. The Committee having received the Rules and granted its mandate set out under Standing Order 210 did a detailed scrutiny of the Rules and took cognizance of the High Court Judgment by Mrima J, dated 27th January, 2022 that required the expeditious dealing of the Rules. The committee invited the National Transport and Safety Authority (NTSA) and the Kenya Driving Schools Association at separate meetings to deliberate on the rules. However, the committee noted that both parties had not come to a consensus on certain provisions of the said Rules. The committee resolved to invite both parties to a joint meeting for a hearing that enabled the committee approve the Rules with the exception of three provisions which the Committee proposed to the Cabinet Secretary to amend for purposes of conformity to the Constitution, the Act and in light of the deliberations at the aforementioned meetings as well as to comply with the judgment issued by the High Court.
- 66. With the Rules approved by the National Assembly, the National Transport and Safety Authority restored the provision of all services to the general that had been suspended.

The Public Finance Management (National Roads Toll Fund) Regulations, 2021,

- 67. The Regulations were made by the Cabinet Secretary for the National Treasury and Planning pursuant to section 24 (4) of the Public Finance Management Act, 2012 and was published in the gazette vide Legal Notice No.222 of 2021.
- 68. The purpose of the Regulations is to establish a dedicated fund pool for meeting Government's payment obligations contracted under project agreements for road development programs in Kenya, especially those implemented under the tolling framework.
- 69. The National Roads Toll Fund is proposed to be established under the Public Finance Management Act, 2012 as a resource mobilization strategy of the National Treasury to support Government's investment agenda for roads modernization in Kenya. Under the National Tolling Policy of 2016, the Government has articulated its commitment to national transport infrastructure investment over a ten-year planning window, from 2016 to 2025, through the development of a National Surface Transport Sector Funding Policy. The purpose of the 2016 Tolling Policy statement is to support the National Surface Transport Sector Funding Policy by summarizing how road tolls will be applied in order to fund National Road infrastructure expenditure.
- 70. The Integrated National Transport Policy prioritizes the improvement and development of Kenya's national road network to achieve the aspirations of Kenya Vision 2030. Expenditure plans covering investment, rehabilitation and maintenance of Kenya's road sector show an annual funding deficit of over Ksh.100 billion, on top of a large pending bills portfolio of nearly Ksh. One trillion shillings. Without action to identify additional funding sources, it is evident that Kenya may not manage to deliver on its aggressive growth agenda under both Vision 2030 and the Big Four Agenda, since national trunk roads are central enablers of economic growth.
- 71. The primary objective of tolling is therefore to raise additional funds directly from road users in a cost-effective and equitable manner in order to contribute to the sustainable development, rehabilitation and maintenance of Kenya's National Road network. The passing of the regulations paved way for the operationalization of the tolling system on the Nairobi expressway.

6. COMMITTEE'S UNCOMPLETED, PENDING AND LAPSED BUSINESS

72. The following business were pending before the Committee at the end of the Sixth (6th) Session of the 12th Parliament:

- i. The draft Merchant Shipping (Seafarers Identity Document) Regulations, 2022
- ii. The draft Merchant Shipping (Tonnage Measurement) Regulations, 2022
- iii. The draft Merchant Shipping (Maritime Labour) Regulations, 2022
- The draft Merchant Shipping (Load Line) Regulations, 2022.
- v. The draft Merchant Shipping (Collision Prevention) Regulations, 2022
- The draft Salaries and Remuneration Commission (Remuneration and Benefits of State and Other Public Officers) Regulations, 2022;
- vii. The draft Pharmacy and Poisons (Conducts of Clinical Trials)Rules, 2022
- viii. The draft Pharmacy and Poisons (Transportation of Pharmaceuticals) Rules, 2022;
 - ix. The draft Pharmacy and Poisons (Pharmaceuticals Waste Management) Rules, 2022;
 - The draft Pharmacy and Poisons (Pharmacovigilance and Post-Market Surveillance)Rules, 2022;
 - The Draft Pharmacy and Poisons (Registration of Health Products and Technologies)Rules, 2022;
- xii. The draft Pharmacy and Poisons (Amendment) Rules, 2022.
- 73. The Committee considered the Regulations with Regulatory making Authorities on Friday 3rd June 2022 and advised them to take into consideration and published and submit for further scrutiny before the House goes on Sine Die.

7. CHALLENGES AND OPPORTUNITIES

- National Assembly's Standing Order provides for timelines (28 sitting days as per SI Act)
 sitting days for regulations made under 205 of the PFM, 2012;
- SOs of both Houses provides for processing and approval of Regulations as well as annulment Provides for the manner/ submission, Tabling and processing upon publications.
- 3) According to the Standing Order No. 210(4) provides that if the Committee: Resolves that the statutory instrument, be acceded to, the Clerk shall convey that resolution to the relevant state department or the authority that published the statutory instrument.
- 4) If the Committee Does not accede to the statutory instrument, the Committee may recommend to the House that the Assembly resolves that all or part of the statutory instrument be annulled and if the instrument:-
 - (i) is not made under a legislation concerning counties and a resolution is passed by the Assembly within twenty days on which it next sits after the instrument laid before it under paragraph (2), that all or part of the statutory instrument be annulled, the instrument of part thereof shall henceforth stand annulled; and

- (ii) is made under a legislation concerning counties the Clerk shall within seven days of the resolution transmit a message to the Senate.
- 5) Consultation / Public participation Section 5 of the SI Act
- 72. Articles 10 and 118 of the Constitution, sections 5, 5A, 13(a) and (m) of the Statutory Instruments Act require that the regulation-making authority conducts public participation and sufficient consultation with the stakeholders and persons likely to be affected by the Regulations .The Committee has during the 12th Parliament annulled several pieces of regulations due to the failure by the Regulatory making Authority to conduct Public participation on the Regulations.

8. RECOMMENDATIONS

- Committee on Delegated Legislation must find an avenue or an opportunity to introduce amendments to the Parent Act specifically where Regulations were annulled on the basis of substantive legislative matter carried in regulations
- Committee on Delegated Legislation should be more effective and to minimize litigation after Parliamentary approval.
- Holding a Roundtable with Regulatory Making Authorities to ensure that Statutory Instrument Act, 2013 is adhered to;
- State law Office to fully support the Ministries when drafting Regulations before publication.
- 5) Delegated Legislation Information System (DLIS) Establishing of Database
