#### 5.0 ACHIEVEMENTS

38. During the Twelfth Parliament, the Committee processed 79 Questions, 14 Statements, 18 Legislative Proposals, 20 Bills, 20 Petitions, 3 Inquiries, 2 Protocols, 2 Sessional Papers, vetted 6 State Officers and oversaw the scrutiny and implementation of 5 Budget cycles as tabulated below –

## 6.0 CHALLENGES AND RECOMMENDATIONS

39. Some of the challenges that the Committee encountered in the course of carrying out its mandate include –

## 6.1 Challenges

- 40. The Committee met the following challenges in the course of its work -
  - Limited timelines for consideration of business, e.g. twenty-one (21) days allocated for scrutiny of Bills, fourteen (14) days for Legislative Proposals, sixty (60) days for Petitions etc., are not sufficient to consider the said business within the stipulated timelines.
  - Some state officers, e.g. Cabinet Secretaries, were reluctant to appear before the Committee despite several requests and reminders.
  - Lack of adequate resources and delayed exchequer releases delayed the timely implementation of the Committee's annual work plans.
  - iv. Slow or inadequate implementation of Committee recommendations by Government agencies. In addition, there is a lack of an effective feedback mechanism on how government agencies have implemented Committee recommendations adopted by the House.
  - Unrealistic timelines for the National Budget scrutiny process impede the thorough examination of the Estimates.
  - vi. Alteration or rejection of Committee recommendations by the Budget and Appropriations Committee (BAC) during the budget-making undermines the role of Departmental Committees' in the scrutiny process.
  - vii. The labour and social protection sectors lack adequate policies and legislation to regulate issues on labour migration, social development, and social protection, among others.
  - viii. The impact of the COVID-19 Pandemic negatively impacted the Committee's performance because of budget cuts and reduced meeting frequency, especially in the year 2020 and 2021.

## 6.2 Recommendations

- 41. The Committee recommends -
  - Review of Standing Orders to increase the time allocated to consider various businesses, e.g. Bills and Petitions.

- ii) There is a need to amend the Public finance Management Act, 2012 to increase timelines for the Budget scrutiny processes to allow for a thorough examination of Estimates by Parliament.
- iii) The 13<sup>th</sup> Parliament's Committees on Labour and Social Protection should consider prioritising streamlining of the country's labour export sector by fast-tracking the Labour Migration Bill and advocate for the enhancement of funding to the social sector through amendment of Section 34 of the Social Assistance Act to provide for government funding to operationalise the National Social Assistance Fund.
- iv) The Committee may also consider prioritising the enactment of the Children Bill and the Persons with Disabilities Bill should the Twelfth Parliament adjourn sine die before concluding with them. The two pieces seek to align the relevant sectors with the Constitution of Kenya 2020 and international agreements by guaranteeing the protection of the rights of children and persons with disabilities, amongst other progressive provisions.

#### 7.0 CONCLUSION

42. It is the hope of the Twelfth Parliament's Departmental Committee on Labour and Social Welfare that the succeeding Committees on Labour and Social Protection will take up from where this Committee left off for the betterment of Kenya's social sector.


