**PURSUANT** to the provisions of Standing Order 29(1) relating to *Special Sitting* of the House, I have received and acceded to a request from the Leader of the Majority Party to hold Special Sittings of the National Assembly on **13<sup>th</sup> July, 2022, for purposes of –**

- A.** Conveyance of any urgent Messages from the President, National Executive or the Senate;
- B.** Tabling of Report of the Budget and Appropriations Committee on the County Governments Additional Allocations Bill (Senate Bill No. 2 of 2022);
- C.** Tabling of and Notice of Motion of the Report of the Departmental Committee on Defence and Foreign Relations on the Defence Cooperation Agreement between the Government of the Republic of Kenya and the Government of the Republic of the United Kingdom of Great Britain and Northern Ireland;
- D.** Tabling of any Papers with statutory timelines including statutory instruments;
- E.** Transaction of the following Business –
  - (i) Consideration of Motion on Approval of Ratification of Defence Cooperation Agreement between the Government of the Republic of Kenya and the Government of the Republic of the United Kingdom of Great Britain and Northern Ireland;
  - (ii) First Reading, Second Reading, Committee of the Whole House and the Third Reading of the County Governments Additional Allocations Bill (Senate Bill No. 2 of 2022);
  - (iii) Consideration in Committee of the Whole House and Third Reading of the Huduma Bill (National Assembly Bill No. 57 of 2021); and,
  - (iv) Consideration of any other priority Business certified as urgent by the Speaker.
